I have reviewed the information you sent, and I appreciate your response. However, there are still some issues, and I want to make sure we are on the same "page" as far as what is still needed.

1. Label location - You sent a very nice example of the label, but not an engineer's drawing of photo of label location.
2. User's manual - You sent the declaration saying the you would add the 15.105 statement in the manual, however there was no manual in your information. We still need this document.
3. User's manual information/statements - Please show where the 15.21 and the 15.19 (due to the small size of the card), will be added to the manual

(ideally, with the 15.105 statement).

Please keep in mind that we cannot forward for a technical review until we receive the user's manual. If I was not clear in my prior request, I apologize. Also, should you need any further assistance, please do not hesitate to contact me. Thank you.

> > I have completed the administrative review and the issues are below:  
> >  
> > 1. There is not an FCC identification label included with your  
> > documentation for this device.  
> >  
> > 2. And also, since there is not a label, there is not a label location  
> > (either photo or engineer's drawing as to where the label will appear on  
> > the  
> > device).  
> >  
> > 3. Test setup photos - I do not see any in the test reports, or in the  
> > rest  
> > of the documentation. If I am overlooking them, please tell me where  
> > they  
> > are, or if they are not there, please send them.  
> >  
> > 4. User's manual - There is not one.  
> >  
> > 5. User's manual information/statements - Please be sure that when you  
> > send  
> > the user's manual, you have included the 15.21 and the 15.105 statements  
> > in  
> > the manual. Also, due to the small size of the card, please included  
> > the  
> > 15.19 statement in the manual with the other two (usually it is supposed  
> > to  
> > be on the identification label on the unit). I will attach examples.  
> >  
> > 6. Confidential Request - I am sure there are documents you wish to be  
> > held  
> > confidential. Please send us this letter being specific as to what you  
> > want  
> > to be held confidential; usually the schematics and possibly block  
> > diagrams.  
> > Also reference the FCC Rule part. An example of this is attached also.

> > Please be aware that due to there being technical information in the  
> > user's  
> > manual that assists the engineer in the technical review, we will not be  
> > forwarding this to Greg Czumak for review until we receive the above  
> > information, (at least the manual), and that we cannot grant this device  
> > until all of the information is received (label, etc.)  
> >
