6 EUT description

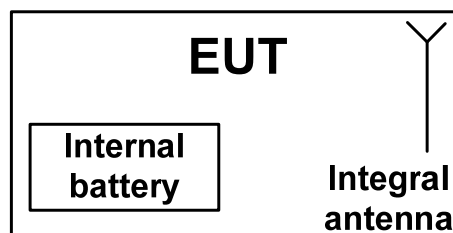
6.1 General information

The EUT is a Triple Technology Wrist Tag that comprises Tx/Rx 433.42 MHz, Rx 125 kHz radio modules. The EUT is powered from 3V internal battery.

According to manufacturer's declaration of similarity provided in Appendix G, the EUT models have the same housing/enclosure, PCB, RF (GFSK) transceiver (433.42 MHz), and LF receiver (125 kHz), and they vary in the following:

- the EUT model 5-WTG41102-0 is provided with a transceiver (433.42 MHz), and LF receiver (125 kHz), an IR receiver and tamper band;
- the EUT model 5-WTG40002-0 is provided with a transceiver (433.42 MHz), and LF receiver (125 kHz), tamper band and without an IR receiver;
- the EUT model 5-WTG41100-0 is provided with a transceiver (433.42 MHz), and LF receiver (125 kHz without tamper and an IR receiver.
- The EUT model 5-WTG41102-0 was tested as the most populated version covering all other variants, model 5-WTG400002-0 was tested partially.

7 Transmitter tests according to 47CFR part 15 subpart C requirements

7.1 Periodic operation requirements

7.1.1 General

The EUT was verified for compliance with periodic operation requirements listed below:

- Continuous transmissions such as voice, video and the radio control of toys are not permitted;
- A manually operated transmitter shall employ switch that will automatically deactivate the transmitter within not more than 5 seconds of being released;
- A transmitter activated automatically shall cease transmission within 5 seconds after activation;
- Periodic transmissions, excluding polling or supervision transmissions, at regular predetermined intervals are not permitted;
- Total duration of polling or supervision transmissions, including data, to determine system integrity in security or safety applications shall not exceed 2 seconds per hour;
- Transmission of set-up information for security systems may exceed the transmission duration limits of 5 seconds, provided such transmissions are under the control of a professional installer and do not exceed ten seconds after a manually operated switch is released or a transmitter is activated automatically. Such set-up information may include data.

The rationale for compliance with the above requirements was either test results or supplier declaration. The summary of results is provided in Table 7.1.1.

7.1.2 Test procedure for transmitter shut down test

7.1.2.1 The EUT was set up as shown in Figure 7.1.1.

7.1.2.2 The spectrum analyzer center frequency was adjusted to the EUT carrier, span set to zero and video triggered for transmission.

7.1.2.3 The transmitter was activated either manually or automatically. Once manually operated transmitter was activated, the switch was immediately released.

7.1.2.4 The transmission time was captured and shown in Plot 7.1.1.

7.1.3 Test procedure for measurements of polling / supervision transmission duration

7.1.3.1 The EUT was set up as shown in Figure 7.1.1.

7.1.3.2 The spectrum analyzer center frequency was adjusted to the EUT carrier, span set to zero and video triggered for transmission.

7.1.3.3 The transmission time was captured and shown in Plot 7.1.2.

Figure 7.1.1 Setup for transmitter shut down test

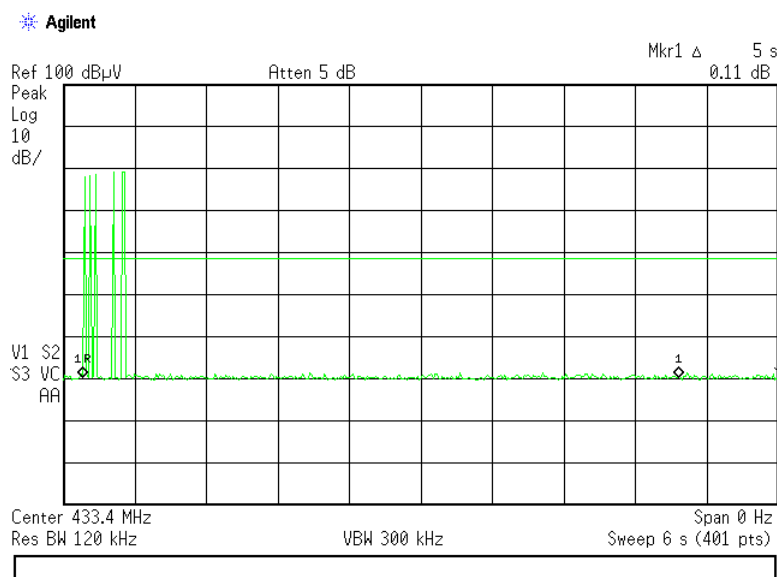

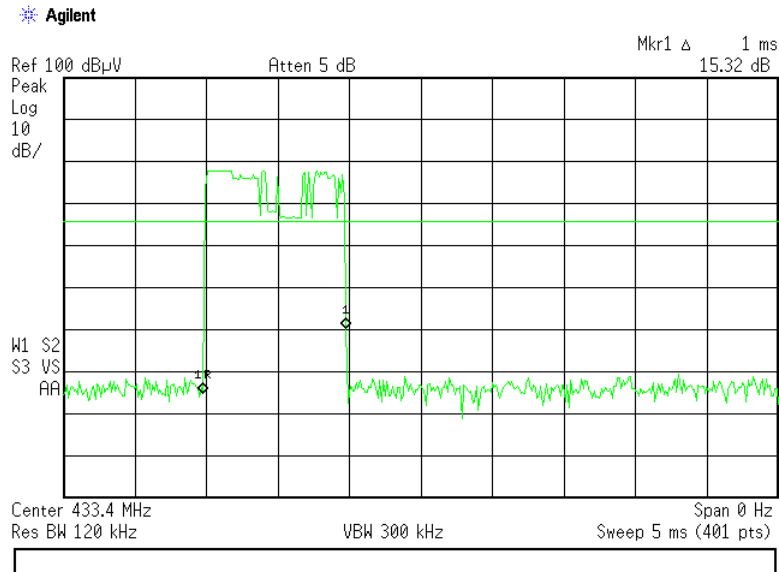

Plot 7.1.1 Transmitter shut down test result

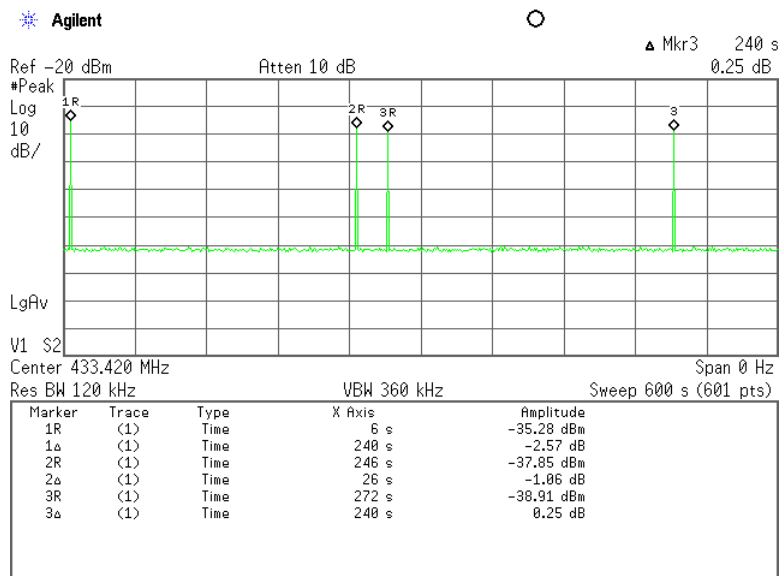

7.2.1 General

This test was performed to measure field strength of fundamental and spurious emissions from the EUT. Specification test limits are given in Table 7.2.1 and Table 7.2.2.

Note 1: The fundamental emission limit in dB(μV/m) was calculated as follows:

$$\text{Lim}_{AVR} = 20 \times \log(56.81818 \times F - 6136.3636) \text{ - within } 130 - 174 \text{ MHz band;}$$

$$\text{Lim}_{AVR} = 20 \times \log(41.6667 \times F - 7083.3333) \text{ - within } 260 - 470 \text{ MHz band,}$$

where F is the carrier frequency in MHz.

The limit for spurious emissions was 20 dB lower than fundamental emission limit.

The above limits provided in terms of average values, peak limit was 20 dB above the average limit.

Note 2: The above field strength limits applied from the lowest radio frequency generated in the device, without going below 9 kHz up to the tenth harmonic of the highest fundamental frequency.

7.2.2 Test procedure for spurious emission field strength measurements in 9 kHz to 30 MHz band

7.2.2.1 The EUT was set up as shown in Figure 7.2.1, energized and the performance check was conducted.

7.2.2.2 The measurements were performed in three EUT orthogonal positions.

7.2.2.3 The specified frequency range was investigated with antenna connected to spectrum analyzer/ EMI receiver. To find maximum radiation the turntable was rotated 360° and the measuring antenna was rotated around its vertical axis.

7.2.2.4 The worst test results (the lowest margins) were recorded in Table 7.2.3, Table 7.2.5 and shown in the associated plots.

7.2.3 Test procedure for spurious emission field strength measurements above 30 MHz

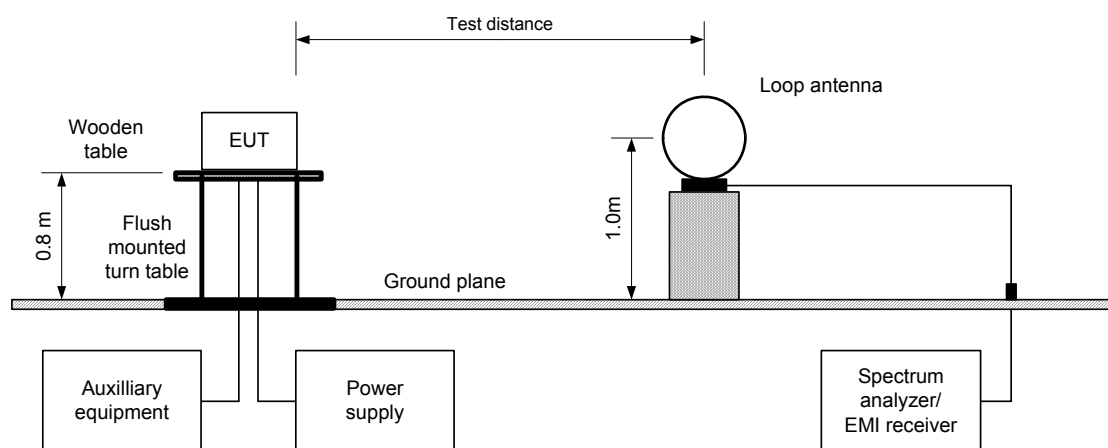
7.2.3.1 The EUT was set up as shown in Figure 7.2.2, energized and the performance check was conducted.

7.2.3.2 The measurements were performed in three EUT orthogonal positions.

7.2.3.3 The specified frequency range was investigated with antenna connected to spectrum analyzer/ EMI receiver. To find maximum radiation the turntable was rotated 360°, the measuring antenna height was changed from 1 to 4 m, its polarization was switched from vertical to horizontal.

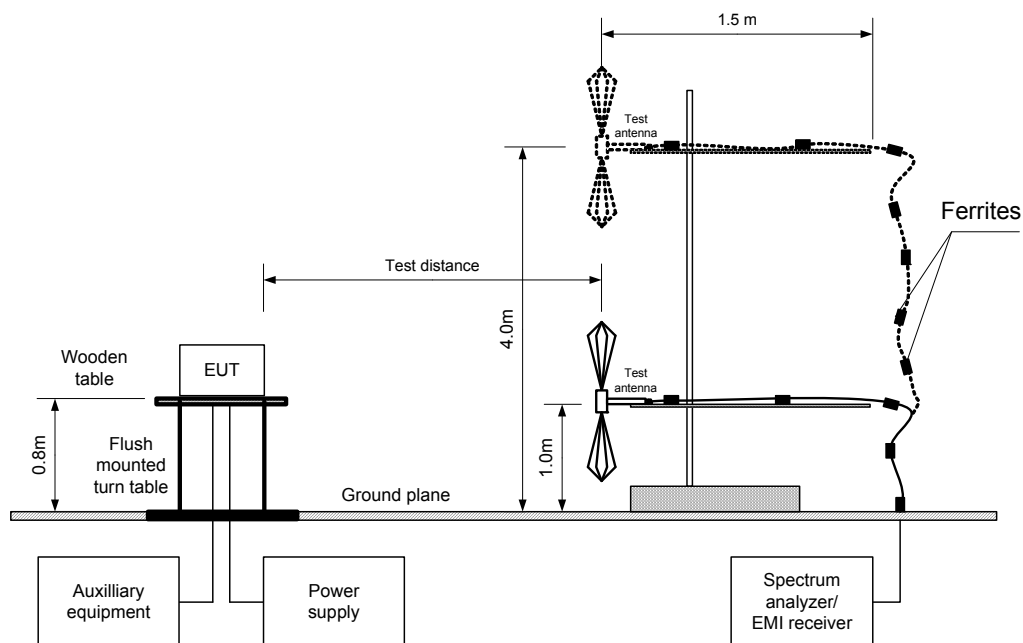

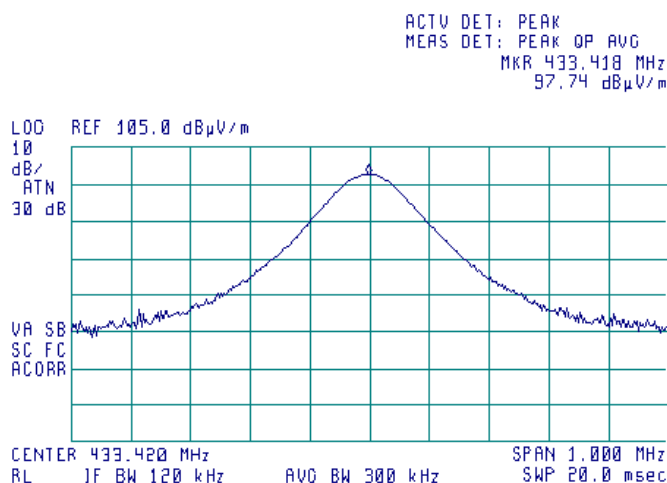

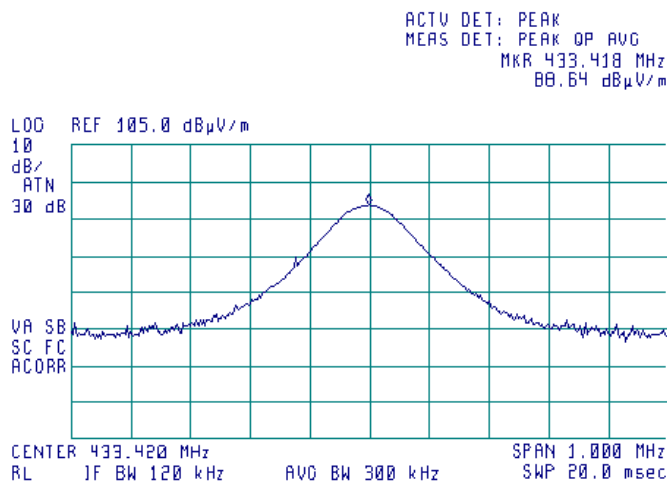
Plot 7.2.1 Radiated emission measurements at the fundamental frequency

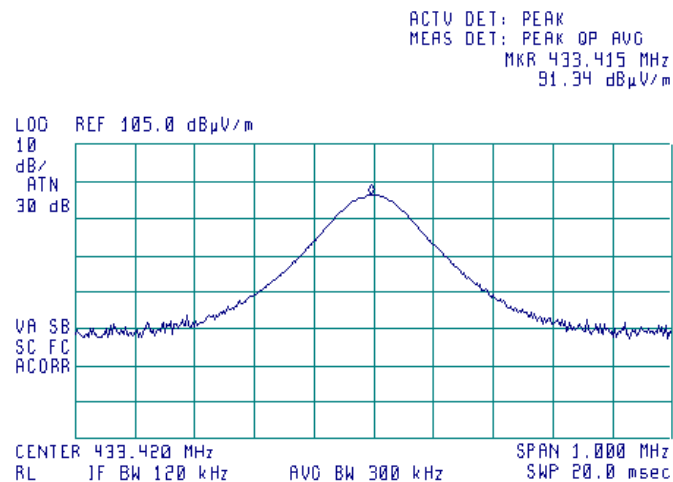

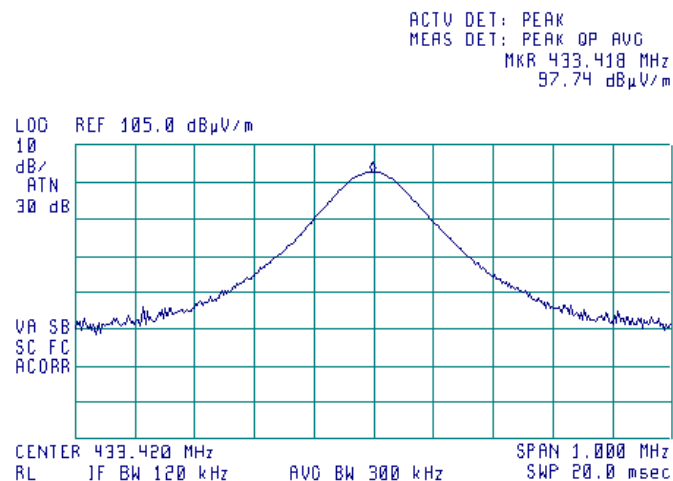
Plot 7.2.3 Radiated emission measurements at the fundamental frequency

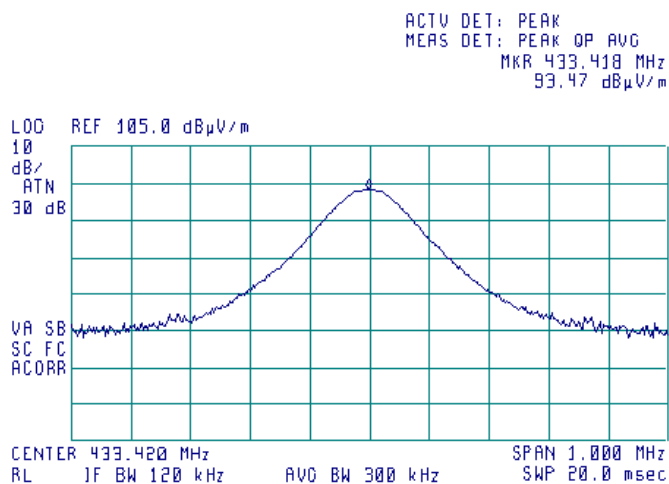

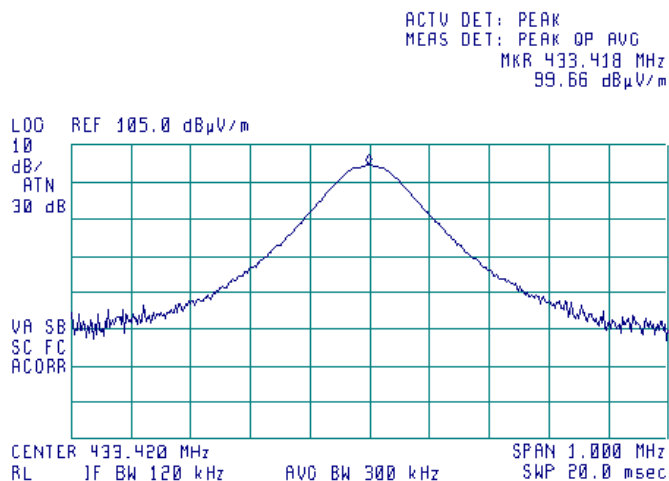
Plot 7.2.5 Radiated emission measurements at the fundamental frequency

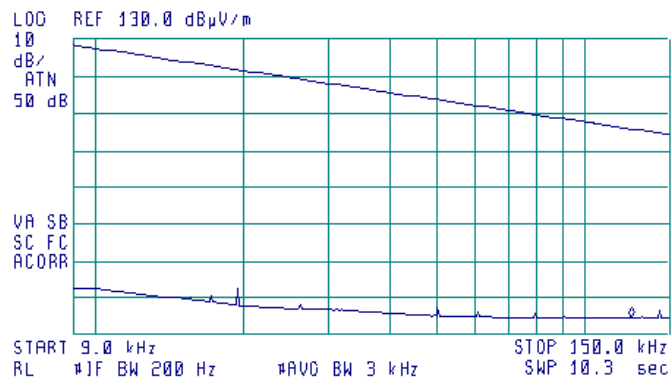

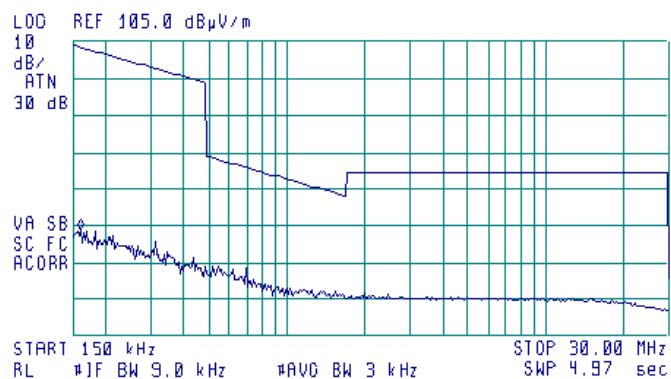


Plot 7.2.8 Radiated emission measurements from 0.15 to 30 MHz

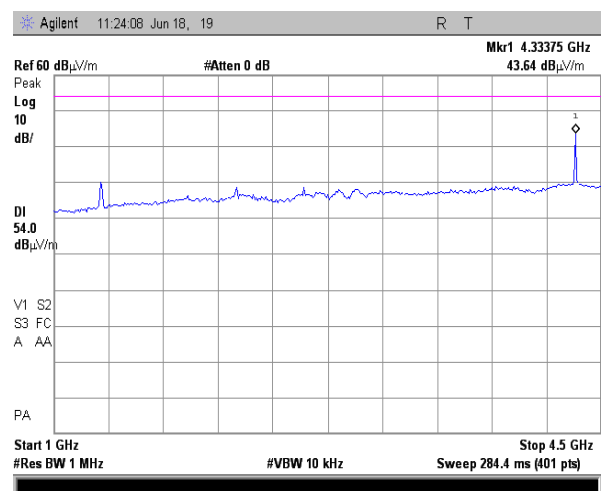
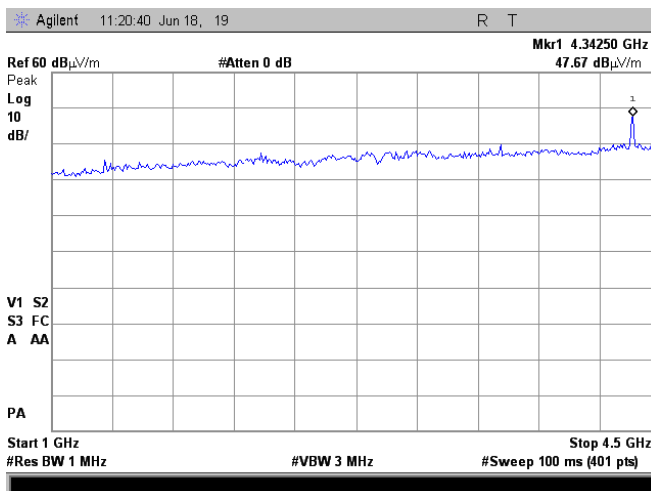
Plot 7.2.9 Radiated emission measurements from 30 to 1000 MHz

Plot 7.2.10 Radiated emission measurements from 1000 to 4500 MHz

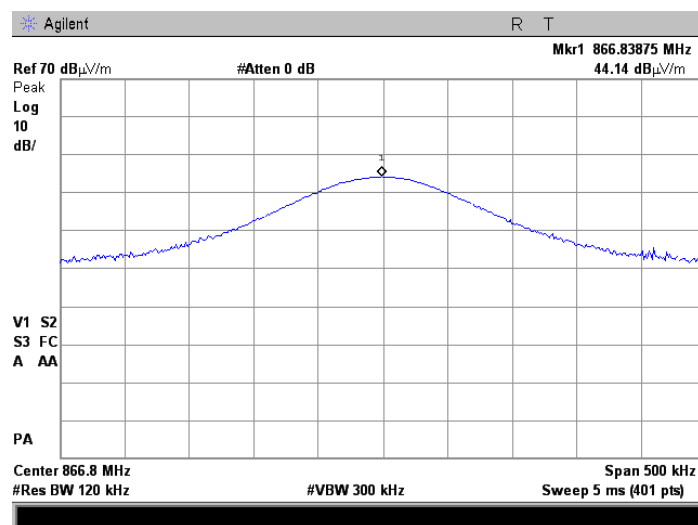

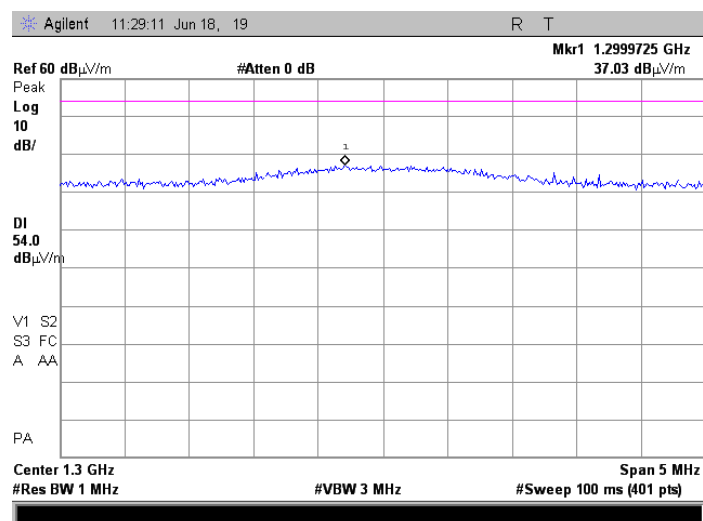
Plot 7.2.11 Radiated emission measurements at the second harmonic frequency

Plot 7.2.12 Radiated emission measurements at the third harmonic frequency

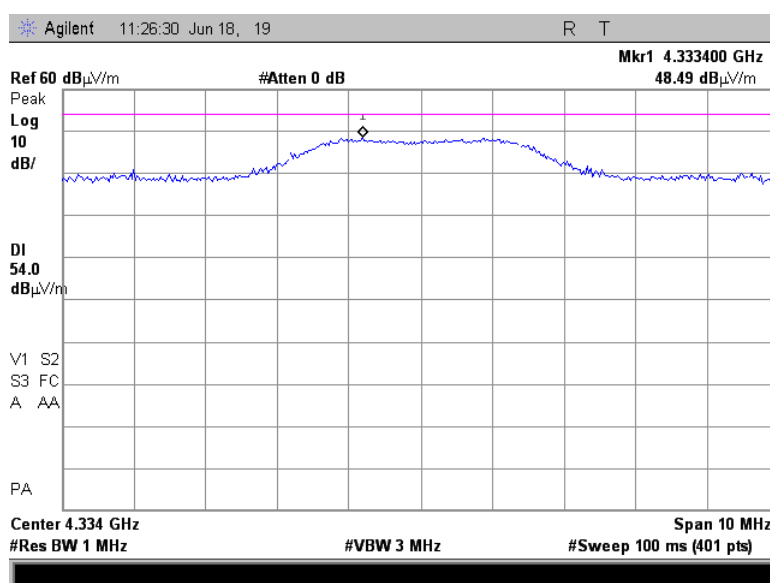

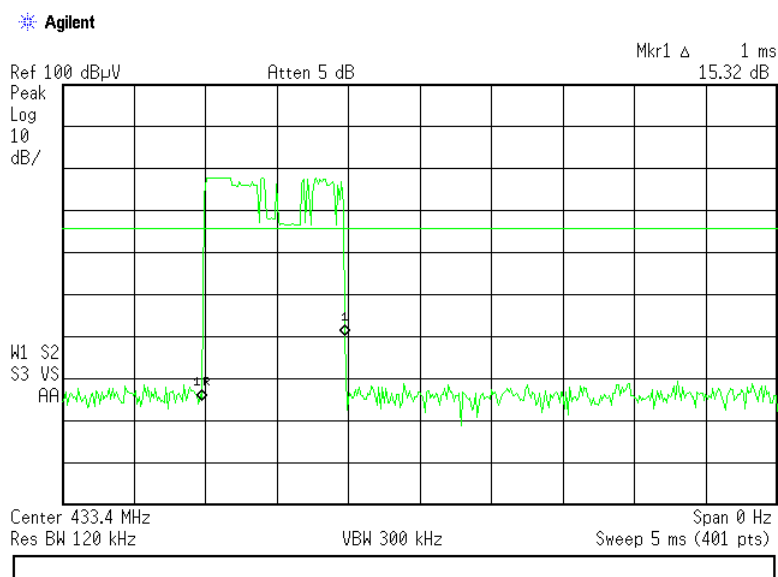
Plot 7.2.13 Radiated emission measurements at the tenth harmonic frequency

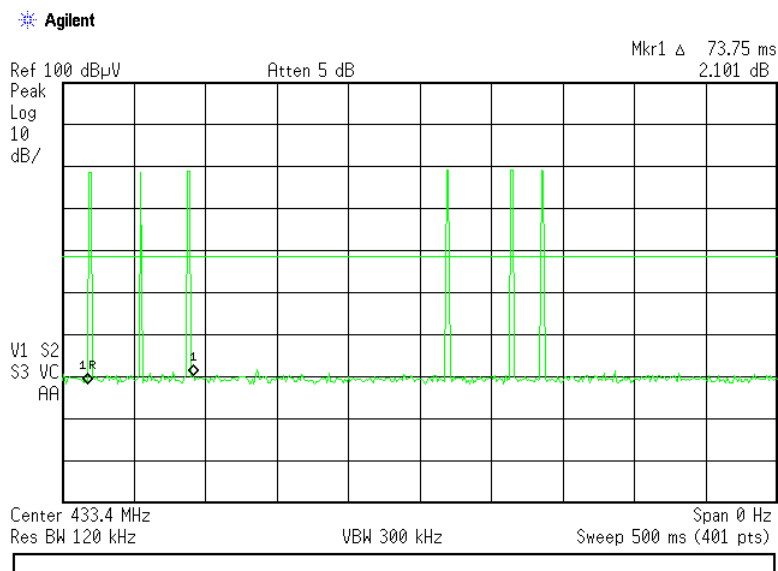

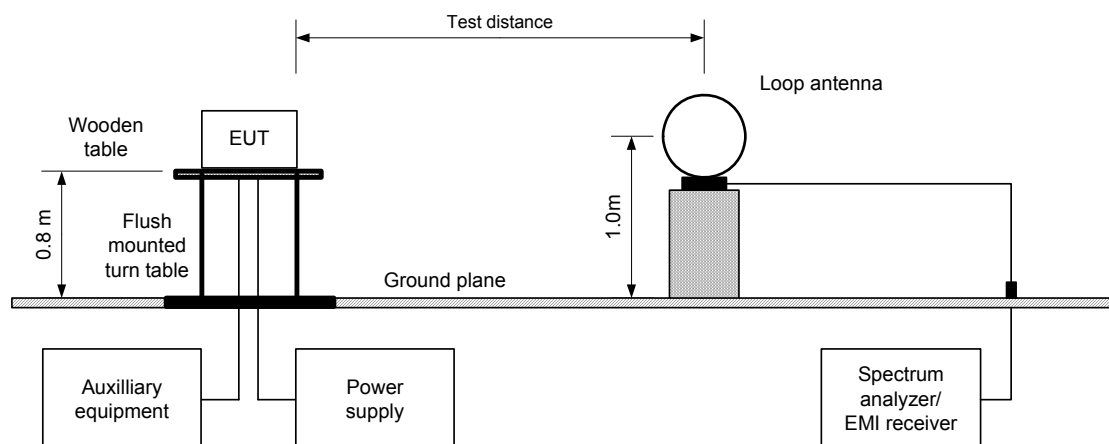

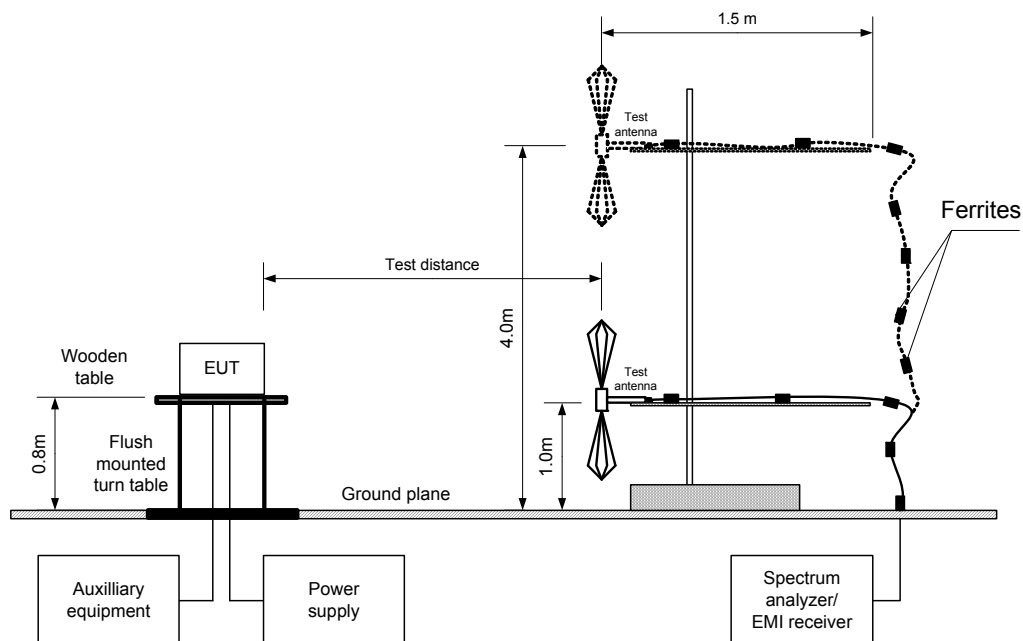

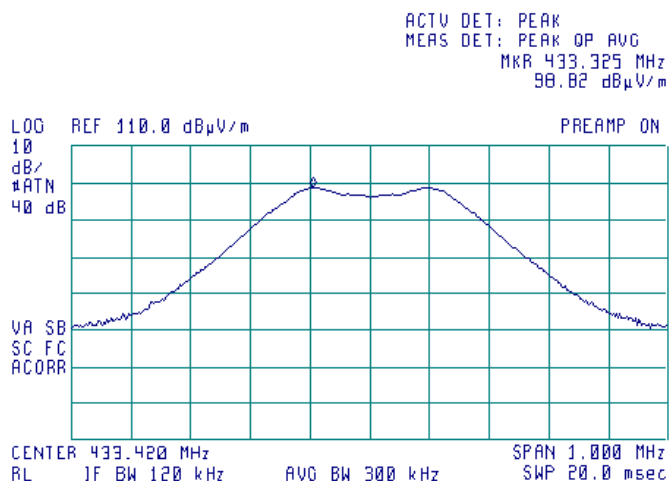
Plot 7.3.1 Radiated emission measurements at the fundamental frequency

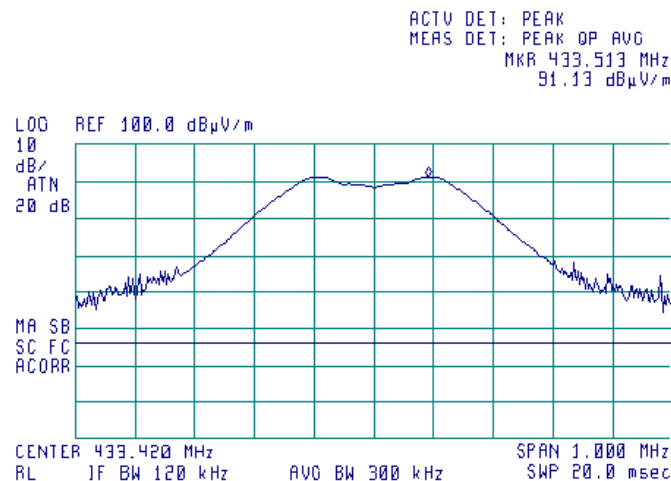

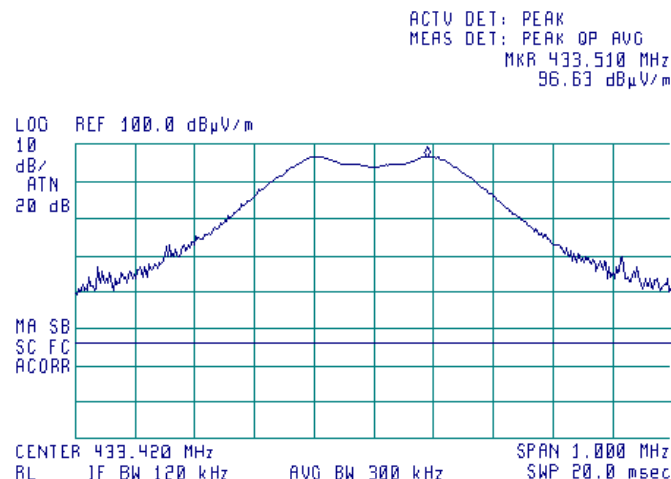
Plot 7.3.3 Radiated emission measurements at the fundamental frequency

Plot 7.3.4 Radiated emission measurements at the fundamental frequency

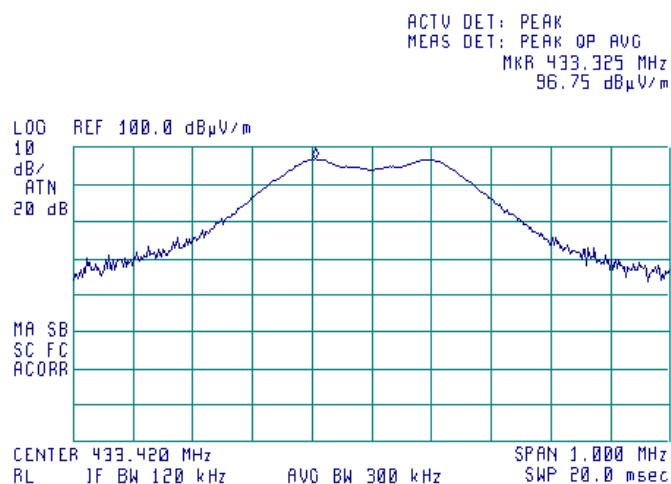

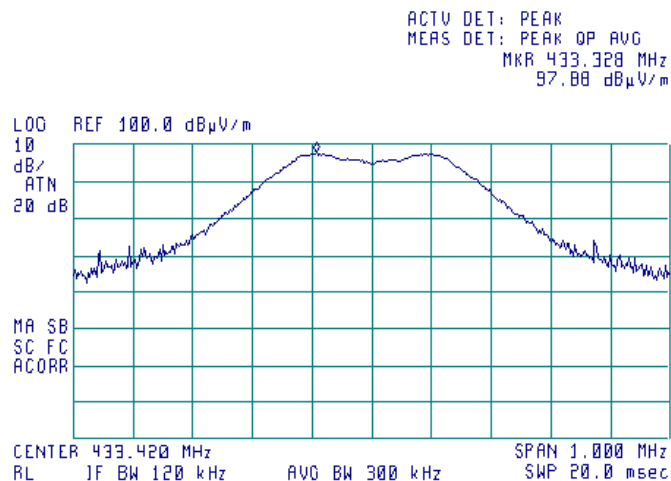
Plot 7.3.5 Radiated emission measurements at the fundamental frequency

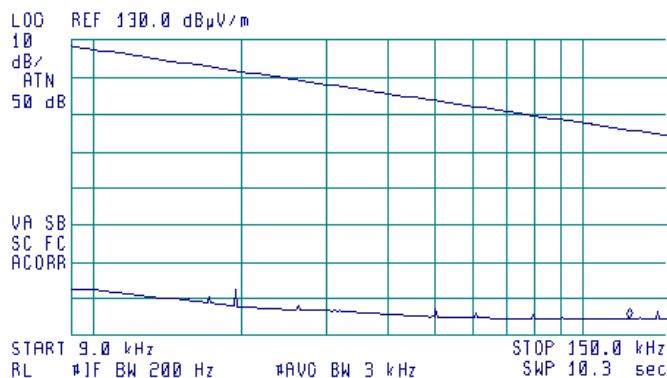

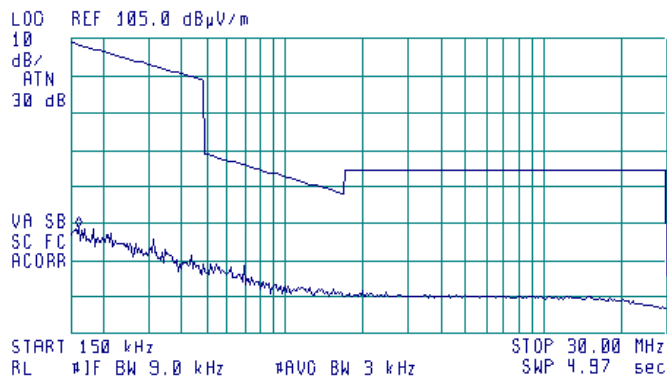


Plot 7.3.8 Radiated emission measurements from 0.15 to 30 MHz

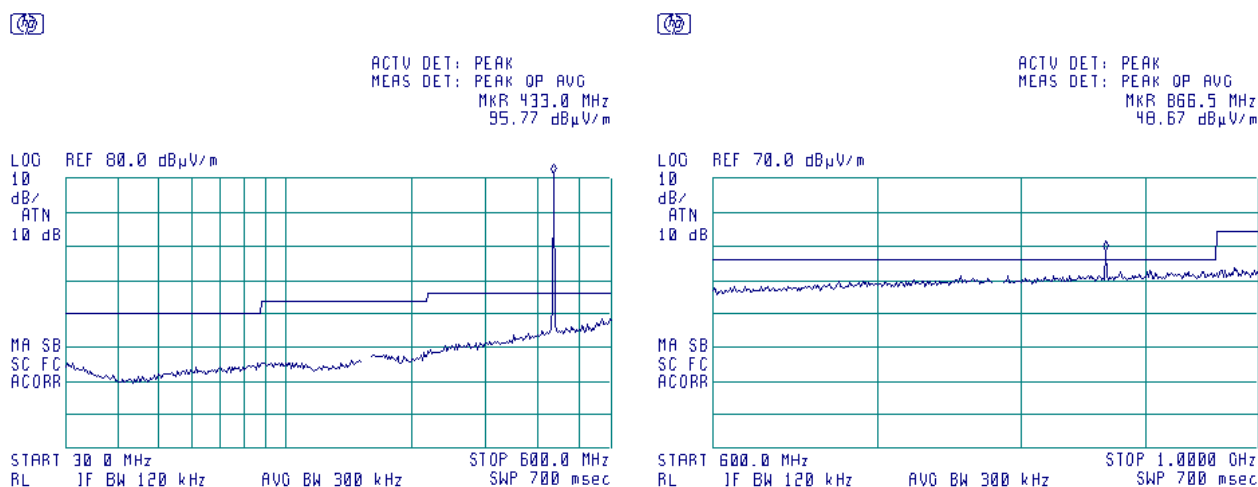

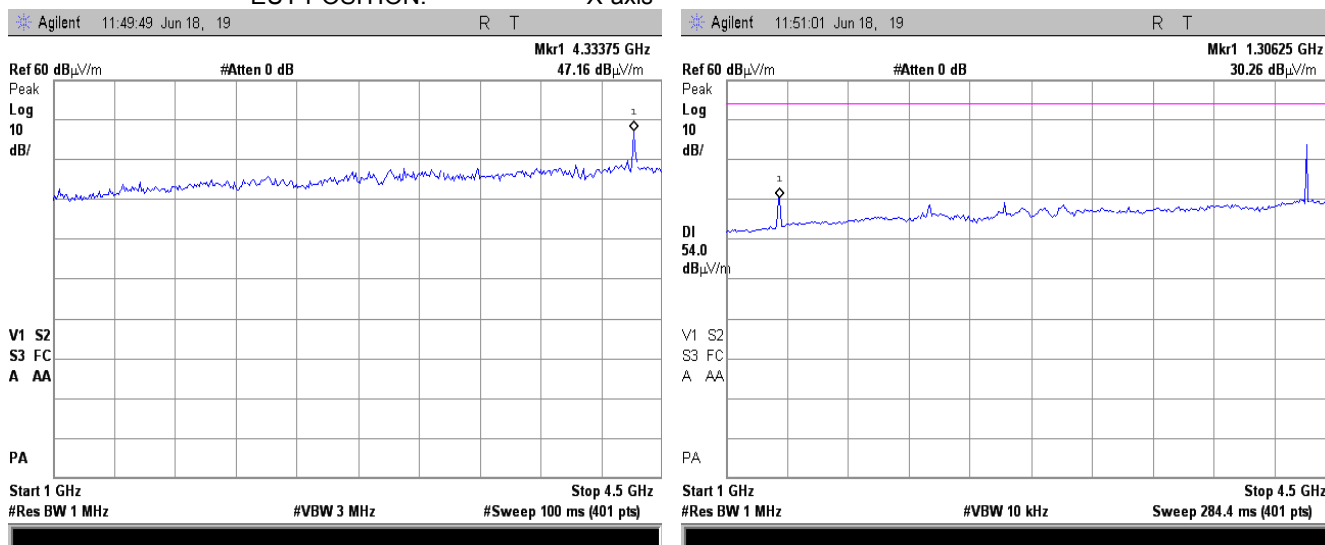
Plot 7.3.9 Radiated emission measurements from 30 to 1000 MHz

Plot 7.3.10 Radiated emission measurements from 1000 to 4500 MHz

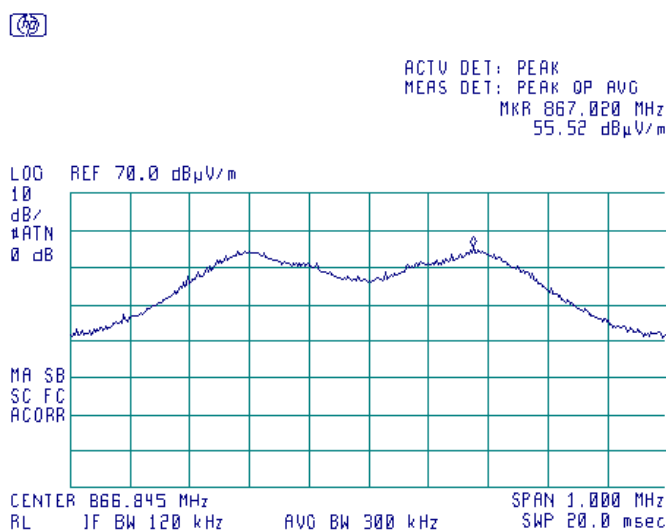

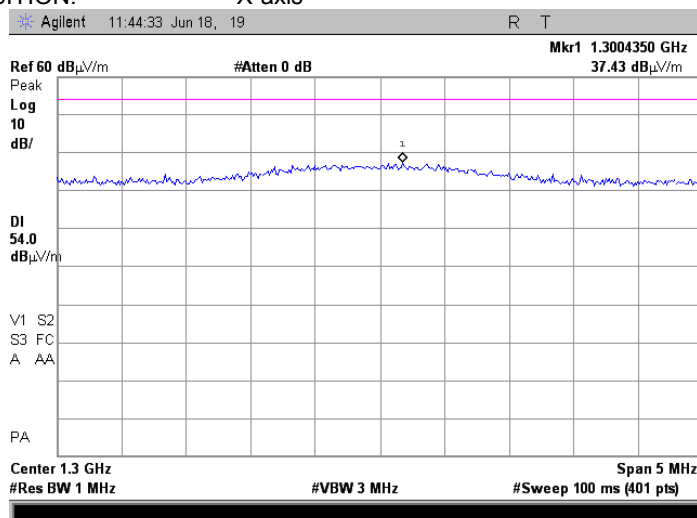
Plot 7.3.11 Radiated emission measurements at the second harmonic frequency

Plot 7.3.12 Radiated emission measurements at the third harmonic frequency

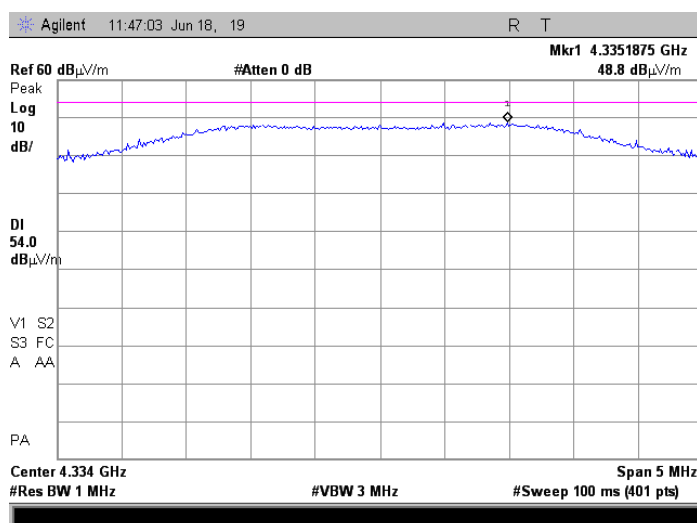

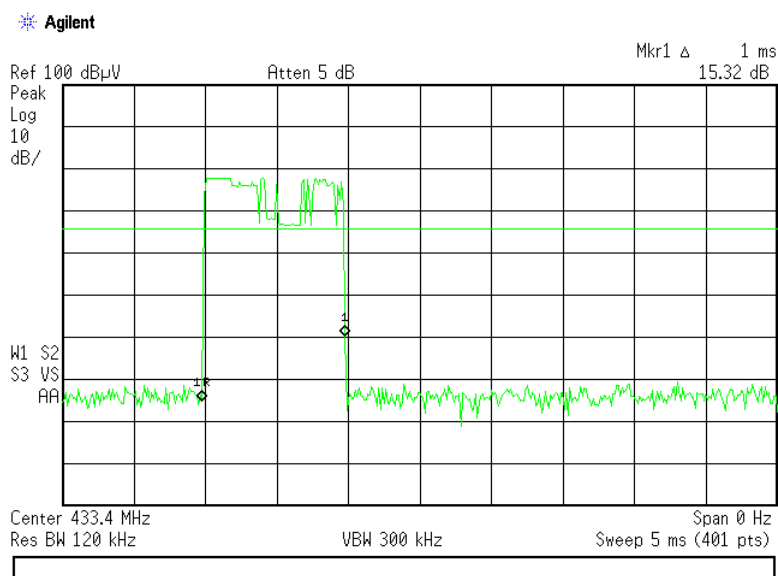
Plot 7.3.13 Radiated emission measurements at the tenth harmonic frequency

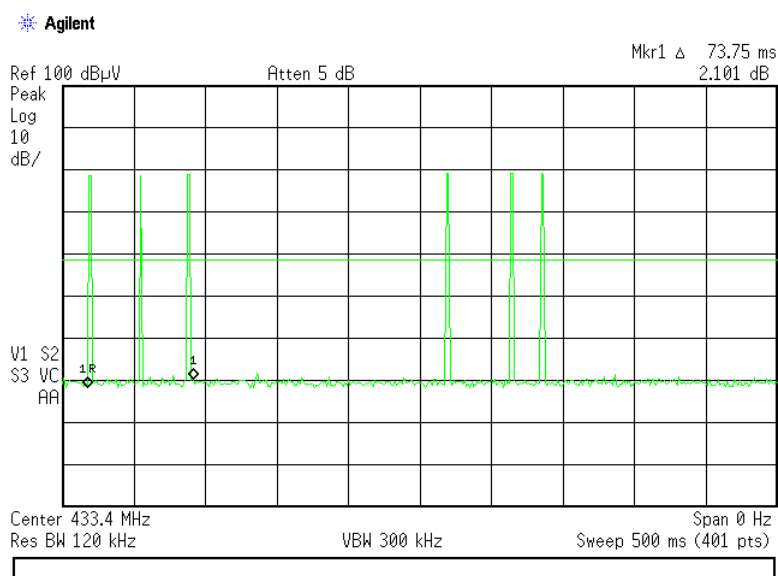

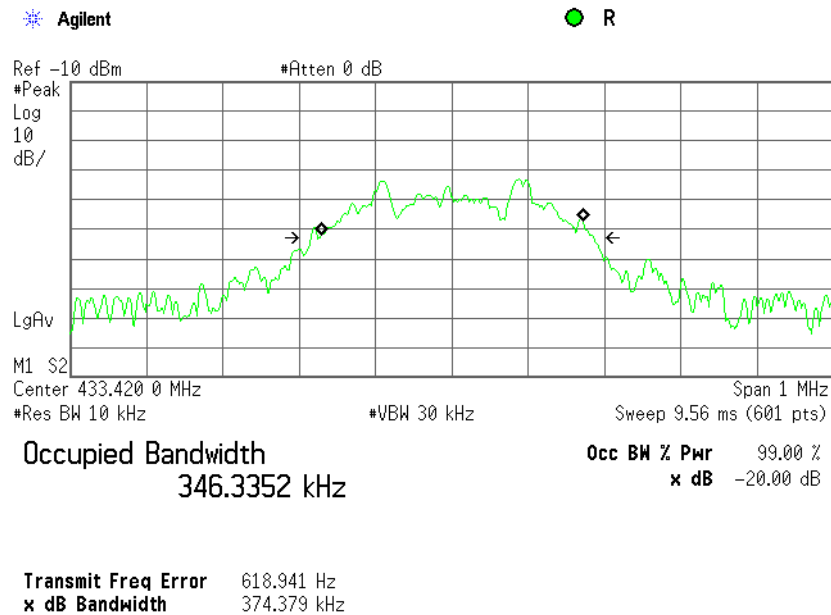

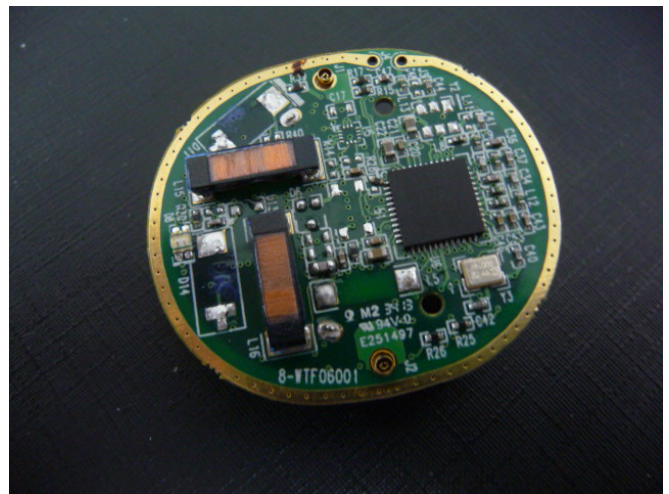

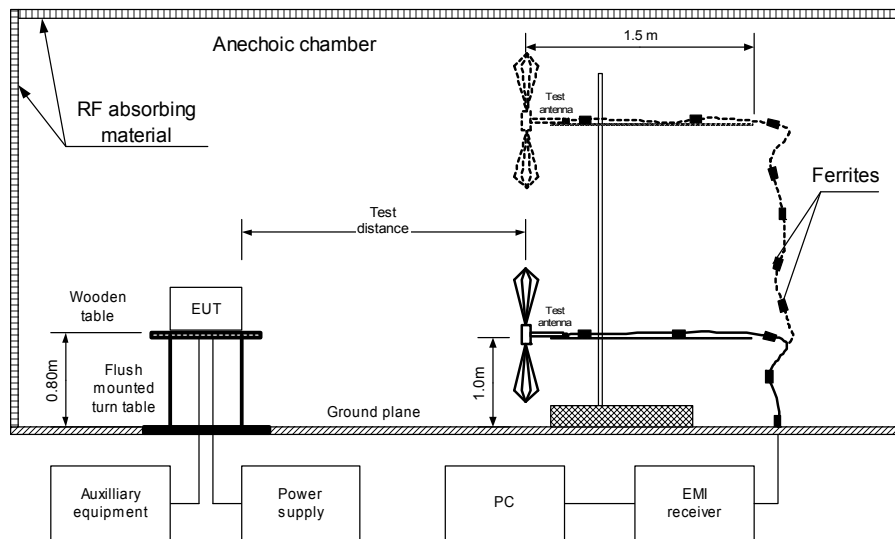

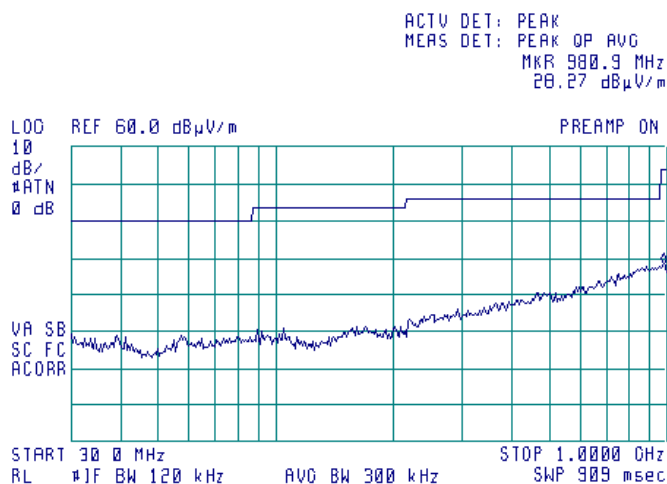

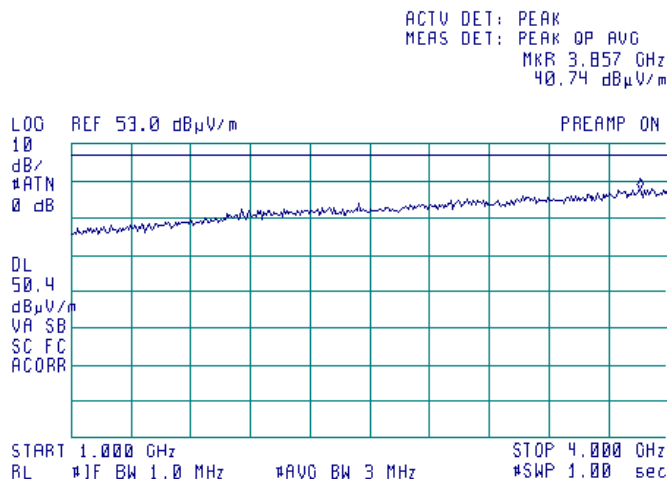
Plot 8.1.1 Radiated emission measurements in 30 - 1000 MHz range, vertical& horizontal antenna polarization
