To Whom it May Concern,

1. The subject product was tested with 5 access points (all access points have FCC ID from the original manufacturers) in the operating frequency bands 2.412-2.462, 5.18-5.24, and 5.745-8.805 GHz.
2. Separate test reports for DTS and NII bands for each access point were issued.
3. The results of intermodulation testing for all access points appears in test report no. 860M With WCE FCC ID OJFMA860WCO 5GHz E76418.00.
4. The following exhibits are common to all 5 applications:
FCC labels for the 860M and WCE, label locations for the 860M and WCE, external photos, internal photos, test setup photos, operational description, block diagram, electrical schematics, users manual, and parts list.
