Reason for request:

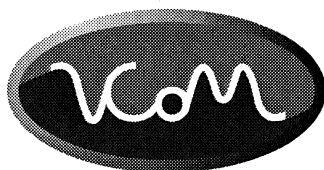
This information is a trade secret. VCom Inc. developed the TR850 product in response
to commercial marketplace requirements. Its design and functional features are exclusive
to VCom.

The TR850 product is offered in the highly competitive Point-to-Multi-Point Fixed
Broadband Wireless service market. Technology in the field of wireless communications
is evolving rapidly, and confidentiality of proprietary design information is essential to
maintain competitiveness in this market. Disclosure of this information may allow
competitors to benefit from VCom's intellectual property.

All employees of VCom Inc. are required to sign an Intellectual Property Agreement
form upon becoming employed with VCom. This will identify the responsibility and
rights of both VCom and the employee in regard to any interest or rights involved in the
discoveries, inventions, improvements, etc. normally referred to as "Inventions" which
are made by the employee during the course of his/her work.

All OEM manufacturing partners, as well as any visitors to the plant, are required to sign
non-disclosure agreements prior to being granted access to production and
research/development areas. Electronic originals of proprietary documents are password
protected and hardcopies are controlled.

This information is not available to the public and there have been no disclosures to
parties who are not employees of VCom with the exception of Bay Area Compliance Lab
Corp., who is acting on our behalf as an agent to FCC.

The period of time required for nondisclosure for the TR850 product is for the life of the product (typically 20 years) and beyond, since features of the current design may be incorporated in future VCom products. This period should therefore be 20 years.

The TR850 product cannot be readily reverse-engineered without the schematics and parts lists. The TR850 incorporates proprietary software embedded in its circuits that is essential for its operation.

The TR850 is not sold directly to the general public; it is sold only to known, approved customers after credit check. No units are sold to known or potential competitors where there may be a possibility of reverse engineering. The TR850 requires professional installation.

The applicant understands that pursuant to Section 0.457 of the Rules, disclosure of this application and all accompanying documentation will not be made before the date of the Grant for this application.
