


Fig.2 Photograph of the Tissue Simulant liquid depth 15cm for Flat position








Fig.3 Antenna position of EUT




Fig.5 Lap-held mode




Fig.6 Primary portrait mode




Fig.7 Secondary portrait mode.




Fig.8 Primary Landscape mode.




Fig.9 Secondary landscape mode.
