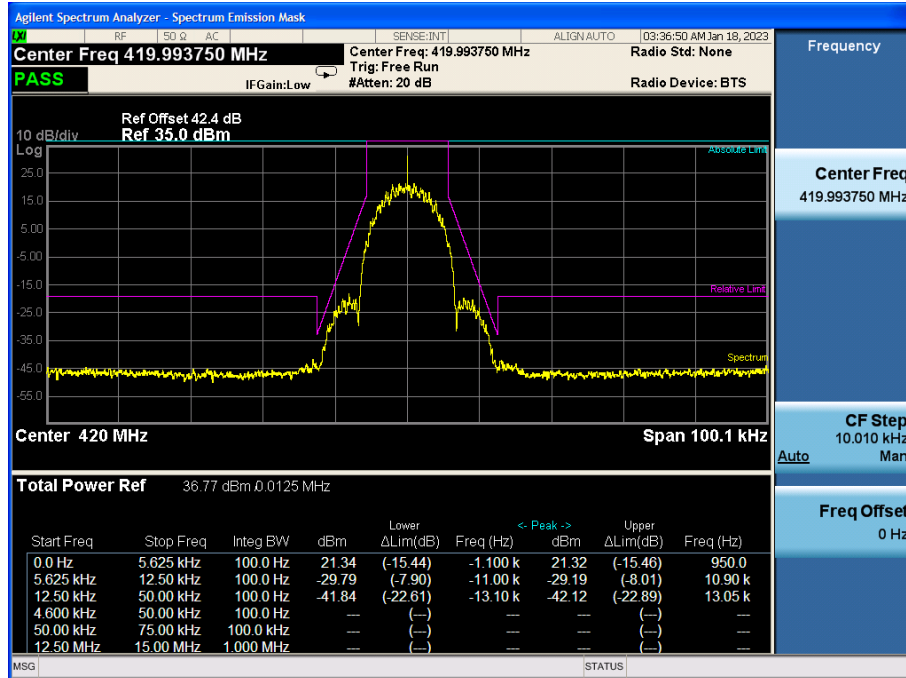


DL_H-DQPSK_MCH_3dB above AGC

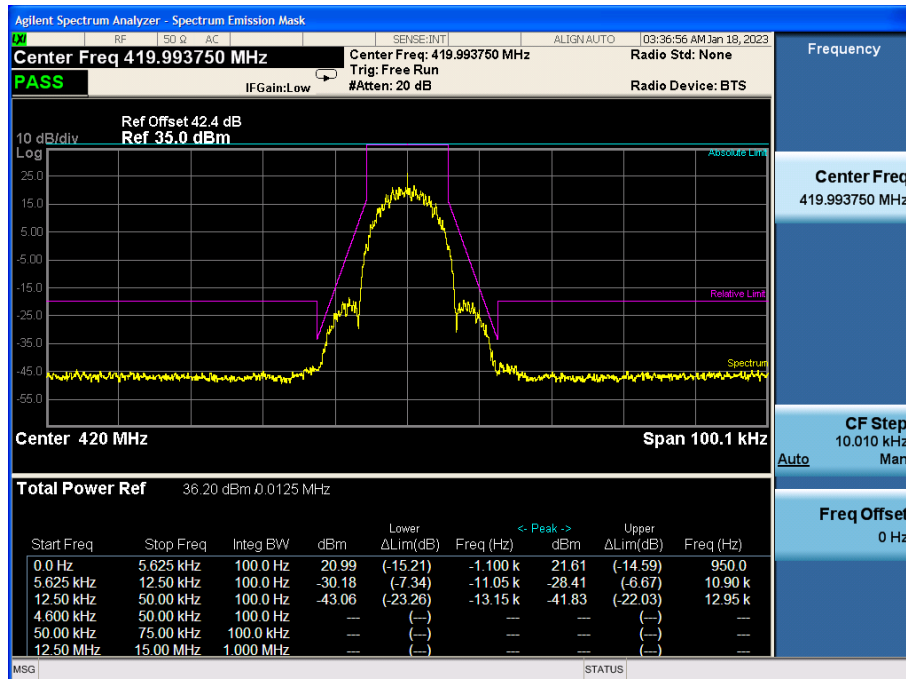
