2 System Test Configuration

2.1 EUT Configuration

Fig. 2-1 Radiated Emission

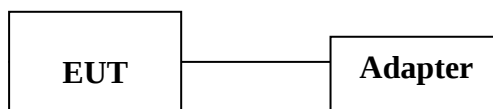


Fig. 2-2 Conducted (Antenna Port) Configuration

Fig. 2-3 AC Power Line Conducted Emission

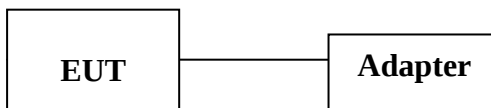

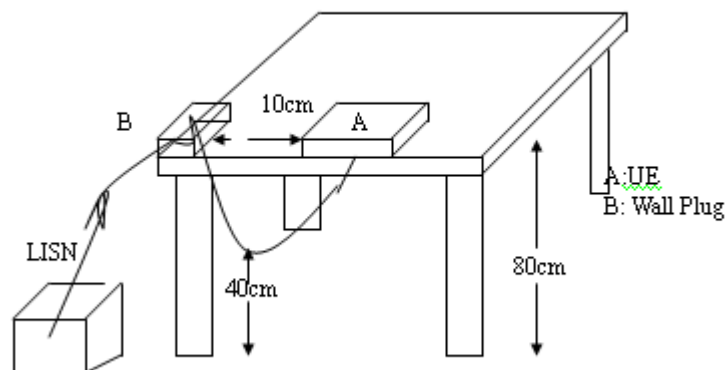

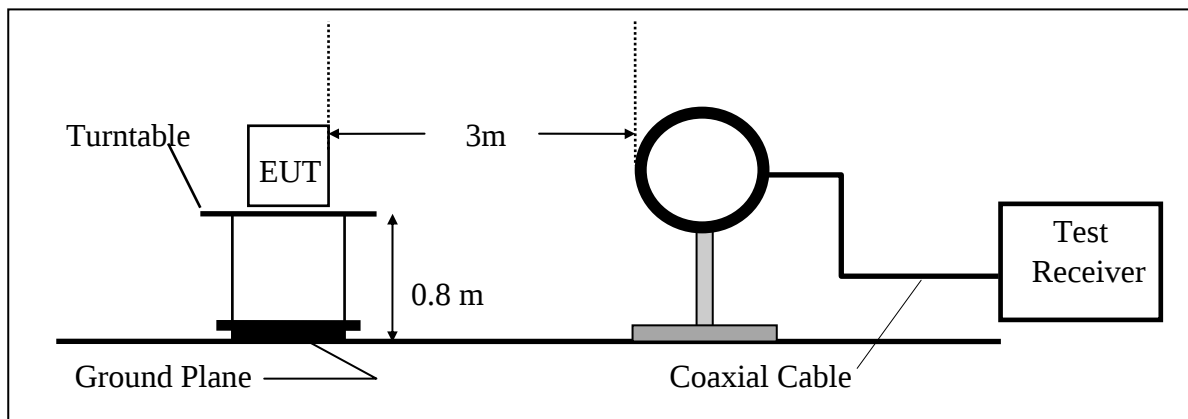

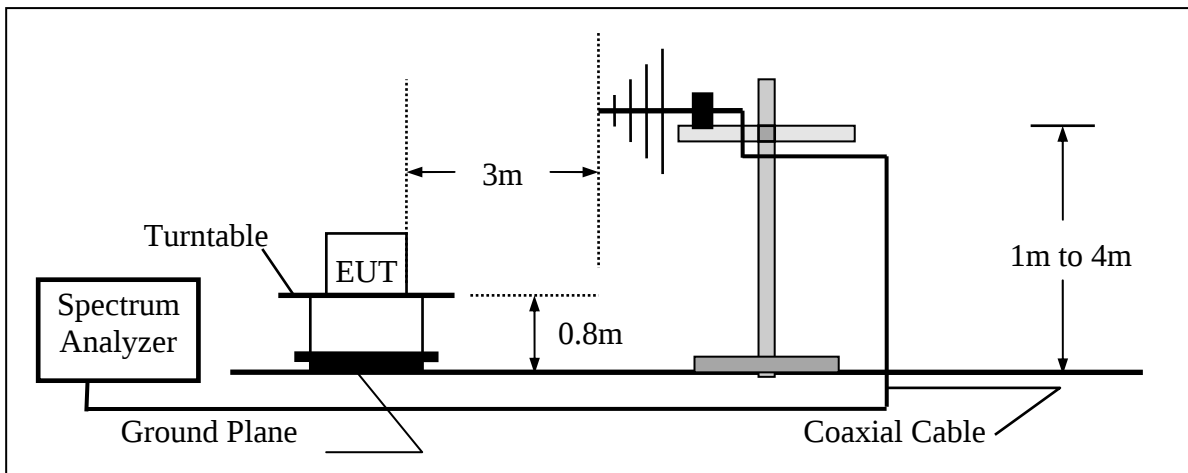

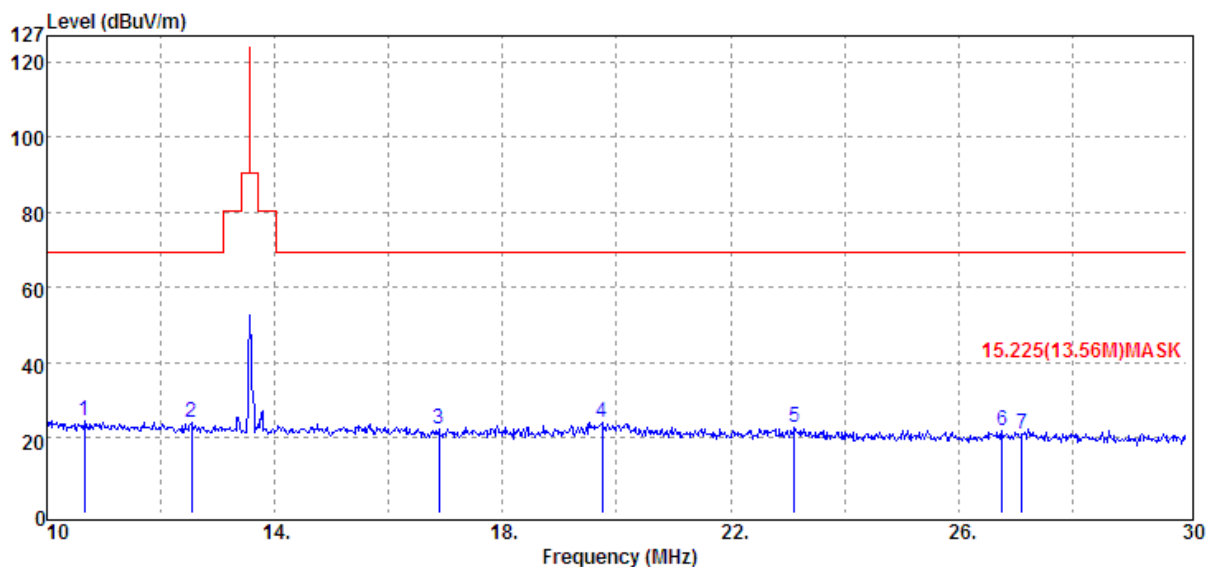

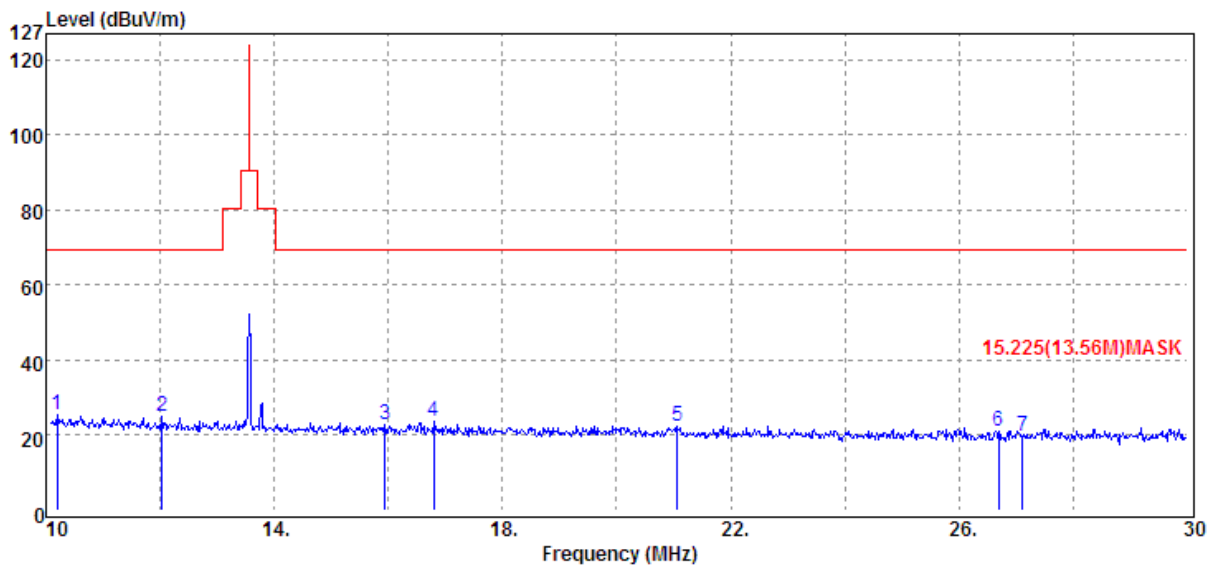

10 ANTENNA REQUIREMENT

10.1. Standard Applicable:

According to §15.203, Antenna requirement.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. When a measurement at the antenna connector is used to determine RF output power, the effective gain of the device's antenna shall be stated, based on measurement or on data from the antenna manufacturer.

For transmitters of RF output power of 10 milliwatts or less, only the portion of the antenna gain that is in excess of 6 dBi (6 dB above isotropic gain) shall be added to the measured RF output power to demonstrate compliance with the radiated power limits specified in the applicable standard. For transmitters of output power greater than 10 milliwatts, the total antenna gain shall be added to the measured RF output power to demonstrate compliance to the specified radiated power limits.
