3 Description of the Equipment under Test (EUT)

3.1 General Description

HRY-LX2 is subscriber equipment in the GSM/WCDMA/LTE system. The GSM frequency bands include GSM850, GSM900, DCS1800 and PCS1900. The UMTS frequency band includes band I, band II, band IV, band V and band VIII. The LTE frequency bands include band 1, band 2, band 3, band 4, band 5, band 7, band 8, band 28, band 38, band 40 and band 41. The Mobile Phone implements such functions as RF signal receiving/transmitting, LTE/HSPA/UMTS and GSM/GPRS/EDGE protocol processing, voice, video MMS service, GPS, AGPS and WIFI etc. Externally it provides one micro SD card interface, earphone port (to provide voice service) and one and two SIM card interface. HRY-LX2 is dual and single SIM smart phone. It also provides Bluetooth module to synchronize data between a PC and the phone, or to use the built-in modem of the phone to access the Internet with a PC, or to exchange data with other Bluetooth devices.

NOTE1: Only Bluetooth BLE test data included in this report.

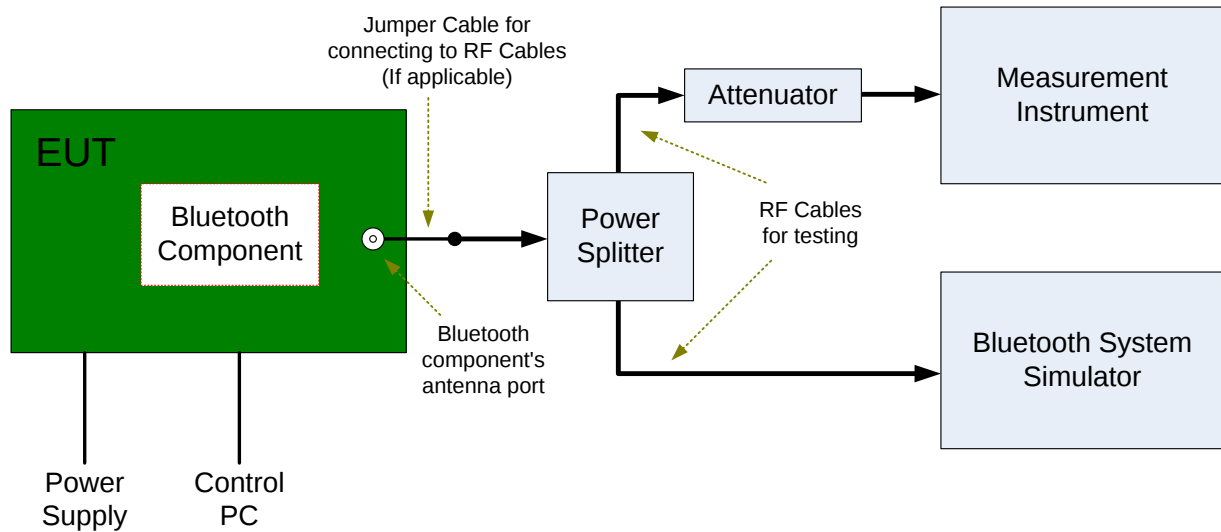
