2 Product Description

2.1 Production Information

2.1.1 General Description

HSDPA/UMTS/GPRS/GSM/EDGE Mobile Phone with Bluetooth- Q1-218H/U9120-6 is subscriber equipment in the WCDMA/GSM system. The WCDMA/HSDPA frequency band is Band I and Band II and Band V, but only Band II band test data included in this report. The GSM/GPRS/EDGE frequency band includes GSM850 and GSM900 and DCS1800 and PCS1900, but only PCS1900 band test data included in this report. The Mobile Phone implements such functions as RF signal receiving/transmitting, WCDMA/HSDPA and GSM/GPRS/EDGE protocol processing, voice, video and MMS service etc. Externally it provides micro SD card interface, earphone port(to provide voice service) and USIM card interface. It also provides Bluetooth module to synchronize data between a PC and the phone, or to use the built-in modem of the phone to access the Internet with a PC, or to exchange data with other Bluetooth devices.

Note: Only tests for WCDMA Band II and GSM/GPRS/EDGE 1900MHz (PCS) band was included in this report for the requirement of FCC part 2 & 24.

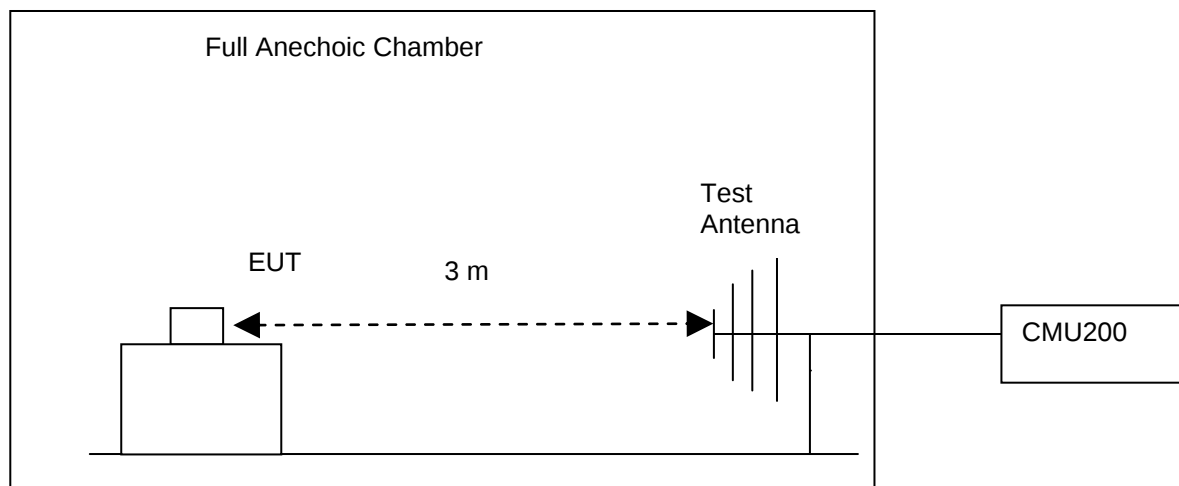
6.1.3 Test Method and Setup

- (a) For transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, ERP shall be measured when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in 2.1033(c)(8). Connect the Mobile Phone to the wireless communication tester CMU200 via the air interface. The band is set as PCS1900MHz and WCDMA1900.

- (b) Test the Radiated maximum output power by the CMU200 received from test antenna.
- (c) Use substitution method to verify the maximum output power. The EUT is substituted by a horn antenna. The horn is connected to a signal generator. And then adjust the output level of the signal generator to get the same received power recorded in step (b) on CMU200, and record the power level of Signal Generator. Of course, the cable loss at the test frequency should be compensated.

Step 2: Substitution method to verify the maximum EIRP

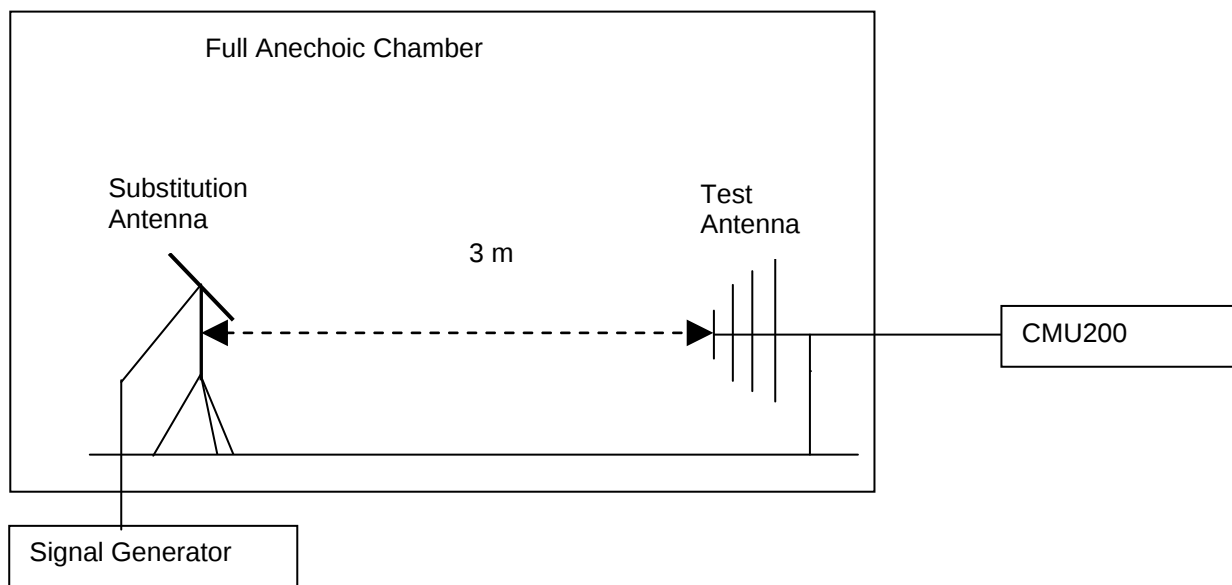


Figure 1. Test Set-up

NOTE: Effective radiated power (ERP) refers to the radiation power output of the EUT, assuming all emissions are radiated from horn antennas.

There is a constant difference of 2.15 dB between EIRP and ERP.

$EIRP (dBm) = ERP (dBm) + 2.15$ (ITU-R Recommendation SM.329-10).

(a)For transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, Conducted maximum power shall be measured when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in 2.1033(c)(8). Connect the Mobile Phone to the wireless communication tester CMU200 via the antenna connector. The band is set as PCS and WCDMA1900M.

(b)Test the Conducted maximum output power by the CMU200.

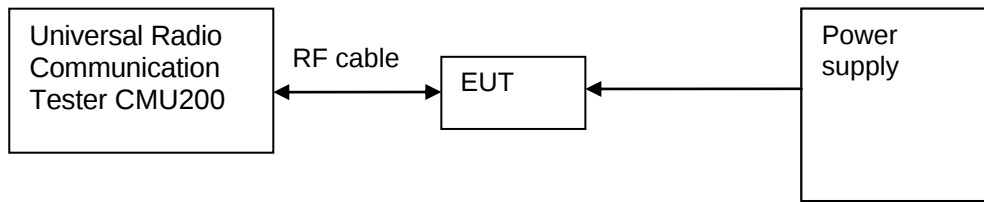


Figure 2. Test Set-up

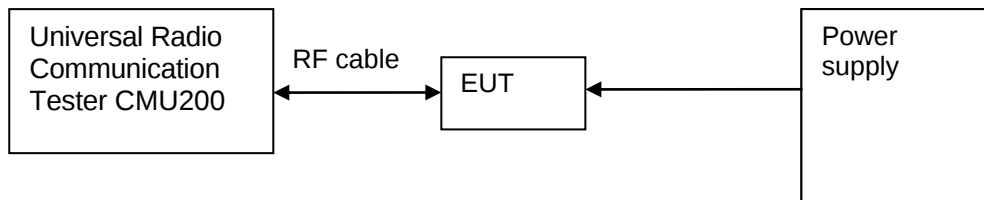


Figure 3. Test Set-up

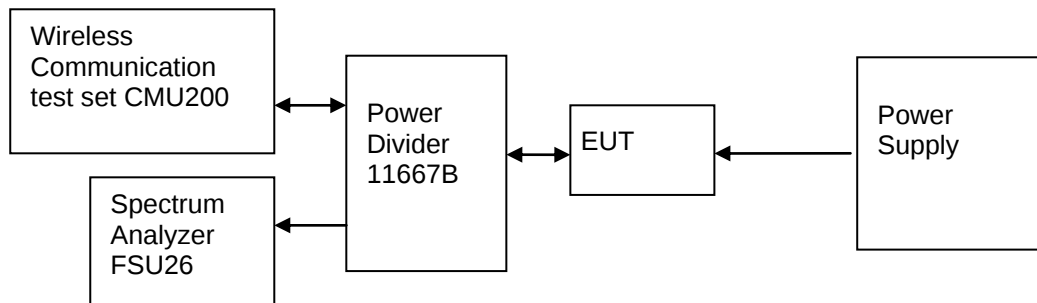


Figure 4. Test Set-up

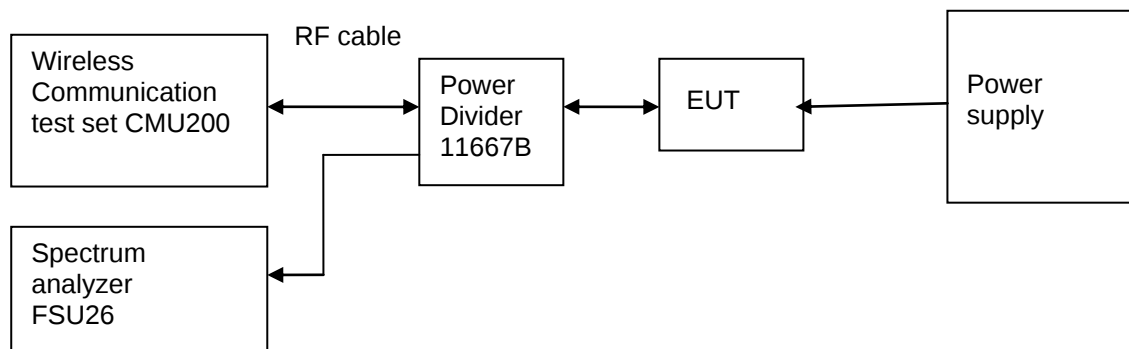


Figure 5. Test Set-up

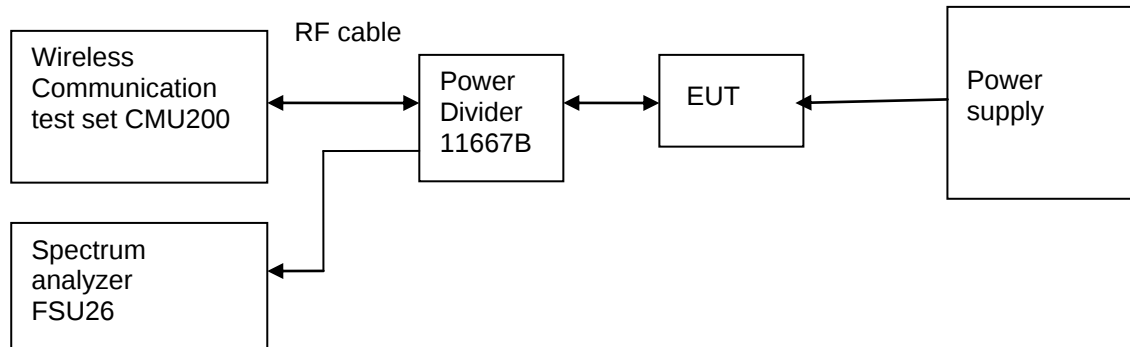


Figure 6. Test Set-up

(b) Frequency measurements shall be made at the extremes of the specified temperature range and at intervals of not more than 10° centigrade through the range. A period of time sufficient to stabilize all of the components of the oscillator circuit at each temperature level shall be allowed prior to frequency measurement. The short-term transient effects on the frequency of the transmitter due to keying (except for broadcast transmitters) and any heating element cycling normally occurring at each ambient temperature level also shall be shown. Only the portion or portions of the transmitter containing the frequency determining and stabilizing circuitry need be subjected to the temperature variation test.

(d) The frequency stability shall be measured with variation of primary supply voltage as follows:

- (1) Vary primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried battery equipment.
- (2) For hand carried, battery powered equipment, reduce primary supply voltage to the battery operating end point, which shall be specified by the manufacturer. Mobile phone can work normally from 3.6V to 4.2V, test below is done according to this limit.
- (3) The supply voltage shall be measured at the input to the cable normally provided with the equipment,

or at the power supply terminals if cables are not normally provided. Effects on frequency of transmitter keying (except for broadcast transmitters) and any heating element cycling at the nominal supply voltage and at each extreme also shall be shown.

(e) When deemed necessary, the Commission may require tests of frequency stability under conditions in addition to those specifically set out in paragraphs (a), (b), (c) and (d) of this section. (For example, measurements showing the effect of proximity to large metal objects, or of various types of antennas, may be required for portable equipment.)

Test Set up

Connect the EUT to the Wireless Communication test set CMU200 via the connector. Then measure the frequency error by the Wireless Communication test set CMU200. The EUT's output is matched with a 50 Ω load.

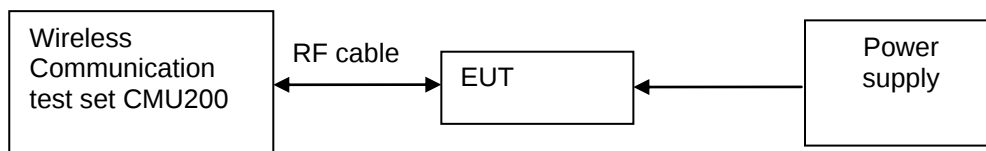


Figure 7. Test Set up
