HSDPA/UMTS/GPRS/GSM Mobile Phone with Bluetooth- U8120/Vodafone 845/V845/Joy is subscriber equipment in the WCDMA/GSM system. The GSM/GPRS frequency band includes GSM900 and DCS1800 and PCS1900, but only PCS1900MHz band test data included in this report. The Mobile Phone implements such functions as RF signal receiving/transmitting, HSDPA/UMTS and GSM/GPRS protocol processing, voice, video, MMS service, GPS, and WIFI etc. Externally it provides micro SD card interface, earphone port(to provide voice service) and USIM card interface. It also provides Bluetooth module to synchronize data between a PC and the phone, or to use the built-in modem of the phone to access the Internet with a PC, or to exchange data with other Bluetooth devices.




Figure 1. Test Set-up




Figure 2. Test Set-up






Figure 4. Test Set-up




Figure 5. Test Set-up




Figure 6. Test Set-up




Figure 7. Test Set-up




Figure 8. Test Set up




Figure 9. Test Set-up
