2.1 Production Information

2.1.1 General Description

HUAWEI IDEOS SERIES; HSDPA/UMTS/GPRS/GSM/EDGE Mobile Phone with Bluetooth; IDEOS, U8150-B is subscriber equipment in the WCDMA/GSM system. It supports GSM/GPRS/EDGE 850/900/1800/1900 and WCDMA/HSDPA 1900/850/2100/1700; But only GSM/GPRS/EDGE 1900 and WCDMA/HSDPA 1900 can be used in this report. The Mobile Phone implements such functions as RF signal receiving/transmitting, HSDPA/UMTS and GSM/GPRS protocol processing, voice, video, MMS service, GPS, and Wi-Fi etc. Externally it provides micro SD card interface, earphone port (to provide voice service) and USIM card interface. It also provides Bluetooth module to synchronize data between a PC and the phone, or to use the built-in modem of the phone to access the Internet with a PC, or to exchange data with other Bluetooth devices.

Note: Only tests for WCDMA Band II and GSM/GPRS/EDGE 1900MHz (PCS) band was included in this report for the requirement of FCC part 2 & 24.


6.1.3 Test Method and Setup

- (a) For transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, ERP shall be measured when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in 2.1033(c)(8). Connect the Mobile Phone to the wireless communication tester CMU200 via the air interface. The band is set as PCS1900M and WCDMA1900.
- (b) Test the Radiated maximum output power by the CMU200 received from test antenna.

- (c) Use substitution method to verify the maximum output power. The EUT is substituted by a horn antenna. The horn is connected to a signal generator. And then adjust the output level of the signal generator to get the same received power recorded in step (b) on CMU200, and record the power level of Signal Generator. Of course, the cable loss at the test frequency should be compensated.

Step 2: Substitution method to verify the maximum EIRP




Figure 1. Test Set-up

 There is a constant difference of 2.15 dB between EIRP and ERP.
 $EIRP (dBm) = ERP (dBm) + 2.15$ (ITU-R Recommendation SM.329-10).




Figure 2. Test Set-up

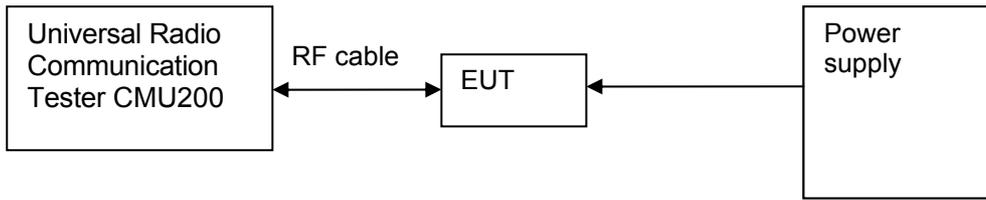


Figure 3. Test Set-up

6.4.3 Test Method and Setup

Mobile Phone was connected to the wireless spectrum analyzer R&S FSQ26 via the one RF connector. The band class is set as PCS and WCDMA1900M; The EUT was controlled to transmit maximum power. Measure and record the occupied bandwidth of the EUT by the R&S FSQ26.

The OBW, that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured under the following conditions as applicable:

(g) Transmitter in which the modulating base band comprises not more than three independent channels - when modulated by the full complement of signals for which the transmitter is rated. The level of modulation for each channel should be set to that prescribed in rule parts applicable to the services for which the transmitter is intended. If specific modulation levels are not set forth in the rules, the tests should provide the manufacturer's maximum rated condition.




Figure 4. Test Set-up




Figure 5. Test Set-up




Figure 6. Test Set-up

- (3) The supply voltage shall be measured at the input to the cable normally provided with the equipment,

or at the power supply terminals if cables are not normally provided. Effects on frequency of transmitter keying (except for broadcast transmitters) and any heating element cycling at the nominal supply voltage and at each extreme also shall be shown.

(e) When deemed necessary, the Commission may require tests of frequency stability under conditions in addition to those specifically set out in paragraphs (a), (b), (c) and (d) of this section. (For example, measurements showing the effect of proximity to large metal objects, or of various types of antennas, may be required for portable equipment.)




Figure 7. Test Set up






TM1:GPRS/GSM Channel 661






TM2:EDGE Channel 661





TM3: WCDMA Channel 9400





Occupied Bandwidth According to FCC Part 2.1049 & Part 24 Subpart E




TM1:GPRS/GSM Channel 512






TM2:EDGE Channel 512






TM3: WCDMA Channel 9262






TM3: WCDMA Channel 9400






TM1:GPRS/GSM Channel 810




