3.1.1 General Description

VKY-L09 is subscriber equipment in the LTE/ WCDMA/GSM system. The LTE frequency band is Band I,Band II,Band III,Band IV,Band V, Band VII,Band VIII, Band IX,Band XII,BandXVII, Band XVIII ,Band XIX, Band XX, Band XXVI, Band XXVIII, Band XXIX,Band XXXVIII,BandXXXIX, Band XL and Band XLI. The HSUPA/HSDPA/UMTS frequency band is Band I, Band II, Band IV, Band V, Band VI, Band VIII and Band XIX, The GSM/GPRS/EDGE frequency band includes GSM850 and GSM900 and DCS1800 and PCS1900, The Mobile Phone implements such functions as RF signal receiving/transmitting, LTE/ WCDMA /GSM protocol processing, voice, video, MMS service, GPS, AGPS,NFC and WIFI etc. Externally it provides earphone port (to provide voice service) and USIM card interface. It also provides Bluetooth module to synchronize data between a PC and the phone, or to use the built-in modem of the phone to access the Internet with a PC, or to exchange data with other Bluetooth devices.




5.1 20dB Bandwidth Measurement


5.5.1 Test Setup

The mains cable of the EUT (maybe per AC/DC Adapter) must be connected to LISN. The LISN shall be placed 0.8 m from the boundary of EUT and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance is between the closest points of the LISN and the EUT. All other units of the EUT and associated equipment shall be at least 0.8m from the LISN.

Ground connections, where required for safety purposes, shall be connected to the reference ground point of the LISN and, where not otherwise provided or specified by the manufacturer, shall be of same length as the mains cable and run parallel to the mains connection at a separation distance of not more than 0.1 m.
