





Body worn - distance between flat phantom and mobile phone is 15 mm






Fig.3 EUT front to flat phantom






Fig.4 EUT back to flat phantom






Fig.5 EUT right to flat phantom







Fig.6 EUT left to flat phantom







Fig.7 EUT top to flat phantom






Fig.8 EUT bottom to flat phantom




Fig.11 Antenna position of EUT
