## C. Test Site

All testing was performed at MET Laboratories, Inc., 3162 Belick Street, Santa Clara, CA 95054. All equipment used in making physical determinations is accurate and bears recent traceability to the National Institute of Standards and Technology.

Radiated Emissions measurements were performed in a 3 meter semi-anechoic chamber (equivalent to an Open Area Test Site). In accordance with §2.948(a)(3), a complete site description is contained at MET Laboratories.

## D. Description of Test Sample

The Meru Networks, Inc. Mission Peak (AP822iV2), Equipment Under Test (EUT), is an 802.11AC wireless access point (WAP) that allows wireless devices to connect to a wired network using Wi-Fi, standard. The WAP usually connects to a router (via a wired network), and can relay data between the wireless devices (such as computers or printers) and wired devices on the network. The EUT supports 2.4 GHz and 5 GHz operation.




Figure 1. Block Diagram of Test Configuration

**Test Procedures:**

The EUT was placed on a non-metallic table, 80 cm above the ground plane inside a semi-anechoic chamber. The method of testing, test conditions, and test procedures of ANSI C63.4 were used. The EUT was powered through a 50 $\Omega$ /50 $\mu$ H LISN. An EMI receiver, connected to the measurement port of the LISN, scanned the frequency range from 150 kHz to 30 MHz in order to find the peak conducted emissions. All peak emissions within 6 dB of the limit were re-measured using a quasi-peak and/or average detector as appropriate.




Plot 2. Conducted Emissions, Neutral Line, PoE

The EUT was placed on a non-metallic table, 80 cm above the ground plane inside a semi-anechoic chamber. The method of testing and test conditions of ANSI C63.4 were used. An antenna was located 3 m from the EUT on an adjustable mast. A pre-scan was first performed in order to find prominent radiated emissions. For final emissions measurements at each frequency of interest, the EUT was rotated and the antenna height was varied between 1 m and 4 m in order to maximize the emission. Measurements in both horizontal and vertical polarities were made and the data was recorded. Unless otherwise specified, measurements were made using a quasi-peak detector with a 120 kHz bandwidth.

**Test Results:**

The EUT was compliant with the Class B requirement(s) of this section. Measured emissions were below applicable limits.






**Plot 6. Radiated Emissions, 1 GHz – 2 GHz, PoE**



## Electromagnetic Compatibility Criteria for Intentional Radiators

### § 15.203 Antenna Requirement

**Test Requirement:**

**§ 15.203:** An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

The structure and application of the EUT were analyzed to determine compliance with Section 15.203 of the Rules. Section 15.203 states that the subject device must meet at least one of the following criteria:

- a.) Antenna must be permanently attached to the unit.
- b.) Antenna must use a unique type of connector to attach to the EUT.
- c.) Unit must be professionally installed. Installer shall be responsible for verifying that the correct antenna is employed with the unit.

**Results:**

The EUT as tested is compliant the criteria of §15.203 because the EUT has permanent antennas.

## Electromagnetic Compatibility Criteria for Intentional Radiators

### § 15.207 Conducted Emissions Limits

**Test Requirement(s):** **§ 15.207 (a):** For an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30MHz, shall not exceed the limits in the following table, as measured using a 50  $\mu$ H/50  $\Omega$  line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

**Test Procedure:** The EUT was placed on a 0.8 m-high wooden table inside a screen room. The EUT was situated such that the back of the EUT was 0.4 m from one wall of the vertical ground plane, and the remaining sides of the EUT were no closer than 0.8 m from any other conductive surface. The EUT was powered from a 50  $\Omega$ /50  $\mu$ H Line Impedance Stabilization Network (LISN). The EMC receiver scanned the frequency range from 150 kHz to 30 MHz. Conducted Emissions measurements were made in accordance with *ANSI C63.4-2003 "Methods and Measurements of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the Range of 9kHz to 40 GHz"*. The measurements were performed over the frequency range of 0.15 MHz to 30 MHz using a 50  $\Omega$ /50  $\mu$ H LISN as the input transducer to an EMC/field intensity meter. For the purpose of this testing, the transmitter was turned on. Scans were performed with the transmitter on.




**Plot 10. Conducted Emissions, 15.207(a), Neutral Line, PoE**

### § 15. 403(c) 26dB Bandwidth


**Test Requirements:** **§ 15.403 (i):** For purposes of this subpart the emission bandwidth shall be determined by measuring the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, that are 26 dB down relative to the maximum level of the modulated carrier. Determination of the emissions bandwidth is based on the use of measurement instrumentation employing a peak detector function with an instrument resolution bandwidth approximately equal to 1.0 percent of the emission bandwidth of the device under measurement.

**Test Procedure:** The transmitter was set to low, mid and high channels at the highest output power and connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using a RBW approximately equal to 1% of the total emission bandwidth,  $VBW > RBW$ . The 26 dB Bandwidth was measured and recorded.

**Test Results** The 26 dB Bandwidth was compliant with the requirements of this section and was determined from the plots on the following pages.






**Figure 2. Occupied Bandwidth, Test Setup**




Plot 13. 26 dB Occupied Bandwidth, 802.11a, 5745 MHz




Plot 14. 26 dB Occupied Bandwidth, 802.11a, 7577 MHz



Plot 15. 26 dB Occupied Bandwidth, 802.11a, 5785 MHz




Plot 16. 26 dB Occupied Bandwidth, 802.11a, 5795 MHz




Plot 17. 26 dB Occupied Bandwidth, 802.11a, 5825 MHz




Plot 18. 26 dB Occupied Bandwidth, 802.11n, 5745 MHz, Port 1




Plot 19. 26 dB Occupied Bandwidth, 802.11n, 7577 MHz, Port 1



Plot 20. 26 dB Occupied Bandwidth, 802.11n, 5785 MHz, Port 1




Plot 21. 26 dB Occupied Bandwidth, 802.11n, 5795 MHz, Port 1




Plot 22. 26 dB Occupied Bandwidth, 802.11n, 5825 MHz, Port 1




Plot 23. 26 dB Occupied Bandwidth, 802.11n, 5745 MHz, Port 2




Plot 24. 26 dB Occupied Bandwidth, 802.11n, 7577 MHz, Port 2



Plot 25. 26 dB Occupied Bandwidth, 802.11n, 5785 MHz, Port 2




Plot 26. 26 dB Occupied Bandwidth, 802.11n, 5795 MHz, Port 2




Plot 27. 26 dB Occupied Bandwidth, 802.11n, 5825 MHz, Port 2

### § 15. 407(a)(3) RF Power Output


**Test Requirements:** **§15.407(a)(3):** For the band 5.725–5.825 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W.

**Test Procedure:** The EUT was connected to a spectrum analyzer through an attenuator and set to transmit continuously on the low, mid, and high channels. Its power was measured according to measurement method SA-1, as described in 789033 D02 General UNII Test Procedures v01. Plots were corrected for attenuator and cable loss. EUT will be professionally installed and Meru Networks will lower power accordingly when both radios are operating simultaneously and in the same band.

## Electromagnetic Compatibility Criteria for Intentional Radiators

### § 15.407(b)(4), (6), (7) Undesirable Emissions

**Test Requirements:** § 15.407(b)(4), (6), (7); §15.205: Emissions outside the frequency band.

**§ 15.407(b)(4):** For transmitters operating in the 5.725–5.825 GHz band: all emissions within the frequency range from the band edge to 10 MHz above or below the band edge shall not exceed an EIRP of –17 dBm/MHz; for frequencies 10 MHz or greater above or below the band edge, emissions shall not exceed an EIRP of –27 dBm/MHz.

**§ 15.407(b)(6):** Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in Section 15.209. Further, any U-NII devices using an AC power line are required to comply also with the conducted limits set forth in Section 15.207.

**§ 15.407(b)(7):** The provisions of Section 15.205 of this part apply to intentional radiators operating under this section.

**Test Procedure:** The transmitter was placed on an 80cm non-metallic table inside in a semi-anechoic chamber. Measurements were performed with the EUT rotated 360 degrees and varying the adjustable antenna mast height to determine worst case orientation for maximum emissions. A preamp was used in the range from 7-18GHz to improve noise floor. Plots were corrected for cable loss, antenna, and preamp gain.

For frequencies from 30 MHz to 1 GHz, measurements were made using a quasi-peak detector with a 120 kHz bandwidth.


For measurements above 1 GHz, measurements were made with a Peak detector with 1 MHz resolution bandwidth. A notch filter was used to filter the transmitting signal. Where the spurious emissions fell into a restricted band, measurements were also made with an average detector to make sure they complied with 15.209 limits. Only noise floor was observed above 18 GHz.

**Test Results:** The EUT was compliant with the Radiated Emission limits for Intentional Radiators. See following pages for detailed test results. All emissions above 18 GHz were at the noise floor of the receiver.






Plot 30. Radiated Spurious Emissions, 802.11a 20 MHz, Low Channel, 30 MHz – 1 GHz




Plot 31. Radiated Spurious Emissions, 802.11a 20 MHz, Low Channel, 1 GHz – 7 GHz, Average




Plot 32. Radiated Spurious Emissions, 802.11a 20 MHz, Low Channel, 1 GHz – 7 GHz, Peak




Plot 33. Radiated Spurious Emissions, 802.11a 20 MHz, Low Channel, 7 GHz – 18 GHz




Plot 34. Radiated Spurious Emissions, 802.11a 40 MHz, Low Channel, 30 MHz – 1 GHz




Plot 35. Radiated Spurious Emissions, 802.11a 40 MHz, Low Channel, 1 GHz – 7 GHz, Average




**Plot 36. Radiated Spurious Emissions, 802.11a 40 MHz, Low Channel, 1 GHz – 7 GHz, Peak**




**Plot 37. Radiated Spurious Emissions, 802.11a 40 MHz, Low Channel, 7 GHz – 18 GHz**




**Plot 38. Radiated Spurious Emissions, 802.11a 20 MHz, Mid Channel, 30 MHz – 1 GHz**




Plot 39. Radiated Spurious Emissions, 802.11a 20 MHz, Mid Channel, 1 GHz – 7 GHz, Average


Plot 43. Radiated Spurious Emissions, 802.11a 20 MHz, High Channel, 1 GHz – 7 GHz, Peak




**Plot 44. Radiated Spurious Emissions, 802.11a 20 MHz, High Channel, 7 GHz – 18 GHz**




**Plot 45. Radiated Spurious Emissions, 802.11a 40 MHz, High Channel, 30 MHz – 1 GHz**



**Plot 46. Radiated Spurious Emissions, 802.11a 40 MHz, High Channel, 1 GHz – 7 GHz, Average**




**Plot 47. Radiated Spurious Emissions, 802.11a 40 MHz, High Channel, 1 GHz – 7 GHz, Peak**




**Plot 48. Radiated Spurious Emissions, 802.11a 40 MHz, High Channel, 7 GHz – 18 GHz, Peak**




Plot 49. Radiated Spurious Emissions, 802.11n 20 MHz, Low Channel, 30 MHz – 1 GHz




Plot 50. Radiated Spurious Emissions, 802.11n 20 MHz, Low Channel, 1 GHz – 7 GHz, Average




Plot 51. Radiated Spurious Emissions, 802.11n 20 MHz, Low Channel, 1 GHz – 7 GHz, Peak




Plot 52. Radiated Spurious Emissions, 802.11n 20 MHz, Low Channel, 7 GHz – 18 GHz




Plot 53. Radiated Spurious Emissions, 802.11n 40 MHz, Low Channel, 30 MHz – 1 GHz




Plot 54. Radiated Spurious Emissions, 802.11n 40 MHz, Low Channel, 1 GHz – 7 GHz, Average




**Plot 55. Radiated Spurious Emissions, 802.11n 40 MHz, Low Channel, 1 GHz – 7 GHz, Peak**




**Plot 56. Radiated Spurious Emissions, 802.11n 40 MHz, Low Channel, 7 GHz – 18 GHz**




**Plot 57. Radiated Spurious Emissions, 802.11n 20 MHz, Mid Channel, 30 MHz – 1 GHz**




**Plot 58. Radiated Spurious Emissions, 802.11n 20 MHz, Mid Channel, 1 GHz – 7 GHz, Average**




**Plot 59. Radiated Spurious Emissions, 802.11n 20 MHz, Mid Channel, 1 GHz – 7 GHz, Peak**




**Plot 60. Radiated Spurious Emissions, 802.11n 20 MHz, Mid Channel, 7 GHz – 18 GHz**




**Plot 61. Radiated Spurious Emissions, 802.11n 20 MHz, High Channel, 30 MHz – 1 GHz**




**Plot 62. Radiated Spurious Emissions, 802.11n 20 MHz, High Channel, 1 GHz – 7 GHz, Average**




**Plot 63. Radiated Spurious Emissions, 802.11n 20 MHz, High Channel, 1 GHz – 7 GHz, Peak**




**Plot 64. Radiated Spurious Emissions, 802.11n 20 MHz, High Channel, 7 GHz – 18 GHz**




**Plot 65. Radiated Spurious Emissions, 802.11n 40 MHz, High Channel, 30 MHz – 1 GHz**



**Plot 66. Radiated Spurious Emissions, 802.11n 40 MHz, High Channel, 1 GHz – 7 GHz, Average**




Plot 67. Radiated Spurious Emissions, 802.11n 40 MHz, High Channel, 1 GHz – 7 GHz, Peak




Plot 68. Radiated Spurious Emissions, 802.11n 40 MHz, High Channel, 7 GHz – 18 GHz, Peak




Plot 69. Radiated Spurious Emissions, 802.11ac 80 MHz, 30 MHz – 1 GHz



Plot 70. Radiated Spurious Emissions, 802.11ac 80 MHz, 1 GHz – 7 GHz, Average




Plot 71. Radiated Spurious Emissions, 802.11ac 80 MHz, 1 GHz – 7 GHz, Peak




Plot 72. Radiated Spurious Emissions, 802.11ac 80 MHz, 7 GHz – 18 GHz




Plot 73. Radiated Band Edge, 802.11a, Low Channel (5715 & 5725 MHz), Average



Plot 74. Radiated Band Edge, 802.11a, Low Channel (5715 & 5725 MHz), Peak




Plot 75. Radiated Band Edge, 802.11a, High Channel (5825 & 5835 MHz), Average




Plot 76. Radiated Band Edge, 802.11a, High Channel (5825 & 5835 MHz), Peak




Plot 77. Radiated Band Edge, 802.11n 20 MHz, Low Channel (5715 & 5725 MHz), Average



Plot 78. Radiated Band Edge, 802.11n 20 MHz, Low Channel (5715 & 5725 MHz), Peak




Plot 79. Radiated Band Edge, 802.11n 20 MHz, High Channel (5825 & 5835 MHz), Average




Plot 80. Radiated Band Edge, 802.11n 20 MHz, High Channel (5825 & 5835 MHz), Peak




Plot 81. Radiated Band Edge, 802.11n 40 MHz, Low Channel (5715 & 5725 MHz), Average



Plot 82. Radiated Band Edge, 802.11n 40 MHz, Low Channel (5715 & 5725 MHz), Peak




Plot 83. Radiated Band Edge, 802.11n 40 MHz, High Channel (5832 & 5835 MHz), Average




Plot 84. Radiated Band Edge, 802.11n 40 MHz, High Channel (5832 & 5835 MHz), Peak




Plot 85. Radiated Band Edge, 802.11n 80 MHz (5715 & 5725 MHz), Average

All devices that are capable of transmitting simultaneously in more than one Part-15 band between 5 and 6 GHz (*i.e.*, in two or more of the four U-NII bands or in the 5.8 GHz 15.247 band and at least one U-NII band) are subject to Permit But Ask provisions. This includes devices marketed as IEEE Std 802.11acor “pre-standard” IEEE Std 802.11ac.




Plot 249. Frequency Stability, 5725 – 5825 MHz, -40°C, 120 V




Plot 250. Frequency Stability, 5725 – 5825 MHz, -30°C, 120 V




Plot 251. Frequency Stability, 5725 – 5825 MHz, -20°C, 120 V




Plot 252. Frequency Stability, 5725 – 5825 MHz, -10°C, 120 V




Plot 253. Frequency Stability, 5725 – 5825 MHz, 0°C, 120 V




Plot 254. Frequency Stability, 5725 – 5825 MHz, 10°C, 120 V




Plot 255. Frequency Stability, 5725 – 5825 MHz, 20°C, 120 V




Plot 256. Frequency Stability, 5725 – 5825 MHz, 30°C, 120 V

## Certification & User's Manual Information

### L. Certification Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart I — Marketing of Radio frequency devices:

#### § 2.801 Radio-frequency device defined.

As used in this part, a radio-frequency device is any device which in its operation is capable of emitting radio-frequency energy by radiation, conduction, or other means. Radio-frequency devices include, but are not limited to:

- (a) The various types of radio communication transmitting devices described throughout this chapter.
- (b) *The incidental, unintentional and intentional radiators defined in Part 15 of this chapter.*
- (c) The industrial, scientific, and medical equipment described in Part 18 of this chapter.
- (d) Any part or component thereof which in use emits radio-frequency energy by radiation, conduction, or other means.

#### § 2.803 Marketing of radio frequency devices prior to equipment authorization.

- (a) Except as provided elsewhere in this chapter, no person shall sell or lease, or offer for sale or lease (including advertising for sale or lease), or import, ship or distribute for the purpose of selling or leasing or offering for sale or lease, any radio frequency device unless:
  - (1) In the case of a device subject to certification, such device has been authorized by the Commission in accordance with the rules in this chapter and is properly identified and labeled as required by §2.925 and other relevant sections in this chapter; or
  - (2) In the case of a device that is not required to have a grant of equipment authorization issued by the Commission, but which must comply with the specified technical standards prior to use, such device also complies with all applicable administrative (including verification of the equipment or authorization under a Declaration of Conformity, where required), technical, labeling and identification requirements specified in this chapter.
- (d) Notwithstanding the provisions of paragraph (a) of this section, the offer for sale solely to business, commercial, industrial, scientific or medical users (but not an offer for sale to other parties or to end users located in a residential environment) of a radio frequency device that is in the conceptual, developmental, design or pre-production stage is permitted prior to equipment authorization or, for devices not subject to the equipment authorization requirements, prior to a determination of compliance with the applicable technical requirements *provided* that the prospective buyer is advised in writing at the time of the offer for sale that the equipment is subject to the FCC rules and that the equipment will comply with the appropriate rules before delivery to the buyer or to centers of distribution.

(e)(1) Notwithstanding the provisions of paragraph (a) of this section, prior to equipment authorization or determination of compliance with the applicable technical requirements any radio frequency device may be operated, but not marketed, for the following purposes and under the following conditions:

- (i) *Compliance testing;*
- (ii) Demonstrations at a trade show provided the notice contained in paragraph (c) of this section is displayed in a conspicuous location on, or immediately adjacent to, the device;
- (iii) Demonstrations at an exhibition conducted at a business, commercial, industrial, scientific or medical location, but excluding locations in a residential environment, provided the notice contained in paragraphs (c) or (d) of this section, as appropriate, is displayed in a conspicuous location on, or immediately adjacent to, the device;
- (iv) Evaluation of product performance and determination of customer acceptability, provided such operation takes place at the manufacturer's facilities during developmental, design or pre-production stages; or
- (v) Evaluation of product performance and determination of customer acceptability where customer acceptability of a radio frequency device cannot be determined at the manufacturer's facilities because of size or unique capability of the device, provided the device is operated at a business, commercial, industrial, scientific or medical user's site, but not at a residential site, during the development, design or pre-production stages.

(e)(2) For the purpose of paragraphs (e)(1)(iv) and (e)(1)(v) of this section, the term *manufacturer's facilities* includes the facilities of the party responsible for compliance with the regulations and the manufacturer's premises, as well as the facilities of other entities working under the authorization of the responsible party in connection with the development and manufacture, but not the marketing, of the equipment.

(f) For radio frequency devices subject to verification and sold solely to business, commercial, industrial, scientific and medical users (excluding products sold to other parties or for operation in a residential environment), parties responsible for verification of the devices shall have the option of ensuring compliance with the applicable technical specifications of this chapter at each end user's location after installation, provided that the purchase or lease agreement includes a proviso that such a determination of compliance be made and is the responsibility of the party responsible for verification of the equipment.

## Certification & User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart J — Equipment Authorization Procedures:

### § 2.901 Basis and Purpose

- (a) In order to carry out its responsibilities under the Communications Act and the various treaties and international regulations, and in order to promote efficient use of the radio spectrum, the Commission has developed technical standards for radio frequency equipment and parts or components thereof. The technical standards applicable to individual types of equipment are found in that part of the rules governing the service wherein the equipment is to be operated.<sup>1</sup> *In addition to the technical standards provided, the rules governing the service may require that such equipment be verified by the manufacturer or importer,* be authorized under a Declaration of Conformity, or receive an equipment authorization from the Commission by one of the following procedures: certification or registration.
- (b) The following sections describe the verification procedure, the procedure for a Declaration of Conformity, and the procedures to be followed in obtaining certification from the Commission and the conditions attendant to such a grant.

### § 2.907 Certification.

- (a) Certification is an equipment authorization issued by the Commission, based on representation and test data submitted by the applicant.
- (b) Certification attaches to all units subsequently marketed by the grantee which are identical (see Section 2.908) to the sample tested except for permissive changes or other variations authorized by the Commission pursuant to Section 2.1043.

### § 2.948 Description of measurement facilities.

- (a) Each party making measurements of equipment that is subject to an equipment authorization under Part 15 or Part 18 of this chapter, regardless of whether the measurements are filed with the Commission or kept on file by the party responsible for compliance of equipment marketed within the U.S. or its possessions, shall compile a description of the measurement facilities employed.
  - (1) If the measured equipment is subject to the verification procedure, the description of the measurement facilities shall be retained by the party responsible for verification of the equipment.
    - (i) *If the equipment is verified through measurements performed by an independent laboratory, it is acceptable for the party responsible for verification of the equipment to rely upon the description of the measurement facilities retained by or placed on file with the Commission by that laboratory. In this situation, the party responsible for the verification of the equipment is not required to retain a duplicate copy of the description of the measurement facilities.*
    - (ii) If the equipment is verified based on measurements performed at the installation site of the equipment, no specific site calibration data is required. It is acceptable to retain the description of the measurement facilities at the site at which the measurements were performed.
  - (2) If the equipment is to be authorized by the Commission under the certification procedure, the description of the measurement facilities shall be filed with the Commission's Laboratory in Columbia, Maryland. The data describing the measurement facilities need only be filed once but must be updated as changes are made to the measurement facilities or as otherwise described in this section. At least every three years, the organization responsible for filing the data with the Commission shall certify that the data on file is current.

## Certification & User's Manual Information

### Label and User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart A — General:

#### § 15.19 Labeling requirements.

(a) *In addition to the requirements in Part 2 of this chapter, a device subject to certification or verification shall be labeled as follows:*

(1) Receivers associated with the operation of a licensed radio service, e.g., FM broadcast under Part 73 of this chapter, land mobile operation under Part 90, etc., shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the condition that this device does not cause harmful interference.

(2) A stand-alone cable input selector switch, shall bear the following statement in a conspicuous location on the device:

This device is verified to comply with Part 15 of the FCC Rules for use with cable television service.

(3) All other devices shall bear the following statement in a conspicuous location on the device:

*This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.*

(4) Where a device is constructed in two or more sections connected by wires and marketed together, the statement specified under paragraph (a) of this section is required to be affixed only to the main control unit.

(5) When the device is so small or for such use that it is not practicable to place the statement specified under paragraph (a) of this section on it, the information required by this paragraph shall be placed in a prominent location in the instruction manual or pamphlet supplied to the user or, alternatively, shall be placed on the container in which the device is marketed. However, the FCC identifier or the unique identifier, as appropriate, must be displayed on the device.

#### § 15.21 Information to user.

The users manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.

## Verification & User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart B — Unintentional Radiators:

### § 15.105 Information to the user.

(a) For a Class A digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class A digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a commercial environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. Operation of this equipment in a residential area is likely to cause harmful interference in which case the user will be required to correct the interference at own expense.

(b) For a Class B digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a residential environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the equipment and receiver.
- Connect the equipment into an outlet on a circuit different from that to which the receiver is connected.
- Consult the dealer or an experienced radio/TV technician for help.
