Pursuant to the provisions of Sections 0.457 and 0.459 of Commission's rules (47CFR§§0.457, 0.459), we are requesting the Commission to withhold the following documents from public disclosure indefinitely.

It is our understanding that all measurement test reports, FCC ID label format cannot be granted as confidential documents and those information will be available for public review once the grant of equipment authorization is issued.
