The objective is to determine compliance with FCC Part 15, Subpart E, section 15.407 Dynamic Frequency Selection (DFS) for devices operating in the bands 5250- 5350 MHz, 5470-5725 MHz.

A minimum of 30 unique waveforms are required for each of the Short Pulse Radar Types 2 through 4. If more than 30 waveforms are used for Short Pulse Radar Types 2 through 4, then each additional waveform must also be unique and not repeated from the previous waveforms. If more than 30 waveforms are used for Short Pulse Radar Type 1, then each additional waveform is generated with Test B and must also be unique and not repeated from the previous waveforms in Tests A or B.

For example if in Short Pulse Radar Type 1 Test B a PRI of 3066 usec is selected, the number of pulses

would be $\text{Roundup} \left\{ \left(\frac{1}{360} \right) \cdot \left(\frac{19 \cdot 10^6}{3066} \right) \right\} = \text{Roundup} \{17.2\} = 18.$

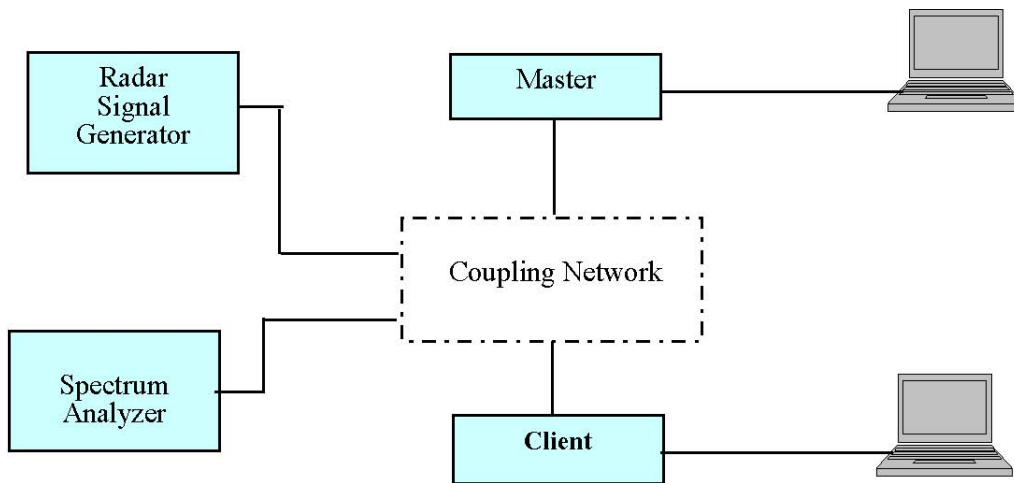

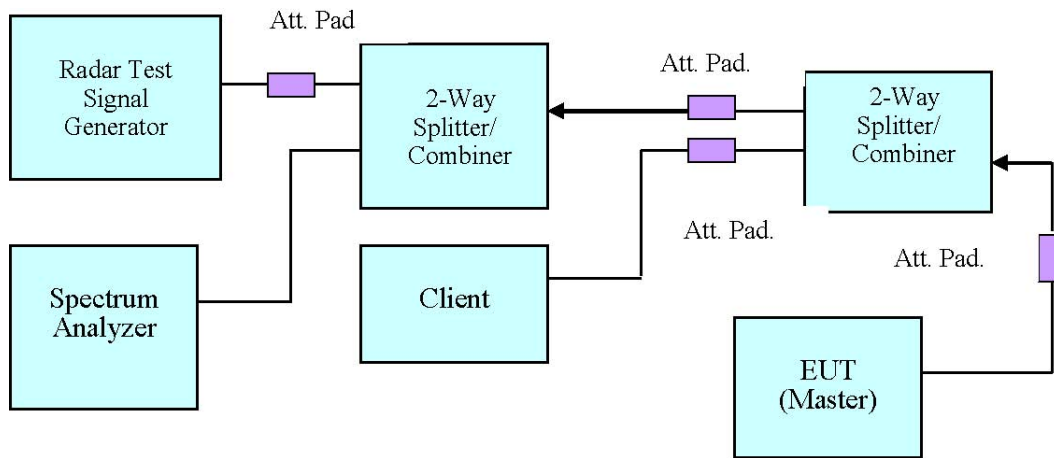
DFS Measurement System

BACL DFS measurement system consists of two subsystems: (1) The radar signal generating subsystem and (2) the traffic monitoring subsystem.

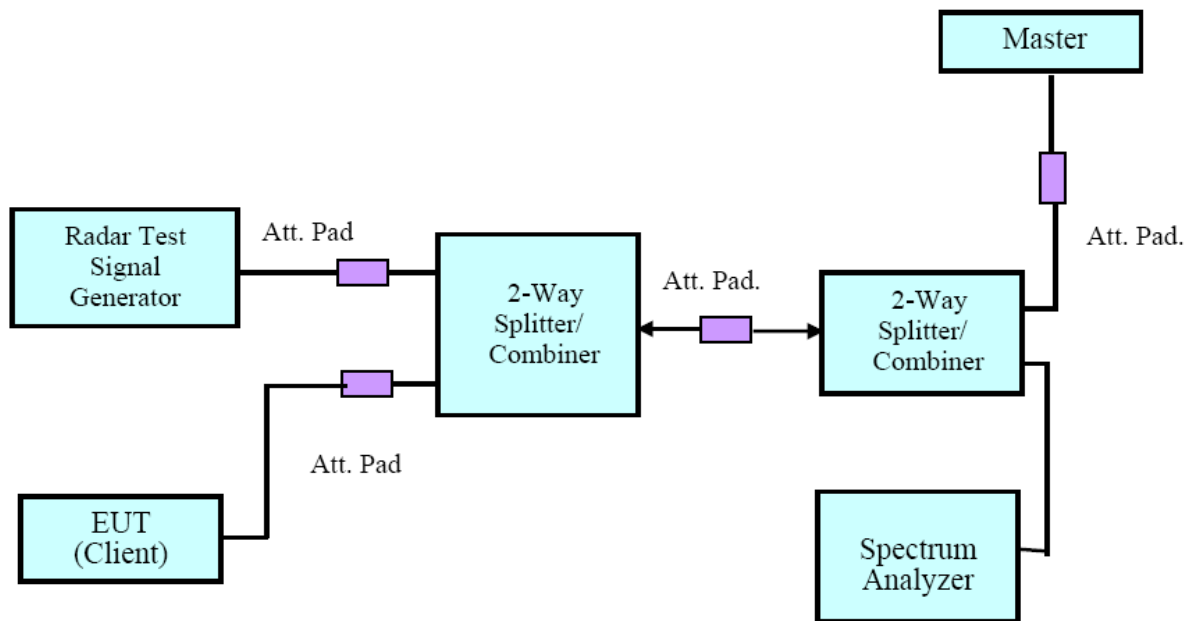
System Block Diagram



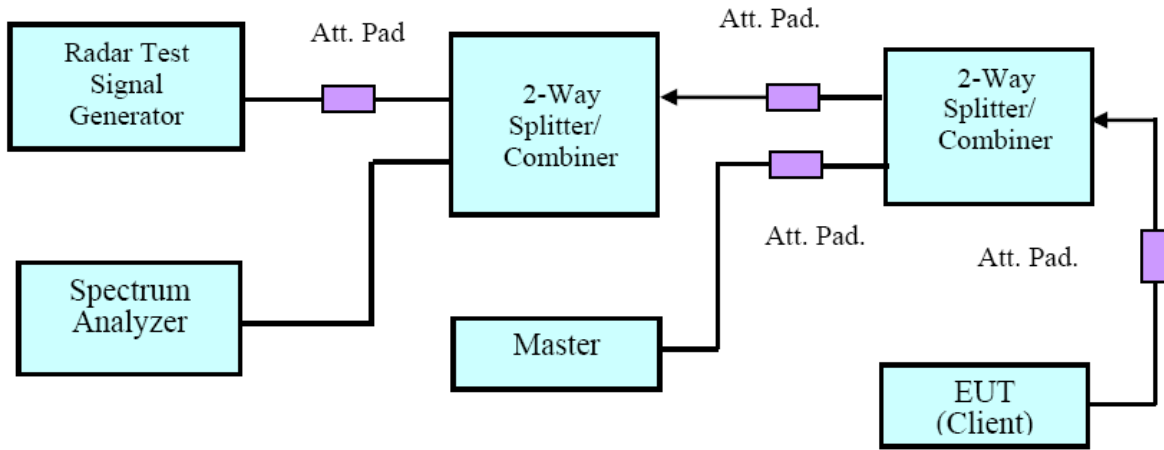

Setup for Master with injection at the Master

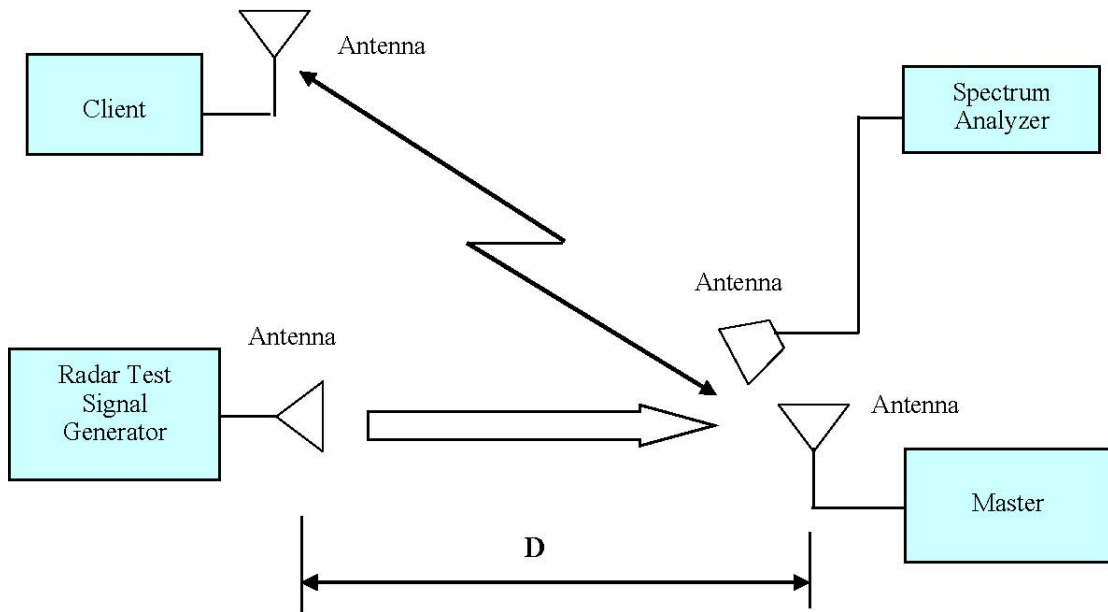


Setup for Client with injection at the Master

4.6 Test Procedure

A spectrum analyzer is used as a monitor verifies that the EUT status including Channel Closing Transmission Time and Channel Move Time, and does not transmit on a Channel during the Non-Occupancy Period after the diction and Channel move. It is also used to monitor EUT transmissions during the Channel Availability Check Time.

TEST RESULTS

Description of EUT

The EUT operates in 5250-5350 MHz and 5470-5725 MHz range.

The rated output power of master device is >23 dBm (EIRP), Therefore the required interference threshold level is -64 dBm, the required radiated threshold at antenna port is -64dBm.

The calibrated radiated DFS detection threshold level is set to -64 dBm.

WLAN traffic is generated by the EUT.

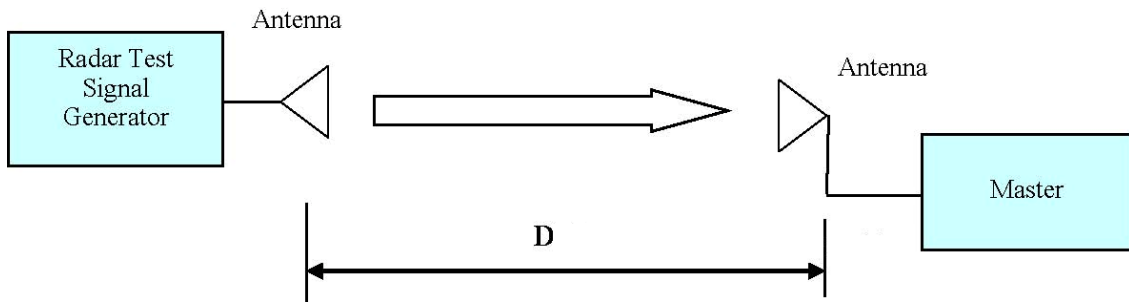

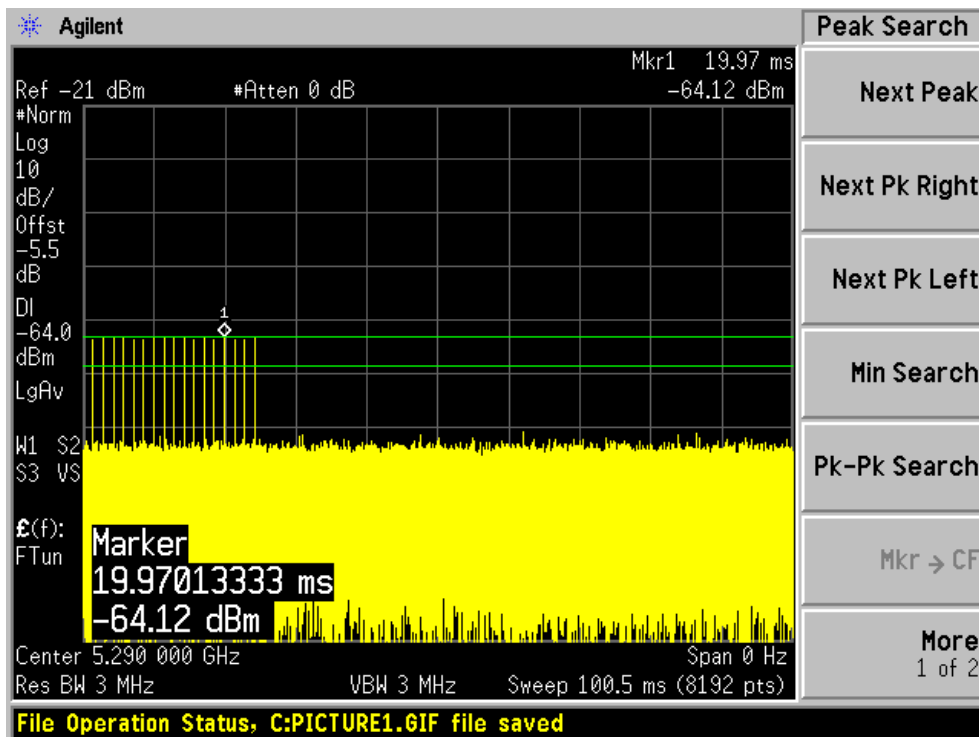
Radar Waveform Calibration



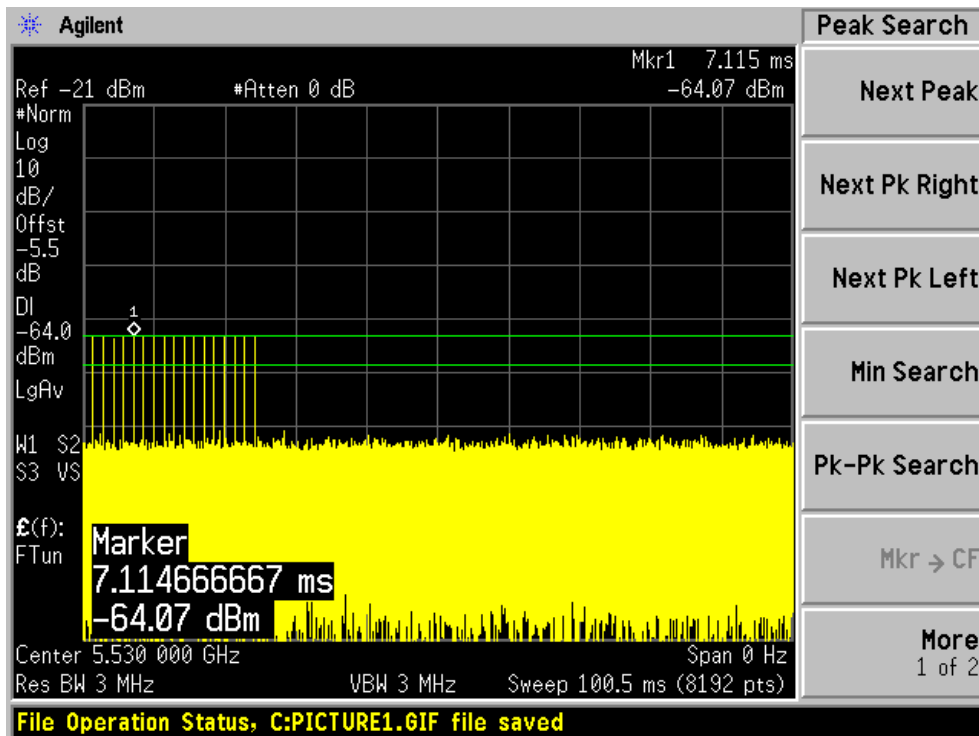

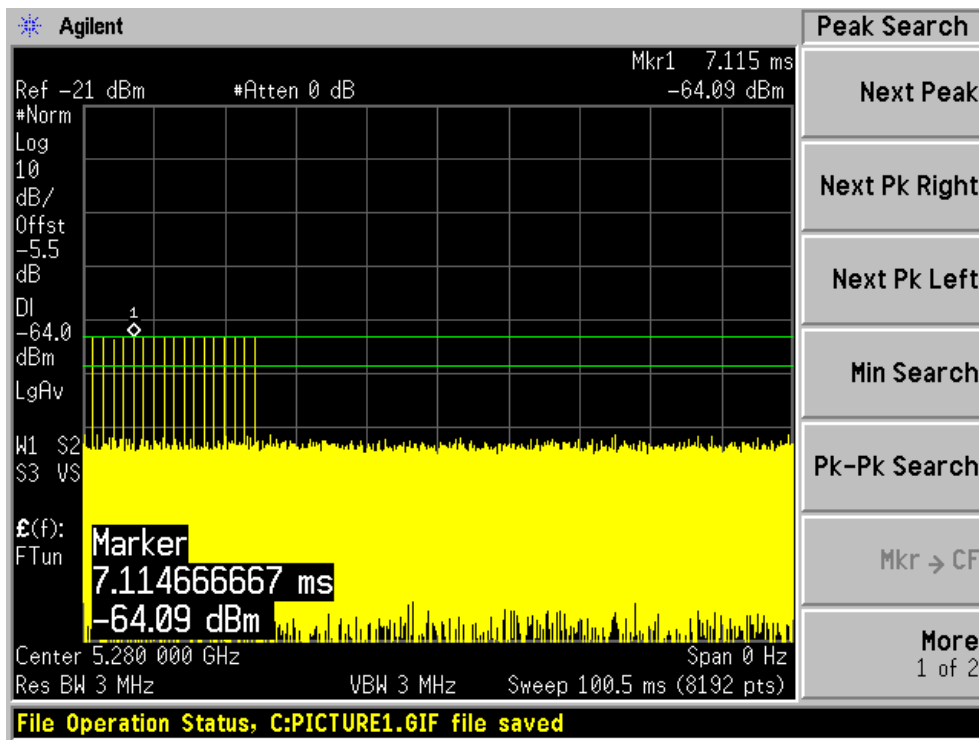
5290 MHz: Radar Type 0



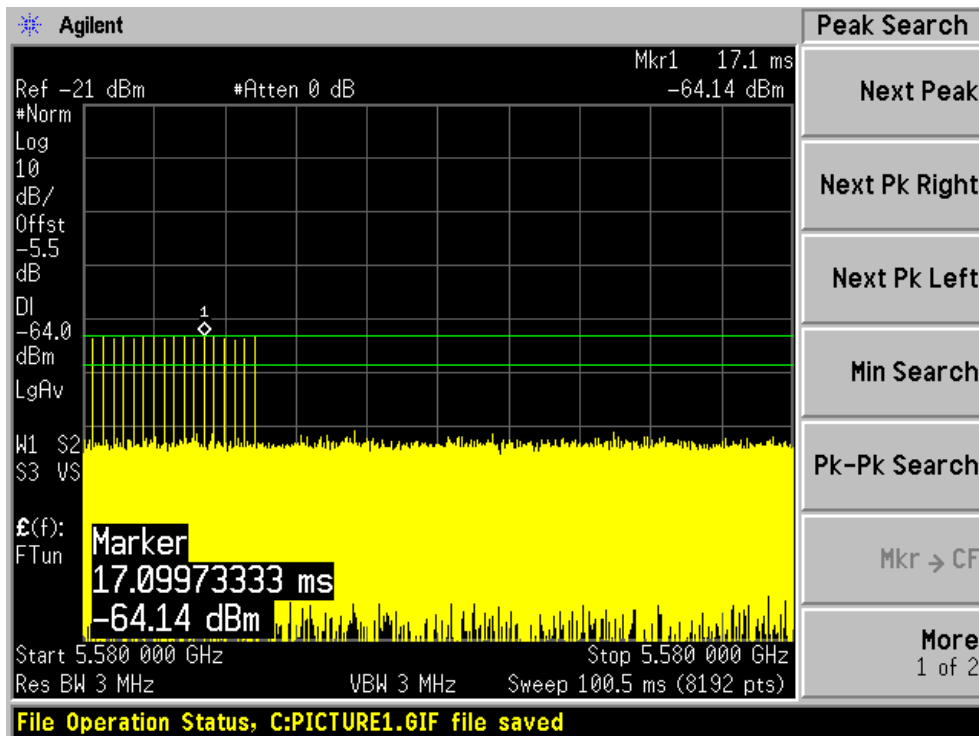
5530 MHz: Radar Type 0

CHANNEL MOVE TIME AND CHANNEL CLOSING TRANSMISSION TIME

Test Procedure

Channel Move Time and the Channel Closing Transmission Time should be performed with Radar Type 0. The measurement timing begins at the end of the Radar Type 0 burst. repeat using a long pulse radar type5 waveform.

The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate a Channel move (an aggregate of 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.

The aggregate channel closing transmission time is calculated as follows:

Aggregate Transmission Time = N*Dwell Time

N is the number of spectrum analyzer bins showing a device transmission Dwell Time is the dwell time per bin (i.e. Dwell Time = S/B, S is the sweep time and B is the number of bin, i.e. 8192)

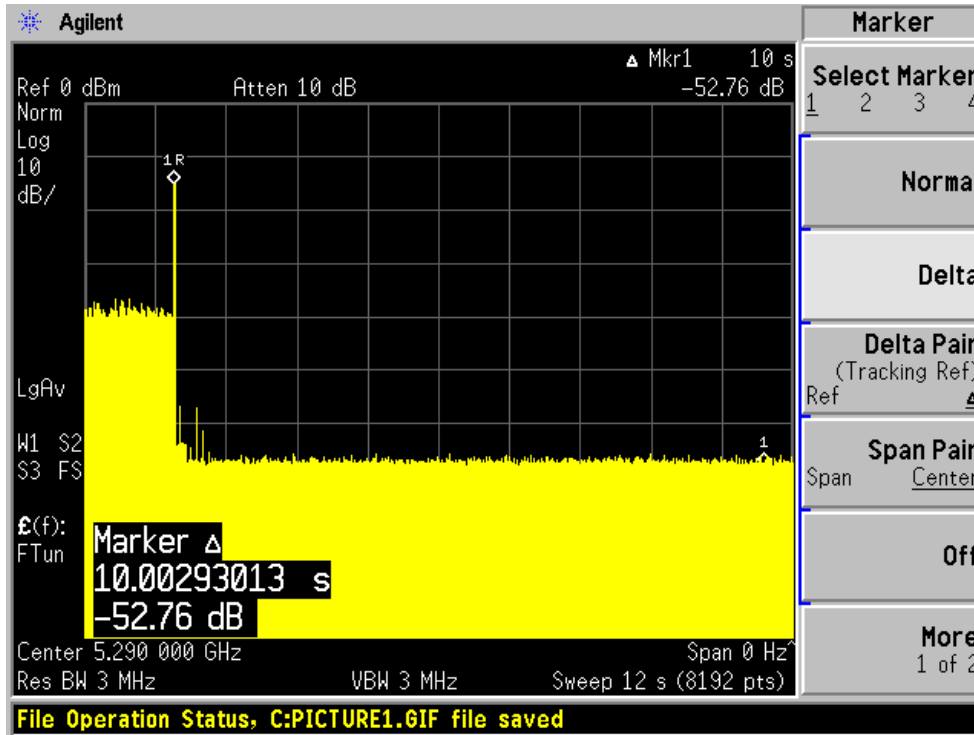

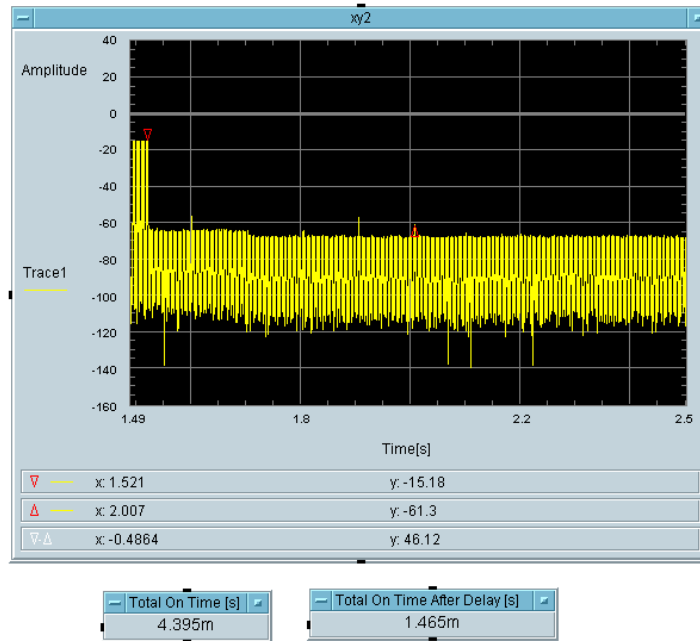

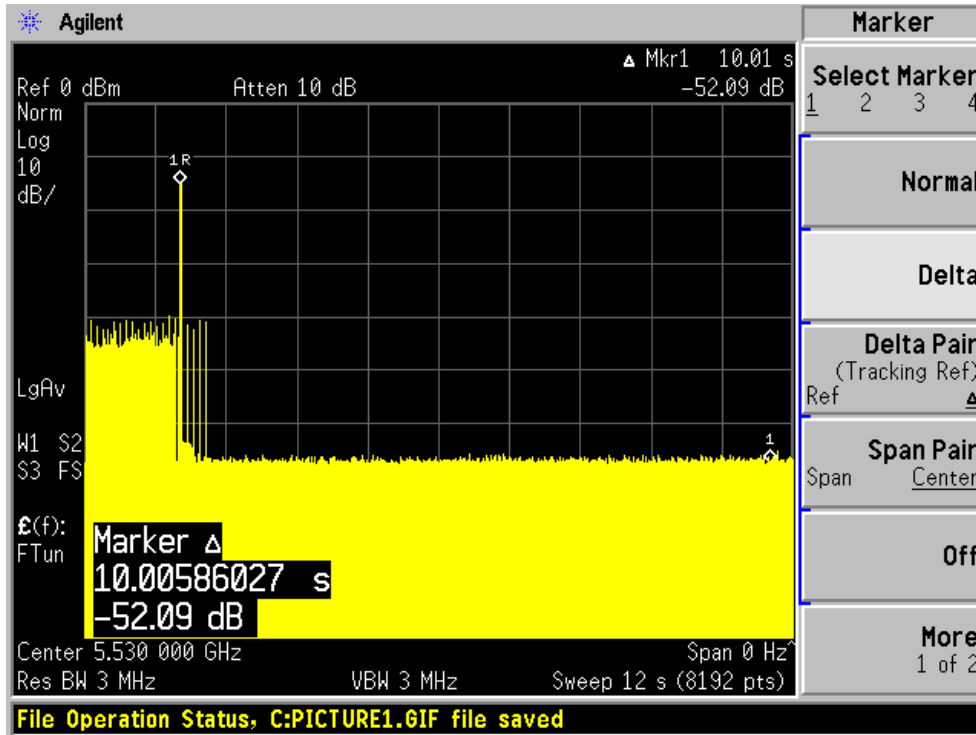
5290 MHz channel closing transmission time

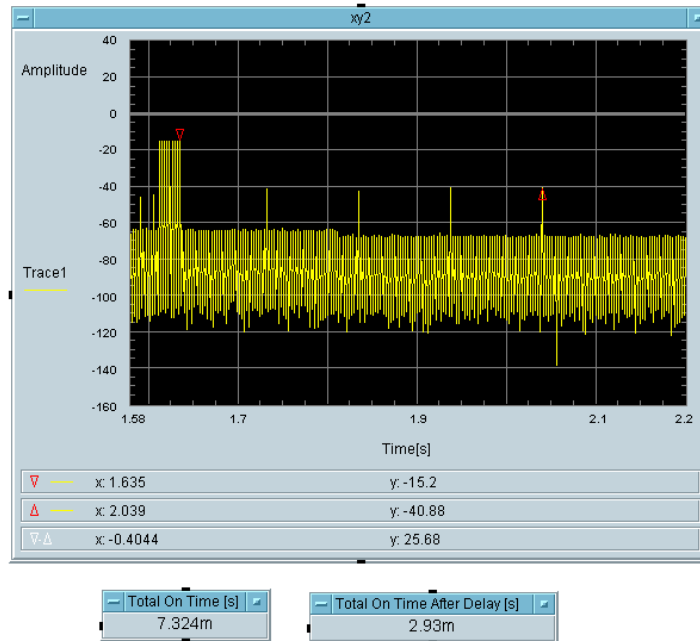

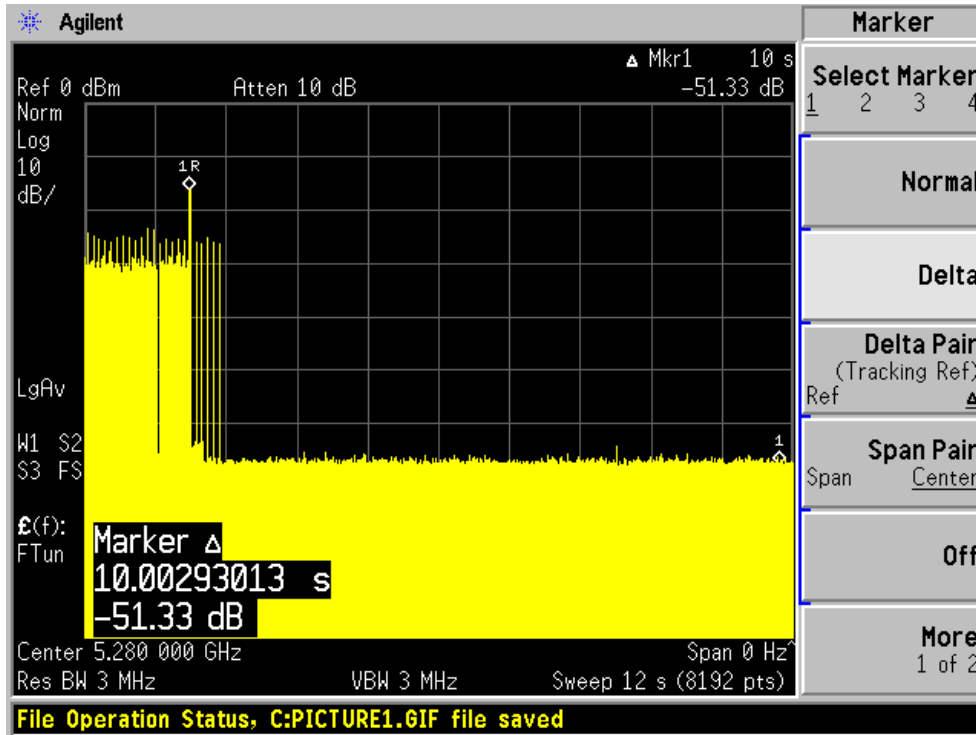
5530 MHz channel closing transmission time

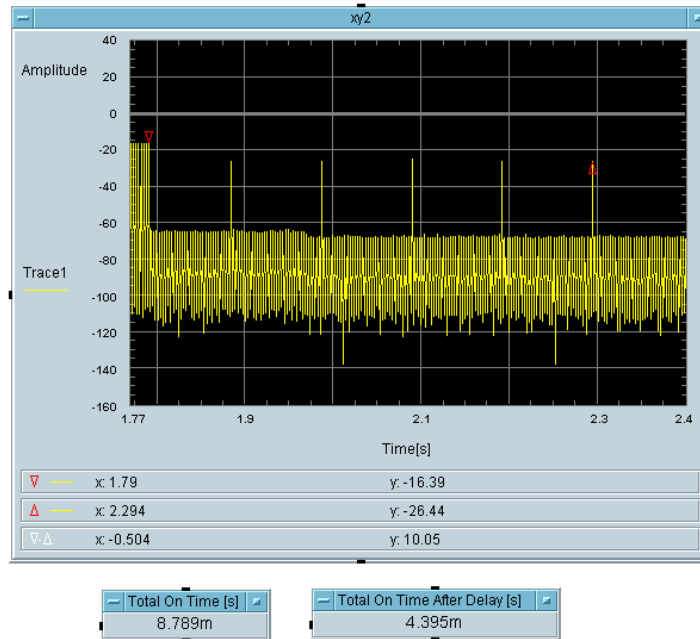

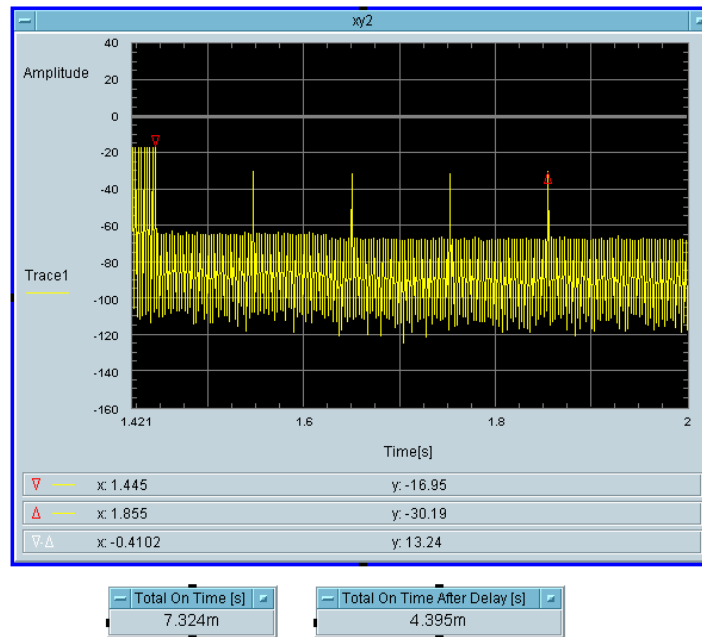

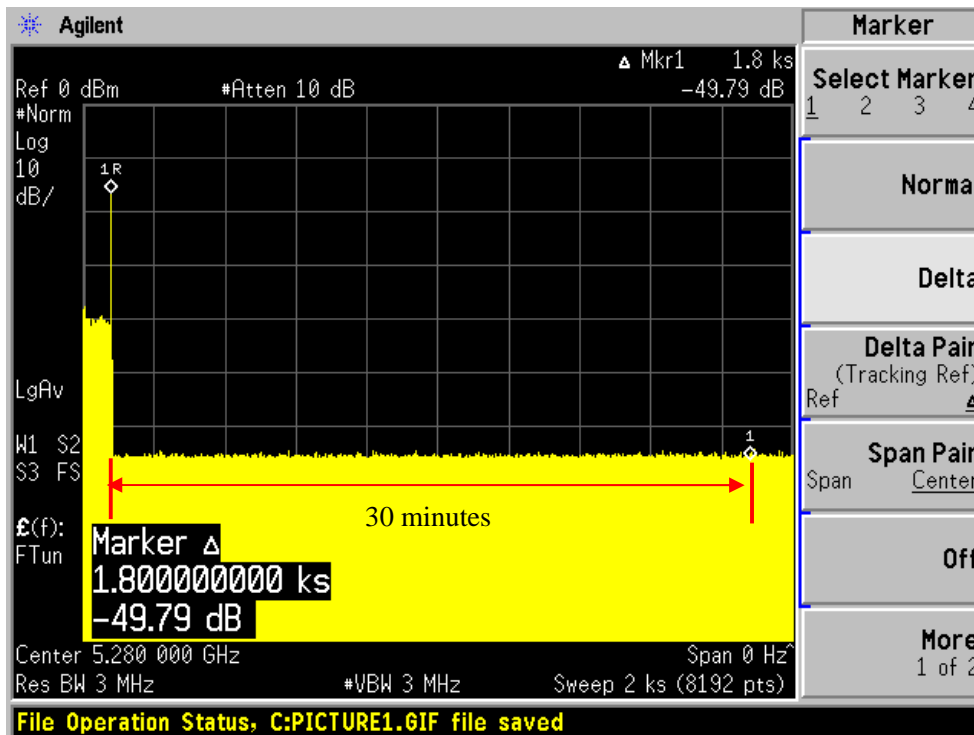
5290 MHz



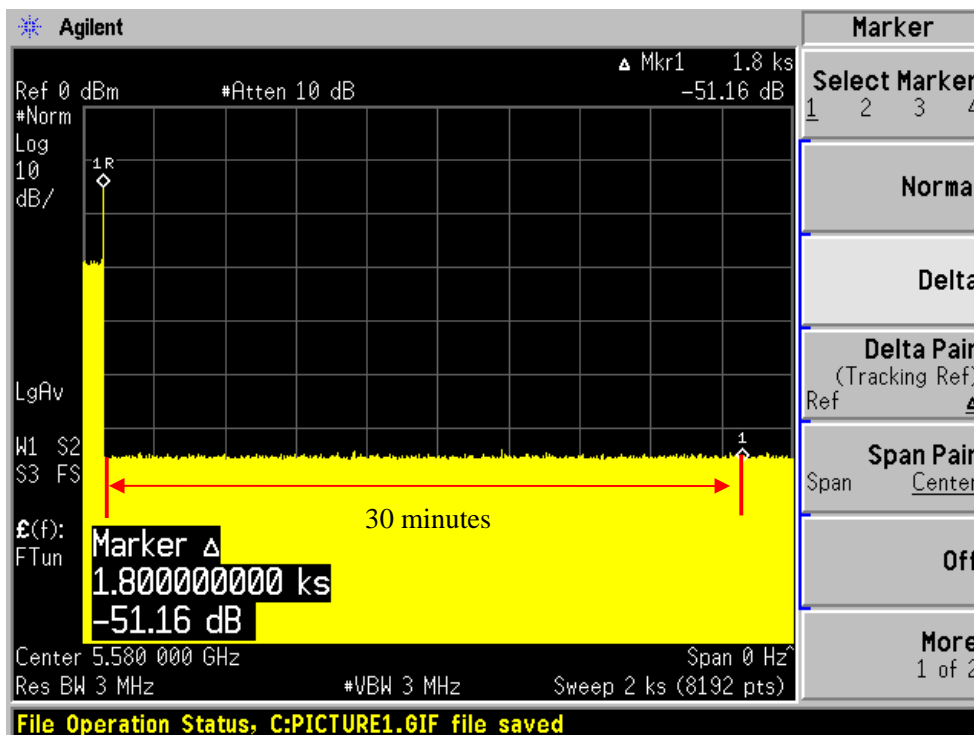
5530 MHz
