2.3 Traceability

4. Test Set-up and Operation Modes

4.1 Principle of Configuration Selection

The equipment under test (EUT) was configured to measure its maximum power level. The test modes were adapted accordingly in reference to the instructions for use.

4.2 Test Operation and Test Software

Setup for testing: Test mode controlled through data interface

This software was running on the laptop computer connected to the EUT. It was used to enable the operation modes listed in section 3.3 as appropriate.

Full test was applied on all test modes, but only worst case was shown.

Diagram of Measurement Configuration for Radiation Test

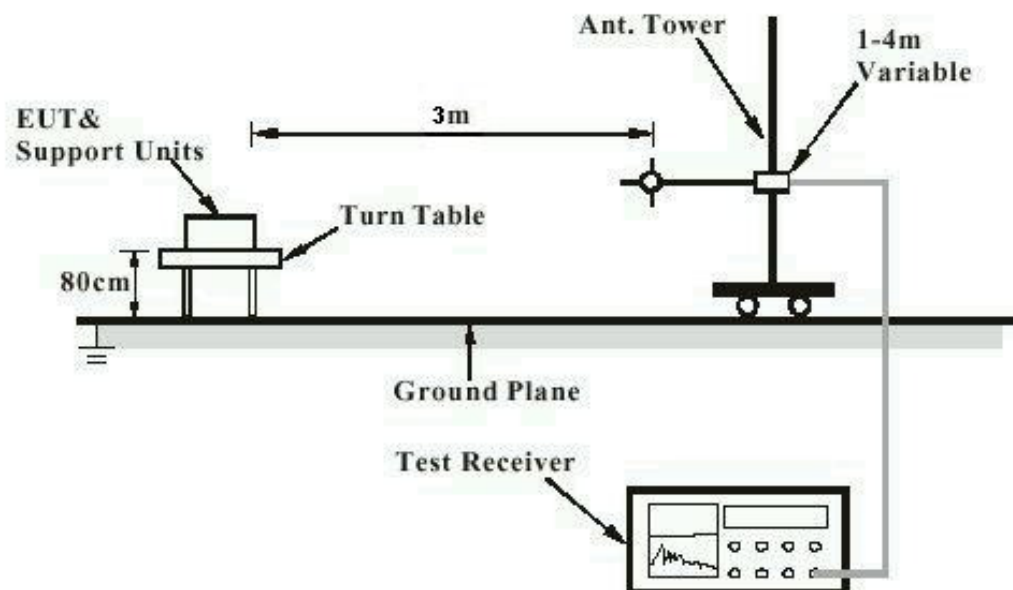


Diagram of Measurement Equipment Configuration for Mains Conduction Measurement (if applicable)

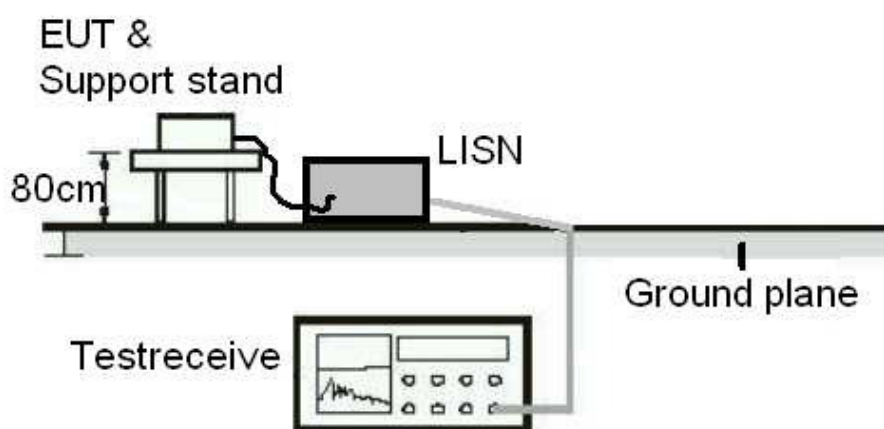
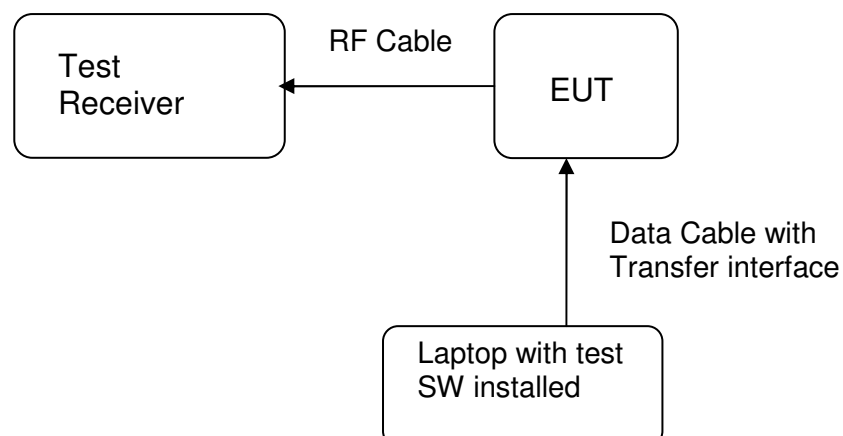


Diagram of Measurement Equipment Configuration for Conducted Transmitter Measurement

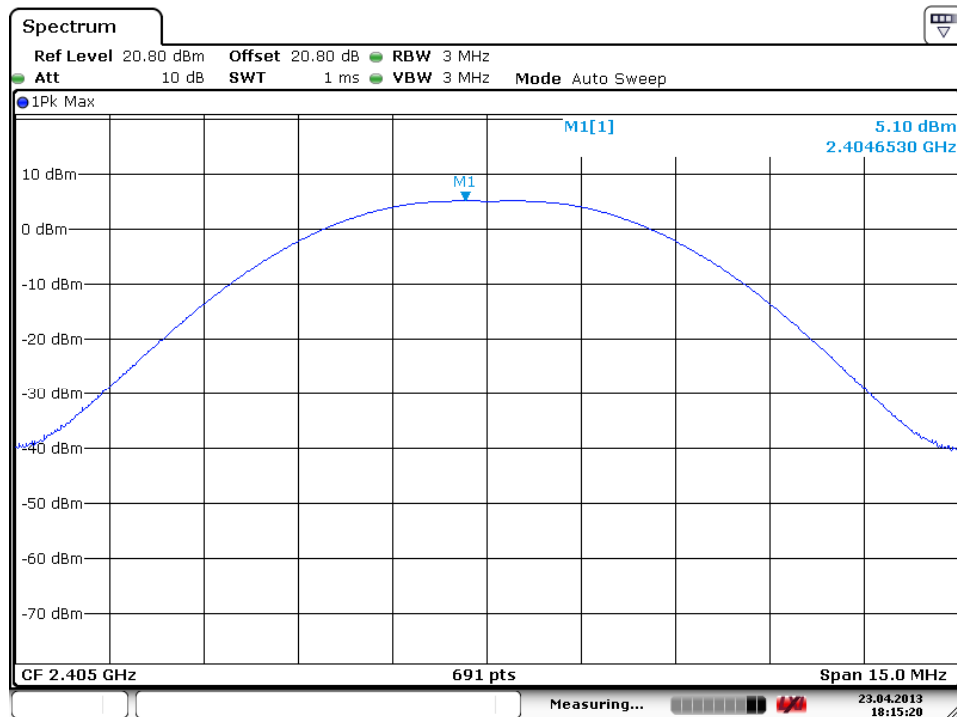

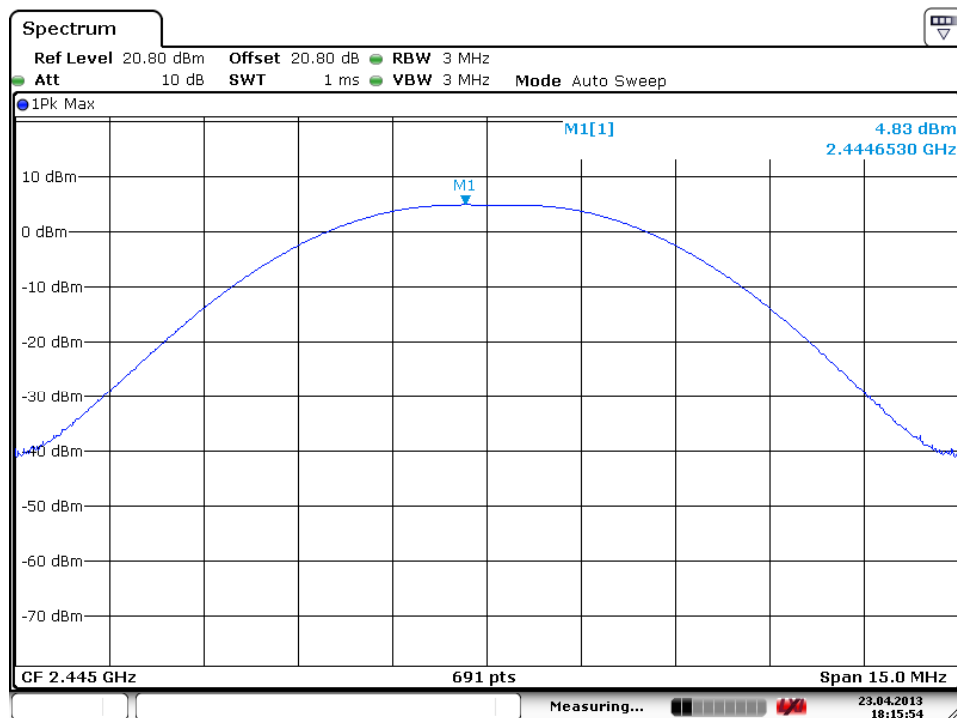
Test Plot of Peak Output Power

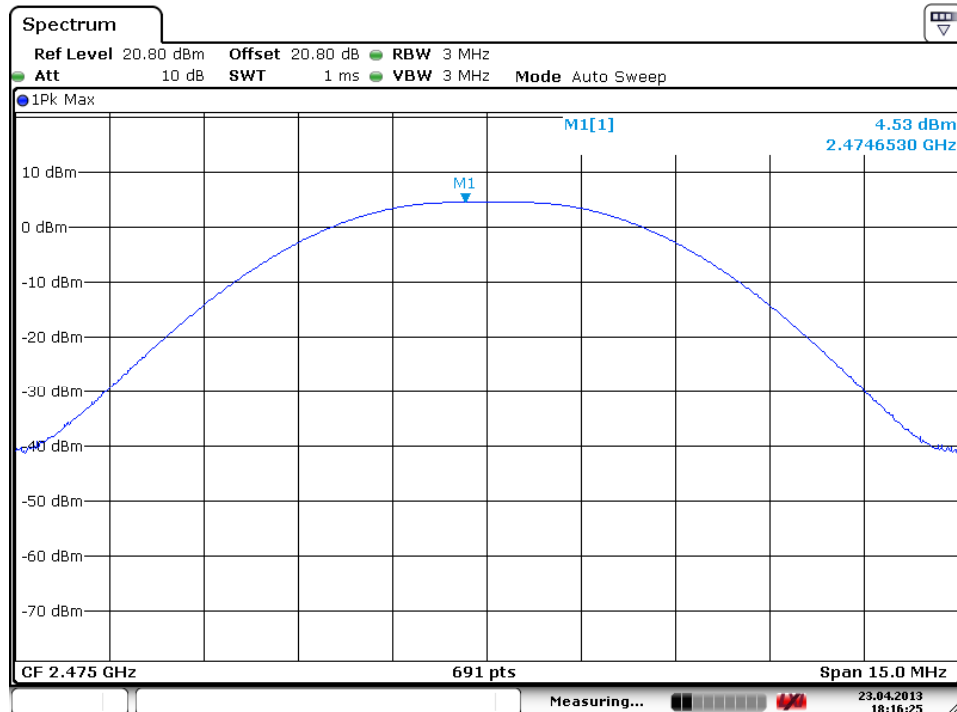

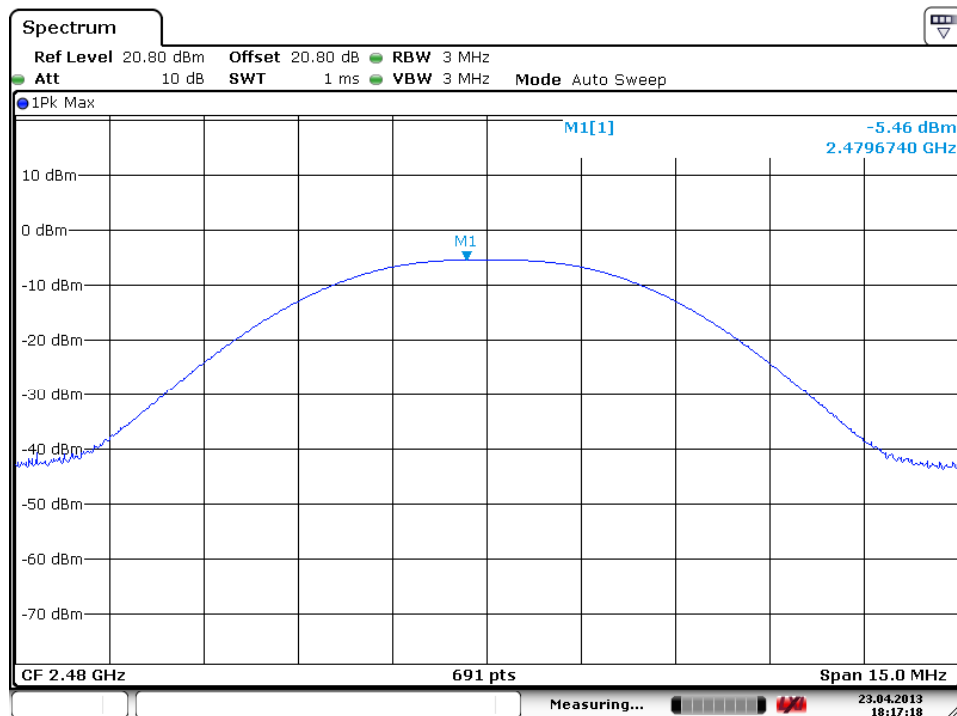

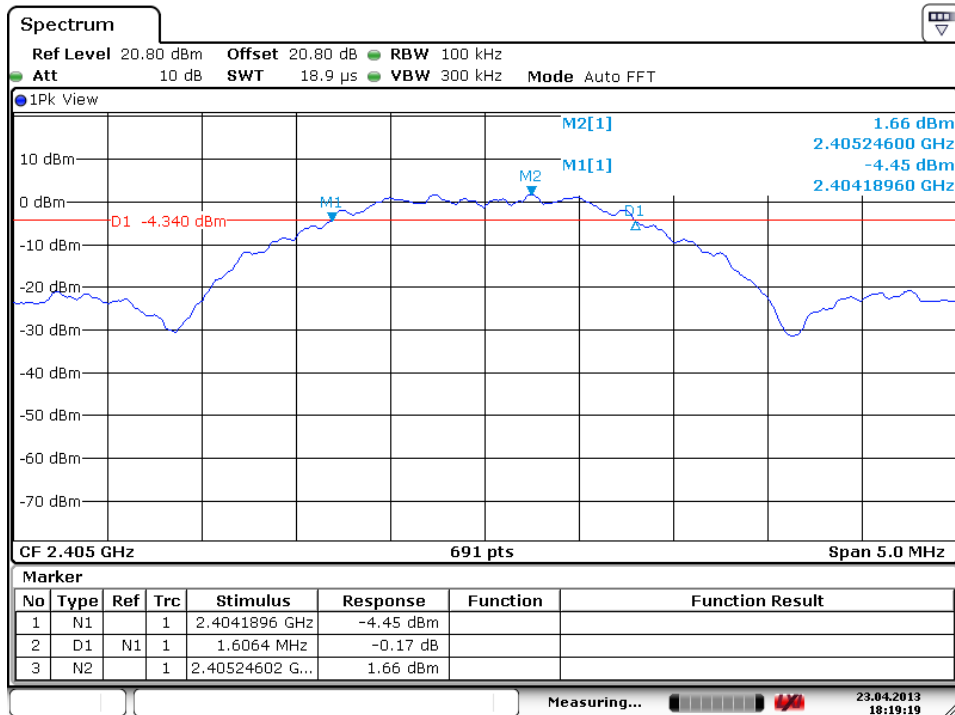

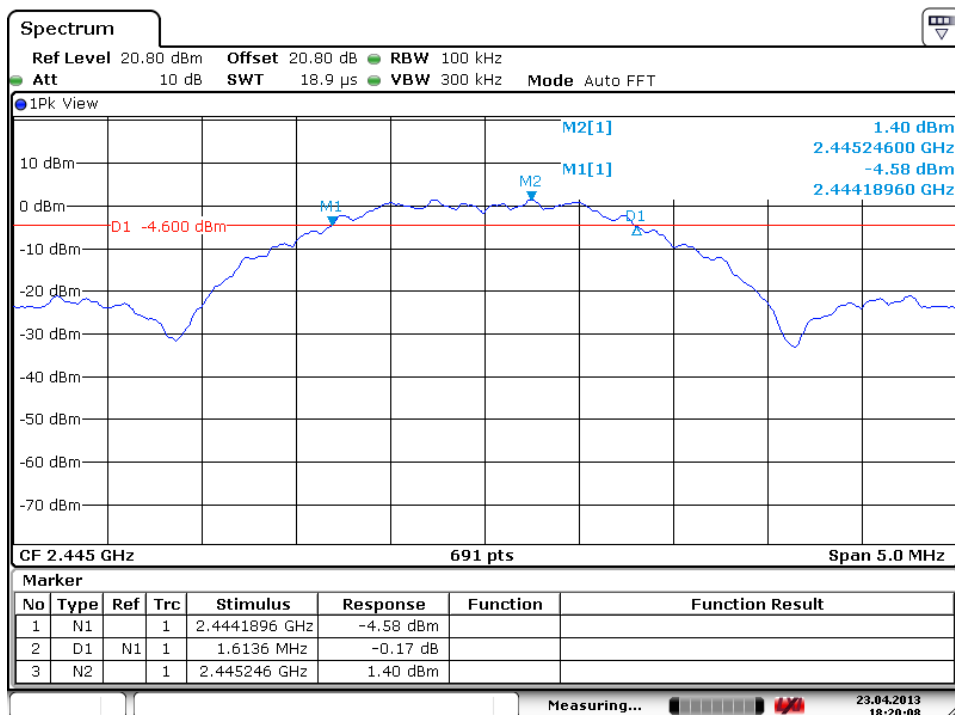
Test Plot of 6dB Bandwidth

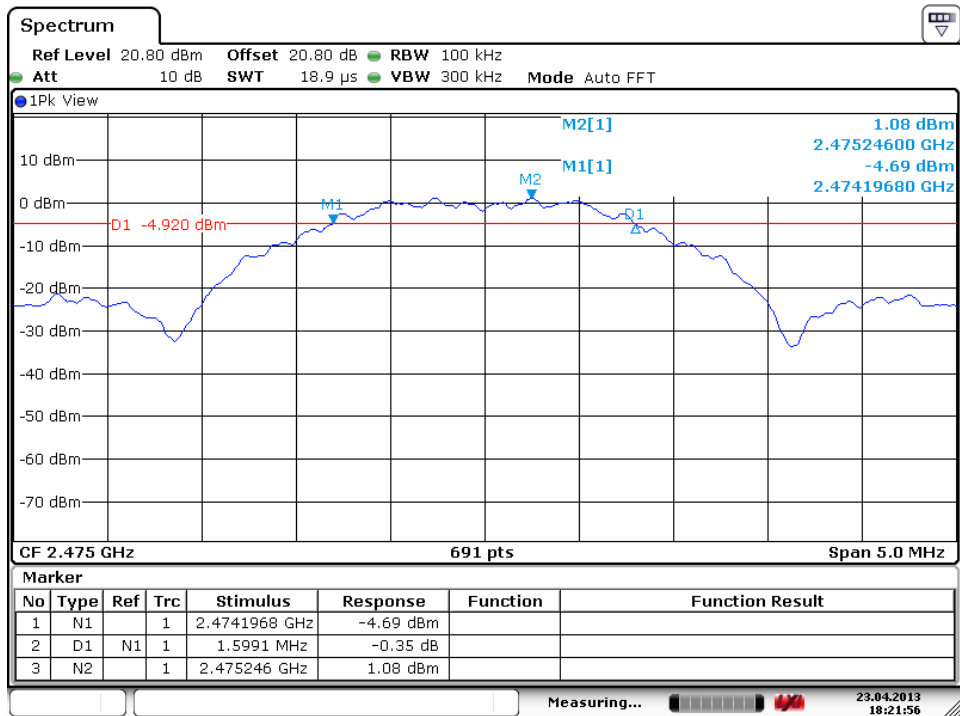

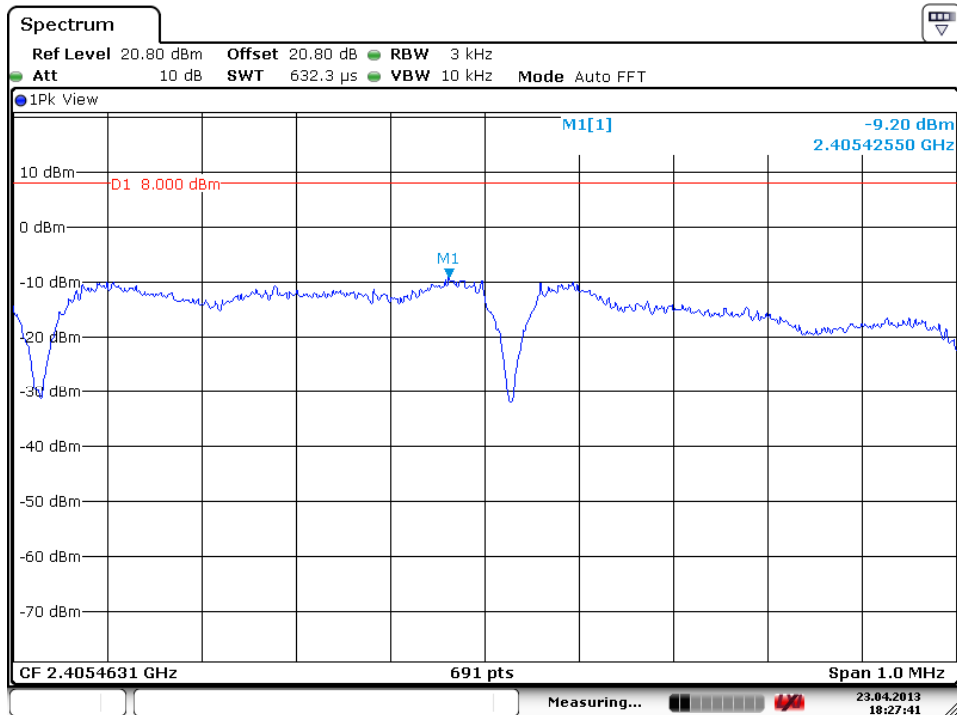

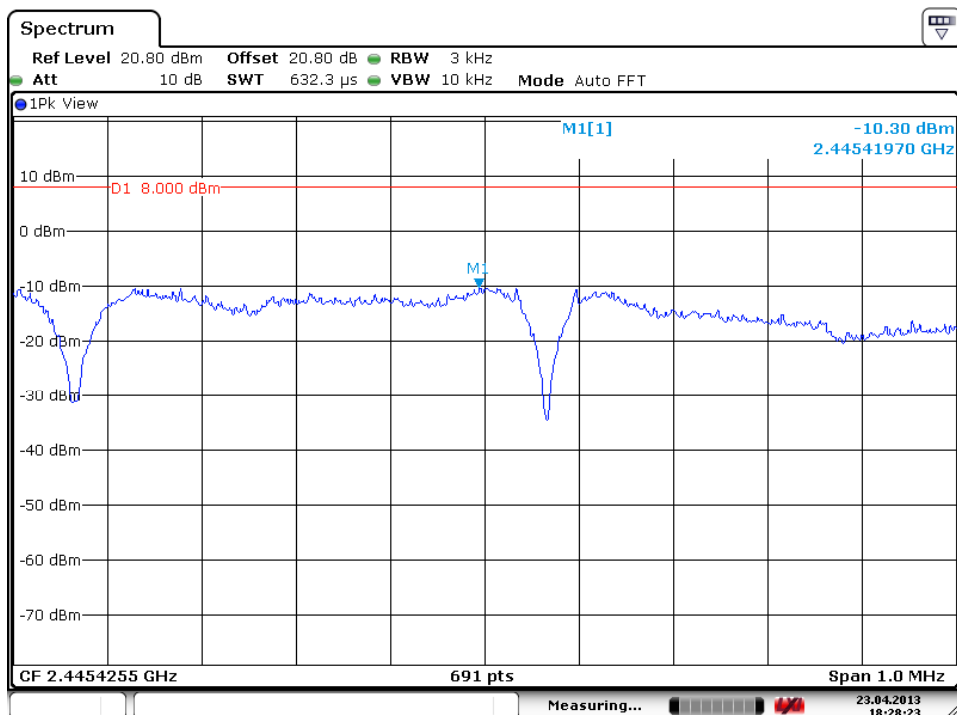
Test Plot of Power Density

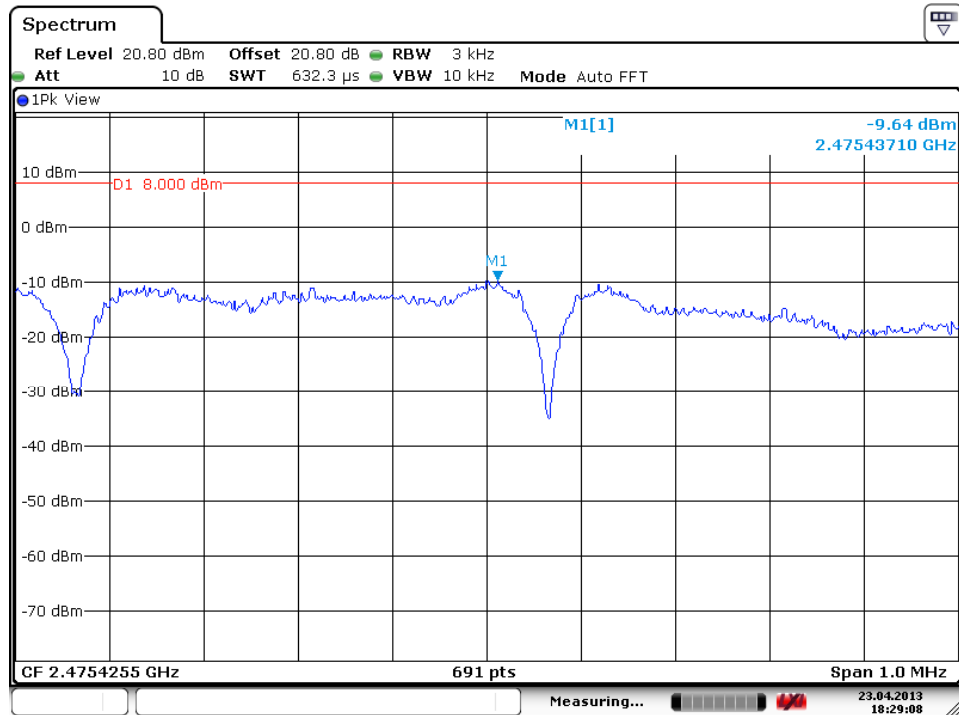

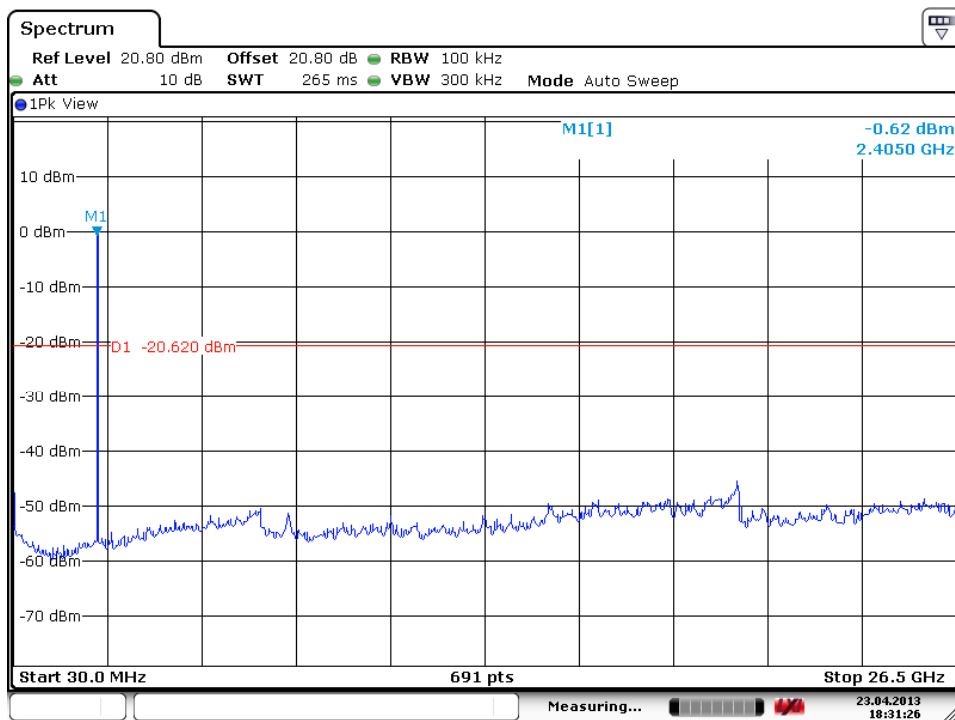

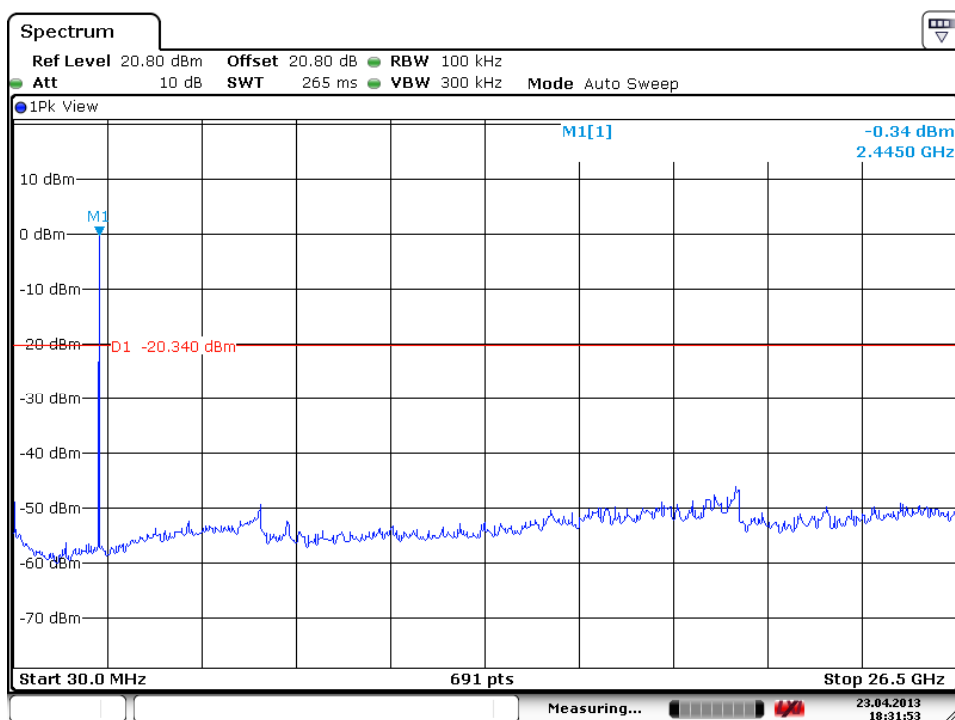
Test Plot of 100kHz Conducted Emissions

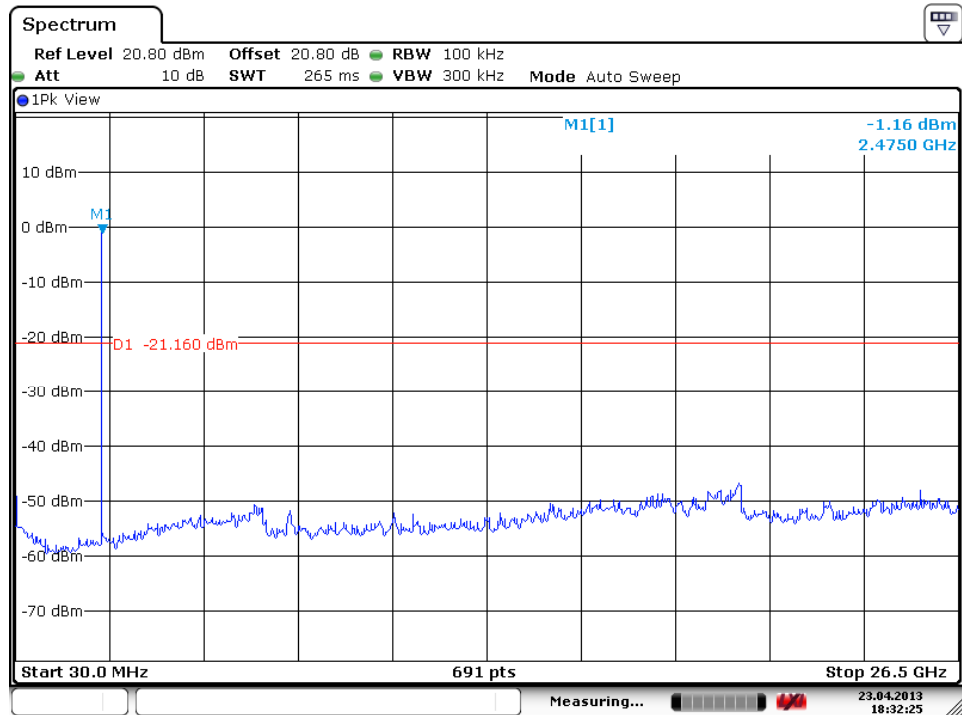

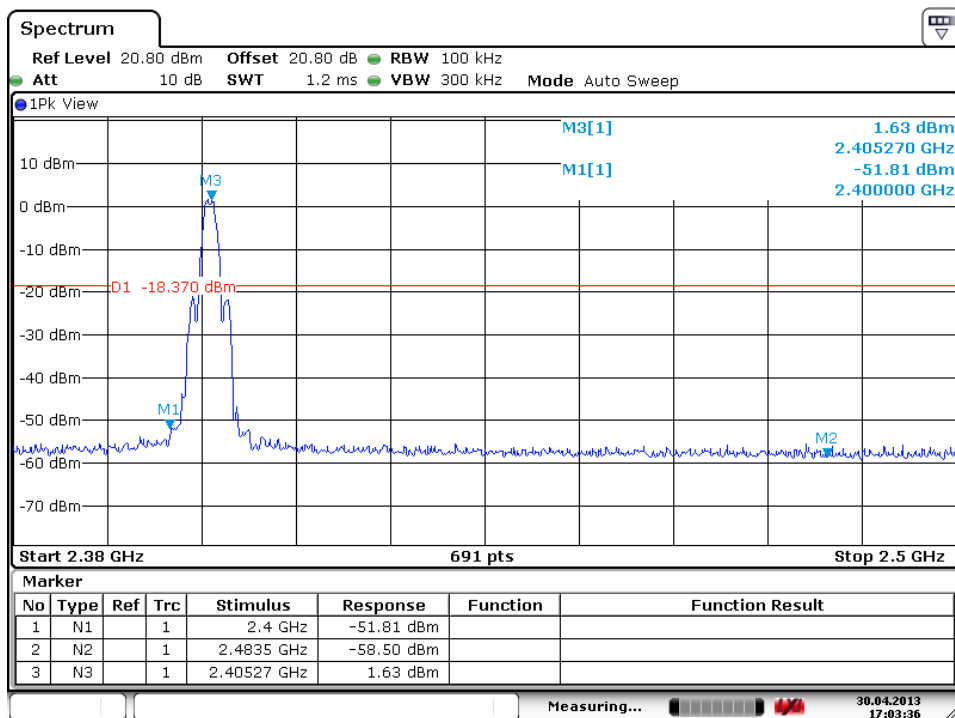

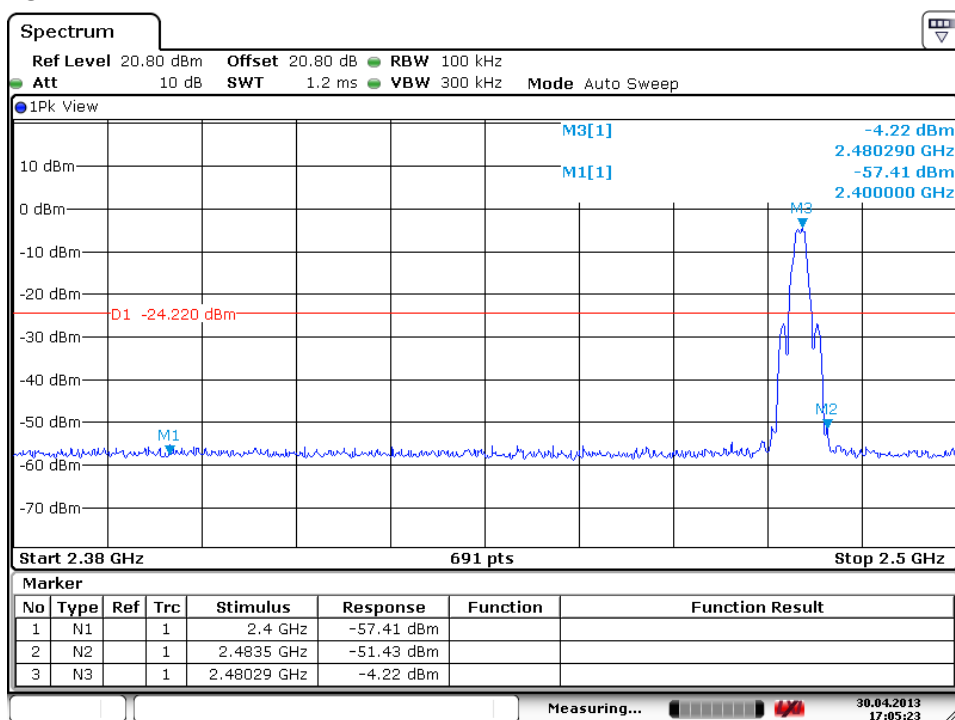
Test Plot of 100kHz Bandwidth of Frequency Band Edge

The Radiated Emissions testing was performed in the X, Y and Z axis orientation. The X Axis orientation is the worst-case and recorded in this test report. Due to the small size of the product and that there are no inductive components of significant size, 9kHz to 30MHz frequency range is not tested based on technical judgment.

6. Safety Human exposure

6.1 Radio Frequency Exposure Compliance

6.1.1 Electromagnetic Fields

The limit for Maximum Permissible Exposure (MPE) specified in FCC 1.1310 is followed. The gain of the antennas used in the product is extracted from the Antenna information provided and also the maximum total power input to the antenna was measured. Through the Friis transmission formula and the maximum gain of the antenna, we can calculate the exposure at a distance of 20 cm away from the product and compare it to the limit of MPE.

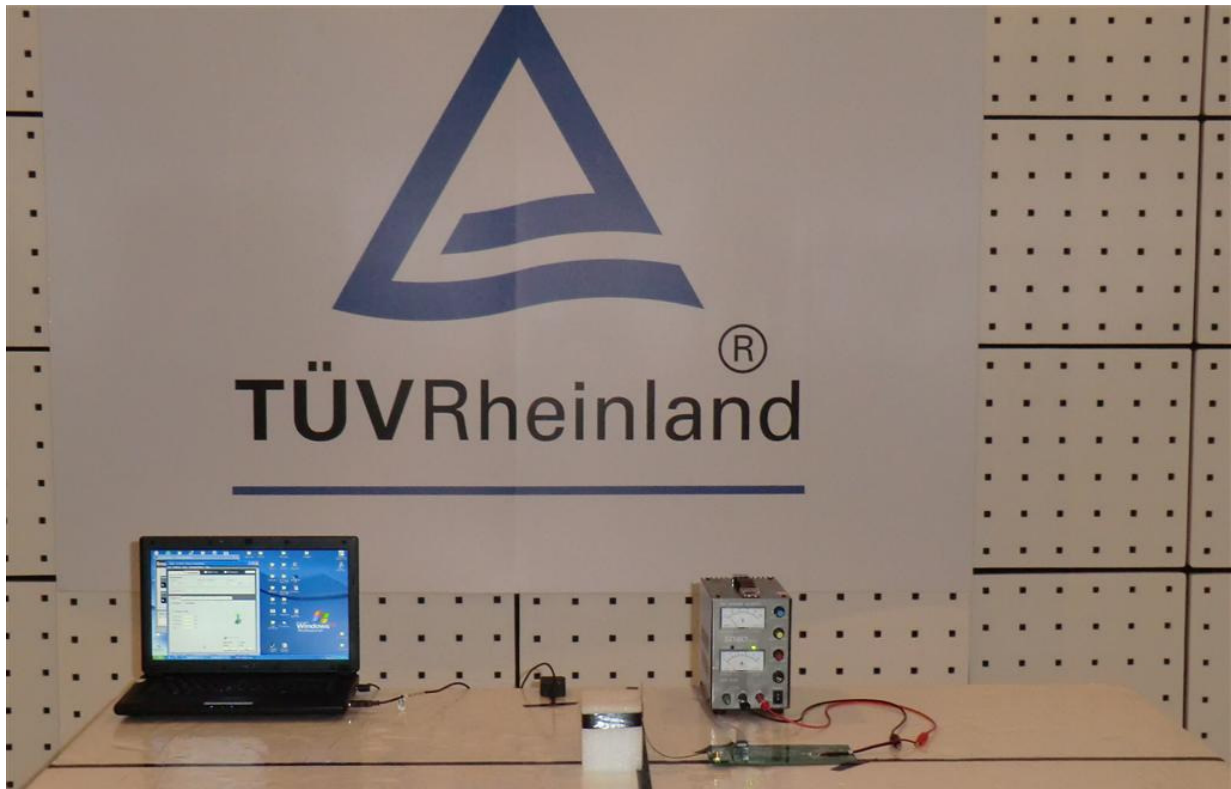

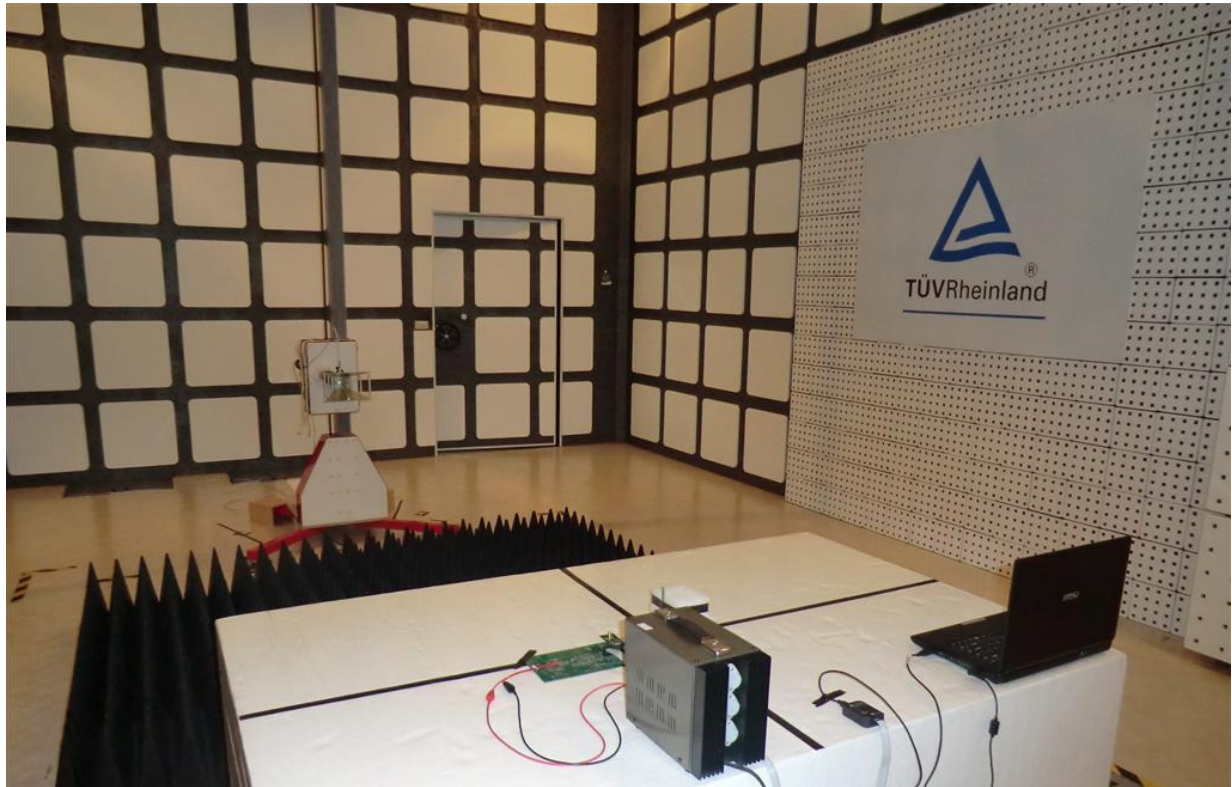
Photograph 1: Set-up for Spurious Emissions (Front View)



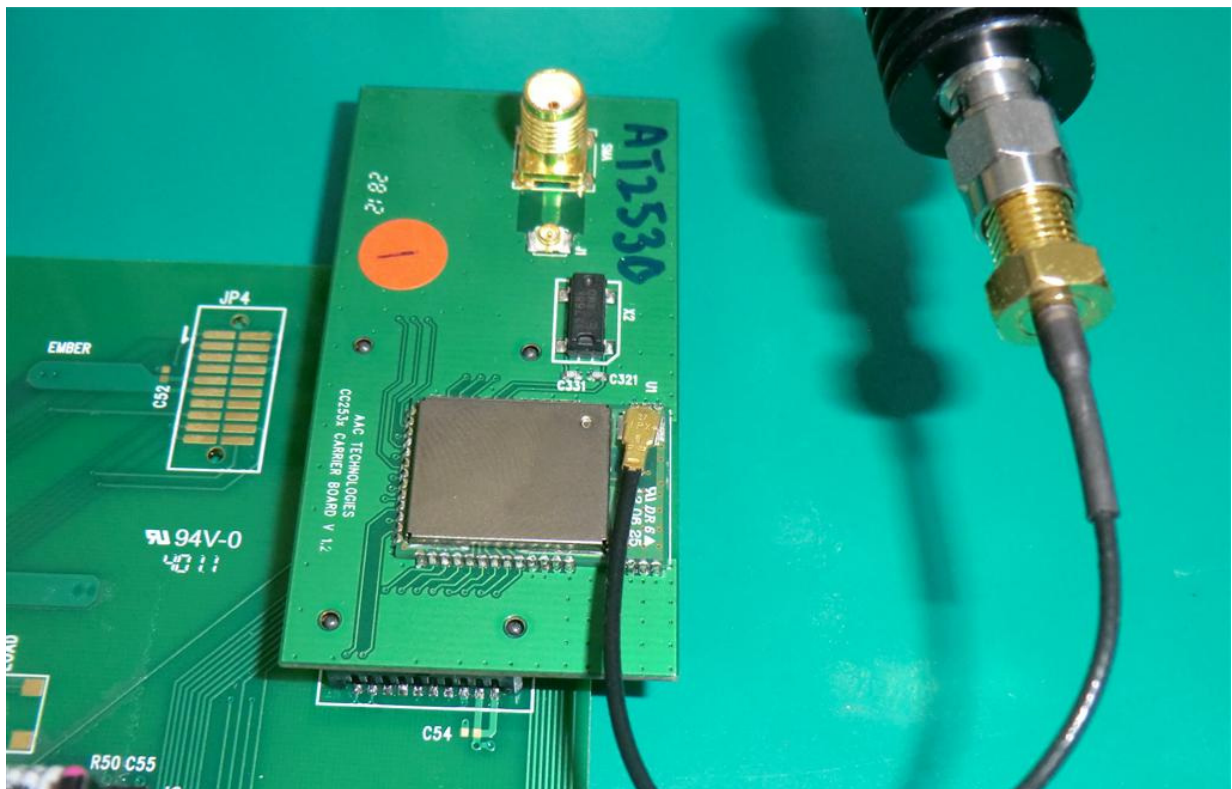
Photograph 2: Set-up for Spurious Emissions (Back View 1)
