## Windows Me/2000/XP

### To Use Documan

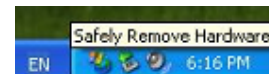
- Plug Documan into a USB port on your system.
- System will automatically detect Documan and install the driver. (on very first use)
- Status light on Documan will blink and turn off when operated properly.
- Documan will be properly detected as a removable disk, if you click the "passmanx.exe" file and input the password. (the initial password is '00000000').
- To use the program, double-click the Menu.exe file from Documan.
- Data can be read or written as same as in hard disk.

### To Remove Documan

- Close all Documan programs or files.

- On Windows taskbar, click the Safely Remove Hardware icon.

- In Safely Remove Hardware, double-click USB Mass Storage Device.

\*When red light on Documan blinks, do not remove Documan. It may damage data or FAT table.

#### Windows 98/98SE

##### To Use Documan

To use Documan in Windows 98/98SE, the USB Driver from the Installation CD has to be installed.

- ☐ Plug Documan into a USB port on your system.
- ☐ The New Hardware installation wizard will open.
- ☐ Install Documan as directed from the dialog box.
- ☐ Windows 98 Installation Driver is included in the 98Driver folder from the Installation CD.

##### To Remove Documan

- ☐ Close all Documan programs or files.
- ☐ When the light on Documan is NOT red, unplug from a USB port.

#### Before Installing Program

Documan requires the following system configuration:

\*In case of reinstallation, you will need original Installation CD and serial number. Please store original Installation CD and serial number in a safe place.

#### Installing Programs on Documan

##### Installing in Windows

When program on Documan was removed, you may reinstall the program using the following methods.

- ☐ If your computer is turned off, turn on your computer.
- ☐ Plug Documan into a USB port on your system.

- ☐ Insert the Installation CD into the CD-ROM Drive with label facing up.
- ☐ Installation program will be prompted automatically.
- ☐ If installation does not start, open Windows Explorer, and then double-click the Install.exe file from the CD-ROM Drive.
- ☐ The License Agreement dialog box will open. Click the Agree option, and then click Next.
- ☐ Enter User Name, Organization and Serial Number on the User Information dialog box. Serial Number is included in the purchased package.
- ☐ In License Agreement, choose installation type, and then click Next.
- ☐ In User Information, click Install to install program on Documan.
