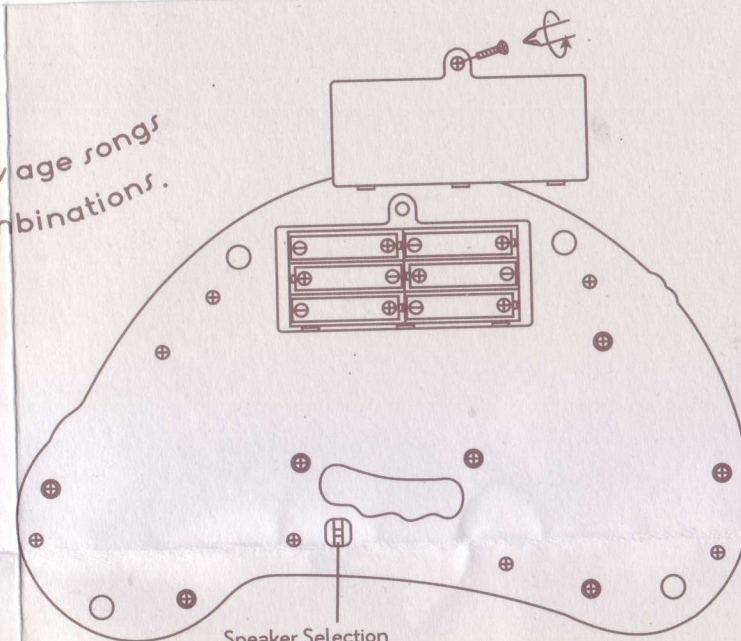

1. THE STAGE

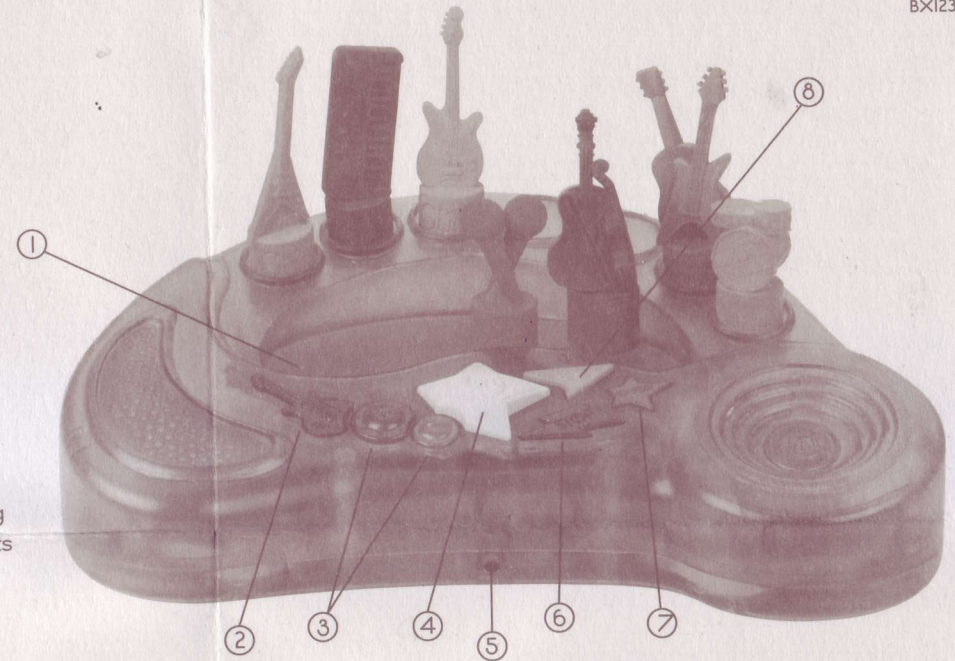
