


Scan Graph of adapter HNC050200X






Figure1: 30MHz to 1GHz radiated emissions test setup




Figure 2: Above 1GHz radiated emissions test setup



5.2.2 Test Procedure

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
6. Repeat above procedures until all frequency measured were complete.

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CL - AG$$

Where FS = Field Strength	CL = Cable Attenuation Factor (Cable Loss)
RA = Reading Amplitude	AG = Amplifier Gain
AF = Antenna Factor




Band Edge and Restrictd band (Radiated measurement)



Peak Measurement in Horizontal polarization




Average Measurement in Horizontal polarization

Peak Measurement in Vertical polarization






Transmitting with 8DPSK mode (Highest channel=2480MHz)

Peak Measurement in Horizontal polarization




Average Measurement in Horizontal polarization






Peak Measurement in Vertical polarization








The EUT communicating with GFSK Mode

Lowest channel=2402MHz










The EUT communicating with Pi/4QPSK Mode

Lowest channel=2402MHz




Middle channel=2447MHz





Highest channel=2480MHz



$$\text{①} < 20\text{mW} < \text{②}.$$

So the SAR report is not required.
