# **ANNEX A: MEASUREMENT RESULTS**

#### A.1 OUTPUT POWER

#### A.1.1 Summary

During the process of testing, the EUT was controlled via Rhode & Schwarz Digital Radio Communication tester (CMU-200) to ensure max power transmission and proper modulation.

This result contains peak output power and EIRP measurements for the EUT. In all cases, output power is within the specified limits.

#### A.1.2 Conducted

#### A.1.2.1 Method of Measurements

The EUT was set up for the max output power with pseudo random data modulation.

These measurements were done at 3 frequencies, 1852.4 MHz, 1880.0MHz and 1907.6MHz for WCDMA Band II;826.4MHz, 836.6MHz and 846.6MHz for WCDMA Band V (bottom, middle and top of operational frequency range).

#### A.2 FREQUENCY STABILITY

#### A.2.1 Method of Measurement

In order to measure the carrier frequency under the condition of AFC lock, it is necessary to make measurements with the EUT in a "call mode". This is accomplished with the use of R&S CMU200 DIGITAL RADIO COMMUNICATION TESTER.

- 1. Measure the carrier frequency at room temperature.
- 2. Subject the EUT to overnight soak at -30°C.
- 3. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on mid channel of WCDMA Band II and WCDMA Band V, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 4. Repeat the above measurements at 10°C increments from -30°C to +50°C. Allow at least 1 1/2 hours at each temperature, unpowered, before making measurements.
- 5. Remeasure carrier frequency at room temperature with nominal voltage. Vary supply voltage from minimum voltage to maximum voltage, in 0.1Volt increments remeasuring carrier frequency at each voltage. Pause at nominal voltage for 1 1/2 hours unpowered, to allow any self-heating to stabilize, before continuing.
- 6. Subject the EUT to overnight soak at +50°C.
- 7. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on the centre channel, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 8. Repeat the above measurements at 10 C increments from +50°C to -30°C. Allow at least 1 1/2 hours at each temperature, unpowered, before making measurements.
- 9. At all temperature levels hold the temperature to +/- 0.5 ℃ during the measurement procedure.

#### A.2.2 Measurement Limit

#### A.2.2.1 For Hand carried battery powered equipment

According to the JTC standard the frequency stability of the carrier shall be accurate to within 0.1 ppm of the received frequency from the base station. This accuracy is sufficient to meet Sec. 24.235, Frequency Stability. The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. As this transceiver is considered "Hand carried, battery powered equipment" Section 2.1055(d)(2) applies. This requires that the lower voltage for frequency stability testing be specified by the manufacturer. This transceiver is specified to operate with an input voltage of between 3.5VDC and 4.2VDC, with a nominal voltage of 3.8VDC. Operation above or below these voltage limits is prohibited by transceiver software in order to prevent improper operation as well as to protect components from overstress. These voltages represent a tolerance of -10 % and +12.5 %. For the purposes of measuring frequency stability these voltage limits are to be used.

#### A.2.2.2 For equipment powered by primary supply voltage

According to the JTC standard the frequency stability of the carrier shall be accurate to within 0.1 ppm of the received frequency from the base station. This accuracy is sufficient to meet Sec. 24.235, Frequency Stability. The frequency stability shall be sufficient to ensure that the



fundamental emission stays within the authorized frequency block. For this EUT section 2.1055(d)(1) applies. This requires varying primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried battery equipment.

#### A.4.1 Occupied Bandwidth Results

Occupied bandwidth measurements are only provided for selected frequencies in order to reduce the amount of submitted data. Data were taken at the extreme and mid frequencies of the US Cellular/PCS frequency bands. The table below lists the measured 99% BW. Spectrum analyzer plots are included on the following pages.

The measurement method is from KDB 971168 4.2:


- a) The spectrum analyzer center frequency is set to the nominal EUT channel center frequency. The frequency span for the spectrum analyzer shall be set wide enough to capture all modulation products including the emission skirts (i.e., two to five times the OBW).
- b) The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1 to 5 % of the anticipated OBW, and the VBW shall be at least 3 times the RBW.
- c) Set the reference level of the instrument as required to keep the signal from exceeding the maximum input mixer level for linear operation. In general, the peak of the spectral envelope must be at least 10log (OBW / RBW) below the reference level.
- e) Set the detection mode to peak, and the trace mode to max hold.
- d) Use the 99 % power bandwidth function of the spectrum analyzer and report the measured bandwidth.




# WCDMA Band II Channel 9262-Occupied Bandwidth (99% BW)-QPSK


# Channel 9400-Occupied Bandwidth (99% BW)-QPSK







#### A.4.1Emission Bandwidth Results

The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emissions are attenuated at least 26 dB below the transmitter power.




#### Channel 9262-Emission Bandwidth (-26dB BW)-QPSK




# Channel 9400-Emission Bandwidth (-26dB BW)-QPSK








# Channel 4183-Emission Bandwidth (-26dB BW)-QPSK



#### A.5.1 Measurement limit

On any frequency outside frequency band of the US Cellular/PCS spectrum, the power of any emission shall be attenuated below the transmitter power (P, in Watts) by at least 43+10Log (P) dB. For all power levels +30 dBm to 0 dBm, this becomes a constant specification limit of -13 dBm. According to KDB 971168 6.0, a relaxation of the reference bandwidth is often provided for measurements within a specified frequency range at the edge of the authorized frequency block/band. This is often implemented by permitting the use of a narrower RBW (typically limited to a minimum RBW of 1% of the OBW) for measuring the out-of-band emissions without a requirement to integrate the result over the full reference bandwidth.




# HIGH BAND EDGE BLOCK-C (WCDMA Band II ) - Channel 9538-QPSK



#### A.6 CONDUCTED SPURIOUS EMISSION

#### Reference

FCC: CFR Part 2.1057, 22.917, 24.238.

#### A.6.1 Measurement Method

The following steps outline the procedure used to measure the conducted emissions from the EUT.

- Determine frequency range for measurements: From CFR 2.1057 the spectrum should be investigated from the lowest radio frequency generated in the equipment up to at least the 10th harmonic of the carrier frequency. For the mobile station equipment tested, this equates to a frequency range of 13 MHz to 9 GHz, data taken from 10 MHz to 25 GHz.
- 2. Determine EUT transmit frequencies: below outlines the band edge frequencies pertinent to conducted emissions testing.
- According to KDB 971168 6.0, the applicable rule part specifies the reference bandwidth for measuring unwanted emission levels (typically, 100 kHz if the authorized frequency band/block is at or below 1 GHz and 1 MHz if the authorized frequency band/block is above 1 GHz)

#### A.6.2 Measurement Limit

Part 24.238 and Part 22.917 specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10 log(P) dB.

The specification that emissions shall be attenuated below the transmitter power (P) by at least 43 + 10 log (P) dB, translates in the relevant power range (1 to 0.001 W) to -13 dBm. At 1 W the specified minimum attenuation becomes 43 dB and relative to a 30 dBm (1 W) carrier becomes a limit of -13 dBm. At 0.001 W (0 dBm) the minimum attenuation is 13 dB, which again yields a limit of -13 dBm. In this way a translation of the specification from relative to absolute terms is carried out.







# Channel 9262: 2.5GHz -7.5GHz


Spurious emission limit -13dBm.

Spurious emission limit -13dBm.




Spurious emission limit -13dBm.

Spurious emission limit -13dBm.







# Channel 9400: 2.5GHz -7.5GHz


Spurious emission limit -13dBm.



#### Channel 9400: 10GHz -15GHz


Spurious emission limit -13dBm.

Spurious emission limit -13dBm.

































# A.7 PEAK-TO-AVERAGE POWER RATIO

#### Reference

FCC: CFR Part 24.232 (d)

The peak-to-average power ratio (PAPR) of the transmitter output power must not exceed 13 dB. The PAPR measurements should be made using either an instrument with complementary cumulative distribution function (CCDF) capabilities to determine that PAPR will not exceed 13 dB for more than 0.1 percent of the time or other Commission approved procedure. The measurement must be performed using a signal corresponding to the highest PAPR expected during periods of continuous transmission.

According to KDB 971168 5.7.1:

- a)Refer to instrument's analyzer instruction manual for details on how to use the power statistics/CCDF function;
- b) Set resolution/measurement bandwidth ≥ signal's occupied bandwidth;
- c) Set the number of counts to a value that stabilizes the measured CCDF curve;
- d) Set the measurement interval to 1 ms
- e)Record the maximum PAPR level associated with a probability of 0.1%
