

## 5.2 MPE Calculation

According to the formula  $S=PG/4\pi R^2$ , we can calculate S which is MPE.

- 1)  $P_d$  = Power density in  $\text{mW/cm}^2$
- 2)  $P_{out}$  = Output power to antenna in  $\text{mW}$
- 3)  $G$  = gain of antenna in linear scale
- 4)  $R$  = min. separation distance between the antenna and the user.
