Limit:	FCC Part15 E Section 15.407: For the band 5.15-5.25GHz, 5.25-5.35GHz, 5.47-5.725GHz, the maximum conducted output power over the frequency bands of operation shall not exceed 250mW. For the band 5.725-5.85GHz, the maximum conducted output power over the frequency bands of operation shall not exceed 1W. RSS-247 Issue 2: Frequency band 5150-5250 MHz: For other devices, the maximum e.i.r.p. shall not exceed 200 mW or $10 + 10 \log_{10} B$, dBm, whichever power is less. B is the 99% emission bandwidth in megahertz. The e.i.r.p. spectral density shall not exceed 10 dBm in any 1.0 MHz band. Frequency band 5250-5350 MHz: The maximum conducted output power shall not exceed 250 mW or $11 + 10 \log_{10} B$, dBm, whichever is less. Test procedure:	Measurement using an RF average power meter (i) Measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied a) The EUT is configured to transmit continuously or to transmit with a constant duty cycle. b) At all times when the EUT is transmitting, it must be transmitting at its maximum power control level. c) The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five. (ii) If the transmitter does not transmit continuously, measure the duty cycle, x, of the transmitter output signal as described in section B). (iii) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter. (iv) Adjust the measurement in dBm by adding $10 \log(1/x)$ where x is the duty cycle (e.g., $10 \log(1/0.25)$ if the duty cycle is 25 percent).

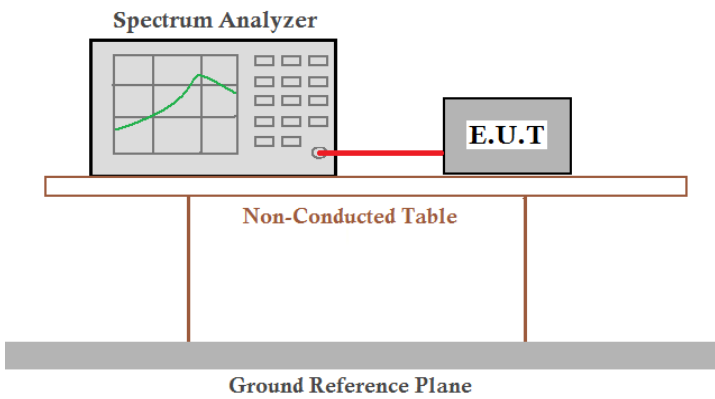

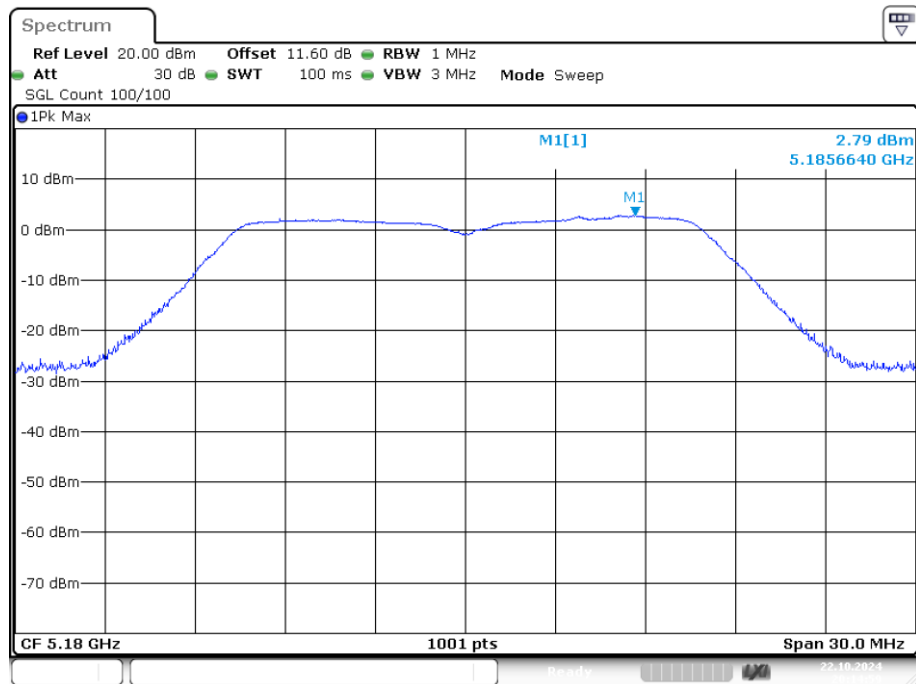

Test setup:	 The diagram illustrates the test setup. A Spectrum Analyzer is connected to an E.U.T. (Equipment Under Test) via a red cable. Both the Spectrum Analyzer and the E.U.T. are placed on a Non-Conducted Table. The table is supported by a Ground Reference Plane.
