

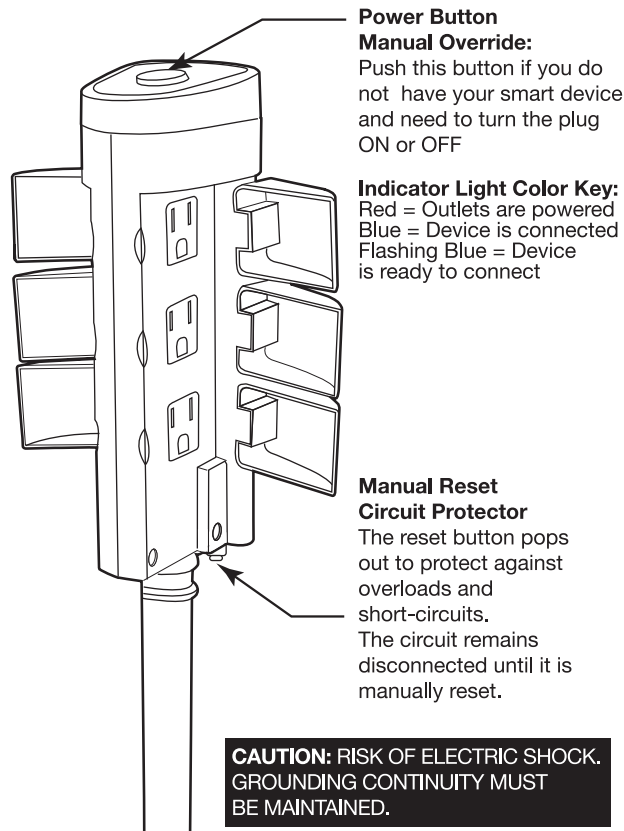

TROUBLESHOOTING TIPS

If you are having difficulty connecting:

- Make sure the Wi-Fi network is a 2.4 GHz network. The outdoor Smart Wi-Fi Yard Stake will not connect to a 5 GHz network.
- Test your Wi-Fi network with other devices such as your phone to make sure it is operating properly.
- The Wi-Fi connection may not have good coverage during set up. Try moving the Smart Wi-Fi Yard Stake closer to your Wi-Fi router.
- Your Wi-Fi network password is case sensitive, make sure you are entering it correctly.

Devices plugged into your Smart Wi-Fi Yard Stake must be ON in order to be controlled via the mobile app.

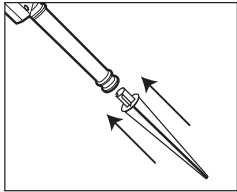
Getting Started:

- 1 Download the Feit Electric app on your smart device

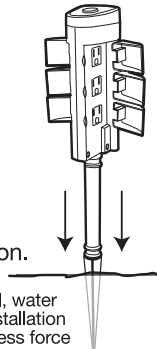


- 2 Assemble and Install your outdoor Smart Wi-Fi Yard Stake

A) Firmly push the barbed stake into the bottom of the Smart Wi-Fi unit until a firm connection is made.



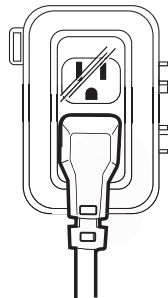
B) With the barbed stake attached, firmly push the Smart Wi-Fi unit into the ground at a suitable location.



NOTE: When installing product in hard or dry soil, water the soil several hours beforehand to make the installation easier. Do not force stake into the ground as excess force can break or bend the stake.

- 3 Plug in your outdoor Smart Wi-Fi Yard Stake

Plug the Smart Wi-Fi Yard Stake into an outdoor rated GFCI receptacle with an appropriate outdoor cover.



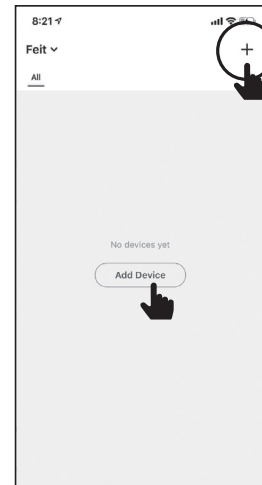

- 4 Launch and use the Feit Electric app to complete the set up

Tap **Add Device** or the + sign, then select **Outdoor Plug** and confirm. You will be prompted to enter you Wi-Fi network and password.

Indicator light must be rapidly blinking to connect. If not already blinking, press and hold the power button for five seconds.

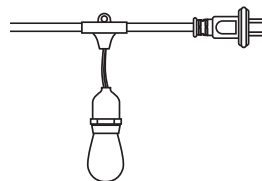
Be sure to connect to a 2.4 GHz Wi-Fi network that covers your installation location.



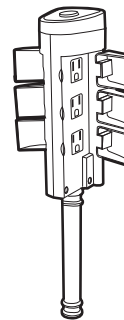
- 5 Plug your device into the outdoor Smart Wi-Fi Stake

Ensure your device is switched to the ON position and plug it into the outdoor Smart Wi-Fi Yard Stake.

NOTE: To protect the unit, each outlet has an individual spring-operated cover which closes automatically when a cord is unplugged or not in use.

WARNING:
