

### 2.1 Limits for Maximum Permissible Exposure (MPE)

### 2.2 MPE Calculation Formula

$$P_d = (P_{out} \cdot G) / (4 \cdot \pi \cdot r^2)$$

where

$P_d$  = power density in mW/cm<sup>2</sup>

$P_{out}$  = output power to antenna in mW

$G$  = gain of antenna in linear scale

$\pi$  = 3.1416

$R$  = distance between observation point and center of the radiator in cm

### 2.3 Classification

The antenna of this product, under normal use condition, is at least 20cm away from the body of the user. So, this device is classified as **Mobile Device**.

5510~5670MHz Directional gain =  $10 \log[(10^{G_1/20} + 10^{G_2/20} + \dots + 10^{G_N/20})^2/2] = 7.74\text{dBi}$

5755~5795MHz Directional gain =  $10 \log[(10^{G_1/20} + 10^{G_2/20} + \dots + 10^{G_N/20})^2/2] = 7.49\text{dBi}$
