To Whom It May Concern:

Ericsson AB requests a Permissive Change (Type Acceptance) for the above mentioned FCC Identifier.

This base station transceiver (Radio Unit - RRUS 11 B26A) is designed for use in LTE and CDMA 800 MHz SMR wireless communications services system. The transmitter will operate from 862 MHz to 869 MHz. It supports Channel Bandwidth of 1.25MHz for CDMA, 3 and 5 MHz for LTE. The receiver circuit supports 817 MHz to 824 MHz. This remote radio unit (RRU) supports modulation type BPSK, QPSK, 8PSK and 16QAM for CDMA, QPSK, 16QAM and 64QAM for LTE. This base station transceiver (RRU) is appropriate to use in different Ericsson radio base stations without re-measurement and re-filing when introducing a new base station type. The base station operates in the broadband PCS services as per 47 CFR Part 90 subpart S. It meets the requirements of 3GPP&3GPP2 specification for operation in CDMA and LTE cellular systems.

This Permissive Change request for this Remote Radio Unit (RRUS 11 B26A) is to include the new access technology LTE which is specified in Exhibit 12.

This base station transceiver (RRU) will in normal mode operates at a nominal power out of 10, 20, 30 and 40 watts at the output connector.

The Exhibit 8 user manuals submitted with this application is generic and may cover multiple products. This application is only valid for the model specified in the Exhibit 12 circuit description.

Ericsson AB requests confidentiality under CFR 0.459 according to attached letter. We further certify that the applicant nor any party to the application is subject to a denial of Federal benefits, that includes FCC benefits, pursuant to section 5301 of the Anti-Drug abuse Act of 1988, 21 U.S.C.
