

# Simple Setup



### 1 Antenna



## 2 HDMI



Connect the included HDMI cable from the HDMI port on the TiVo Bolt to the HDMI IN port on your TV.

**Note:** To receive 4K programming, use the **included** HDMI cable. If you need a longer cable, be sure to use one that is 4K-ready.

# 3 Home network

Connect to your home network. Need help choosing a connection method? See the next page.



**Wireless** - Use your TiVo box's built-in wireless connection. You don't need to connect any additional cables or adapters. (Recommended for single TiVo box setup.)



**Ethernet** - Connect a **Cat5e** Ethernet cable from the TiVo Bolt's ETHERNET port to your router or to an Ethernet jack in your wall. (Recommended for streaming to other TiVo boxes.)



**MoCA®** - If you have a MoCA network in your home, connect a coax cable from the wall jack to the COAX IN port of a MoCA adapter (available from the TiVo Store). Then connect an Ethernet cable from the ETHERNET port of the TiVo Bolt to the ETHERNET port of the adapter. For more detailed instructions, or f you don't yet have a MoCA network in your home, visit **tivo.com/moca**. (Recommended for streaming to other TiVo boxes.)

# 4 Power



Plug in the power cord.

When you see the Welcome screen, follow the on-screen instructions to complete Guided Setup.

# **Connection Options**

The TiVo Bolt needs a high-speed Internet connection to receive program listings, TiVo® service updates, and streaming content. The type of network connection you choose will depend on what you want to do with your TiVo box(es).

But don't worry, no matter which one you pick, you can always change your mind later.

If you plan to stream shows from this TiVo box to other TiVo boxes, you must use a wired connection: Ethernet (Option 2) or MoCA (Option 3).

# Option 1: Wireless

Use this option if you don't plan to stream shows between TiVo boxes.

This option lets you:

- Transfer shows to/from other boxes.
- Stream/download shows to mobile devices

Note that this option uses the TiVo box's built-in wireless capabilities. You won't need additional cables or adapters.

# Option 2: Ethernet

Use this option if you have wired Ethernet connections available to *all* TiVo boxes on your home network.

This option lets you:

- Stream shows to/from other boxes
- Transfer shows to/from other boxes
- Stream/download shows to mobile devices

To use Ethernet, connect a **Cat5e** Ethernet cable from your router or wall jack to your TiVo box.

# Option 3: MoCA

Use this option if you have a MoCA home network.

This option lets you:

- Stream shows to/from other boxes
- Transfer shows to/from other boxes
- Stream/download shows to mobile devices

To add your TiVo Bold Aereo Edition your MoCA network, you will need a MoCA adapter, available in the TiVo Store.

# **Safety Instructions**

Save These Safety Instructions.

### Before you begin

Make sure all your equipment is turned off and the TiVo box is unplugged.

Your TiVo box is only capable of supporting the weight of one or two common A/V components such as VCRs, DVD players, or A/V receivers (provided they have four good, broad, padded feet that distribute of the weight near the corners of the TiVo box).

Also, avoid stacking your TiVo box on top of other electronic components — such as DVD players, A/V receivers — or the vents of your TV.

This product is for use only with listed ITE (Information Technology Equipment).

### Safety information

This product was designed and manufactured to meet strict quality and safety standards. There are, however, some installation and operation precautions of which you should be particularly aware. Please read these instructions before operating the equipment and save them for future reference.

- $1. \, {\sf Read Instructions} {\sf All the safety and operating instructions should be read and understood before the appliance is operated.}$
- 2. Retain Instructions The safety and operating instructions should be retained for future reference.
- 3. Heed Warnings All warnings on the appliance and in the operating instructions should be followed.

### WHO IS COVERED?

Each TiVo box is manufactured from parts and components that are new or substantially equivalent to new in accordance with industry-standard practices. TiVo warrants that the TiVo box will be free from defects in materials and workmanship during the limited warranty period described herein. The limited warranty coverage begins the day you purchase the product, as further described in the following text. For 90 days from the purchase date, the TiVo box will be replaced with a repaired, renewed or comparable product (whichever is deemed necessary by TiVo) if it becomes defective or inoperative (subject to the exclusions set forth below). This exchange is done without charge to you for parts and labor (except applicable taxes, if any). You will be responsible for the cost of shipping. From 90 days to 1 year from the date of purchase, your TiVo box will be replaced with a repaired, renewed, or comparable product (whichever is deemed necessary by TiVo) if it becomes defective or inoperative (subject to the exclusions set forth below). You will be responsible for all labor and shipping costs. Contact Customer Support at tivo.com/support or 877-367-8486 to obtain the labor costs for your exchange.

All products, including replacement products, are covered for solely the original warranty period. When the warranty on the original product expires, the warranty on the replacement product also expires. After one year from the date of purchase, you pay for the replacement of all parts, and for all labor and shipping charges.

### WHAT IS EXCLUDED?

Your warranty does not cover:

- Labor charges for installation or setup of the product.
