Where P_d = power density in mW/cm^2

P_{out} = output power to antenna in mW

G = gain of antenna in linear scale

$\pi = 3.1416$

R = distance between observation point and center of the radiator in cm

P_d the limit of MPE, 1 mW/cm^2 . If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance where the MPE limit is reached.
