3. TEST METHODOLOGY

The measurement procedure described in the American National Standard for Testing Unlicensed Wireless Devices(ANSI C63.10-2009) and FCC Public Notice DA 00-705 dated March 30, 2000 entitled "Filing and Measurement Guidelines for Frequency Hopping Spread Spectrum Systems" were used in the measurement of the **HYUNDAI MOBIS CO., LTD.**

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements. According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2 of ANSI C63.10. (Version :2009) Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3 m away from the receiving antenna, which varied from 1 m to 4 m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical according to the requirements in Section 6.3 of ANSI C63.10. (Version: 2009)

3.4 DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition. Test program used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

Channel low, mid and high with highest data rate (worst case) is chosen for full testing.

4. INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipments, which is traceable to recognized national standards.

5. FACILITIES AND ACCREDITATIONS

5.1 FACILITIES

The SAC(Semi-Anechoic Chamber) and conducted measurement facility used to collect the radiated data are located at the 105-1, Jangam-ri, Majang-Myeon, Icheon-si, Kyunggi-Do, 467-811, Korea. The site is constructed in conformance with the requirements of ANSI C63.4. (Version :2003) and CISPR Publication 22. Detailed description of test facility was submitted to the Commission and accepted dated March 02, 2011 (Registration Number: 90661)

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of Linearly polarized antennas: tuned dipole, bi-conical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements. Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers. Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

6. ANTENNA REQUIREMENTS

According to FCC 47 CFR §15.203:

"An intentional radiator antenna shall be designed to ensure that no antenna other than that furnished by the responsible party can be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section."


8.1 PEAK POWER

LIMIT

The maximum peak output power of the intentional radiator shall not exceed the following:

- 1. For frequency hopping systems operating in the 2400–2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725–5850 MHz band: 1 watt.
- 2. The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi.

TEST PROCEDURE

The transmitter output is connected to the Spectrum Analyzer. The Spectrum Analyzer is set to the peak detector mode. This test is performed with hopping off.

- 1. Span = 2 MHz (GFSK) / 5 MHz (8DPSK)
- 2. RBW = 1 MHz (GFSK) / 3 MHz (8DPSK)
- 3. VBW = 1 MHz (GFSK) / 3 MHz (8DPSK)
- 4. Sweep = auto
- 5. Packet type= DH5 (GFSK) / 3-DH5 (8DPSK)

SAMPLE CALCULATION

Output Power = Spectrum Reading Power + Power Splitter loss + Cable loss(2 ea) = 10 dBm + 6 dB + 1.5 dB = 17.5 dBm

Note:

- 1. Spectrum reading values are not plot data. The power results in plot is already including the actual values of loss for the splitter and cable combination.
- 2. Spectrum offset = Power Splitter loss + Cable loss
- 3. We apply to the offset in the 2.4 GHz range that was rounded off to the closest tenth dB. So, 7.6 dB is offset for peak power measurement.





Test Plots (GFSK) Peak Power (Low-CH)





Peak Power (Mid-CH)





Test Plots (GFSK) Peak Power (High-CH)




Test Plots (8DPSK) Peak Power (Low-CH)




Test Plots (8DPSK)




8.2 BAND EDGES

LIMIT

According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits.

- 2. RBW = 100 kHz
- 3. VBW = 300 kHz



Test Plots without hopping (GFSK) Band Edges (Low-CH)




Test Plots without hopping (GFSK) Band Edges (High-CH)





Test Plots without hopping (8DPSK) Band Edges (Low-CH)




Test Plots without hopping (8DPSK) Band Edges (High-CH)





Test Plots with hopping (GFSK) Band Edges (High-CH)








8.3 FREQUENCY SEPARATION / OCCUPIED BANDWIDTH (99% BW)

LIMIT

According to §15.247(a)(1), Frequency hopping systems operating in the 2400–2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater.

TEST PROCEDURE

The Channel Separation test is performed with hopping on. And the 20 dB Bandwidth test is performed with hopping off.

The spectrum analyzer is set to:

- 1. Span = 3 MHz
- 2. RBW = 30 kHz
- 3. VBW = 100 kHz
- 4. Sweep = auto

The trace was allowed to stabilize. The marker-delta function was used to determine the separation between the peaks of the adjacent channels.





Test Plots (8DPSK) Channel Separation




Test Plots (GFSK)

20 dB Bandwidth & Occupied Bandwidth (Mid-CH)




Test Plots (GFSK)

20 dB Bandwidth & Occupied Bandwidth (Low-CH)




Test Plots (8DPSK)






Test Plots (GFSK)




Test Plots (8DPSK)

Dwell Time (High-CH)








Test Plots (8DPSK)

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in section 15.209(a) (See section 15.205(c).

In making radiated band-edge measurements, there can be a problem obtaining meaningful data because a measurement instrument that is tuned to a band-edge frequency may also capture some in-band signals when using the resolution bandwidth (RBW). In an effort to compensate for this problem, the following technique for determining band-edge compliance shall be used.

- a) Perform an in-band field strength measurement of the fundamental emission using the RBW and detector function specified in 6.3 and 6.4, 6.5, or 6.6, as applicable, and the appropriate regulatory requirements for the frequency being measured. and our Rules for the frequency being measured. For example, for a device operating in the 902-928 MHz band under 47 CFR 15.249, use a 120 kHz RBW with a CISPR QP detector (a peak detector with 100 kHz RBW may alternatively be used). For unlicensed wireless devices operating above 1 GHz, use a 1 MHz RBW, a 1 MHz VBW, and a peak detector as required by 47 CFR 15.35. Repeat the measurement with an average detector (i.e., 1 MHz RBW with 10 Hz VBW). For pulsed emissions, other factors must be included. For example note that radiated measurements of the fundamental emission of a spread spectrum unlicensed wireless device operating under 47 CFR 15.247 are not normally required, but they are necessary in connection with this procedure.
- b) Choose a spectrum analyzer span that encompasses both the peak of the fundamental emission and the band-edge emission under investigation. Set the analyzer RBW to approximately 1% to 5 % of the total span, unless otherwise specified, with a video bandwidth equal to or greater than the RBW. Record the peak levels of the fundamental emission and the relevant band-edge emission (i.e., run several sweeps in peak hold mode). Observe the stored trace and measure the amplitude delta between the peak of the fundamental and the peak of the band-edge emission. This is not an abosolute field strength measurement; it is only a relative measurement to determine the amount by which the emission drops at the band-edge relative to the highest fundamental emission level.
- c) Subtract the delta measured in b) from the field strengths measured in a). The resultant field strengths (CISPR QP, average, or peak, as appropriate) are then used to determine band-edge compliance of the resricted bands, described in 5.9

8.7 POWERLINE CONDUCTED EMISSIONS

LIMIT

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolt (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:

Compliance with this provision shall be based on the measurement of the radio frequency voltage between each power line (LINE and NEUTRAL) and ground at the power terminals.

- 1. The EUT is placed on a wooden table 80 cm above the reference ground plane.
