1. The Outline of FOB-4F81U44

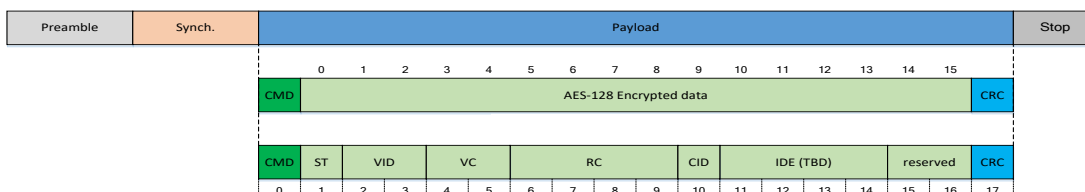

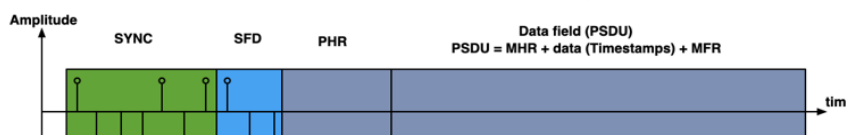

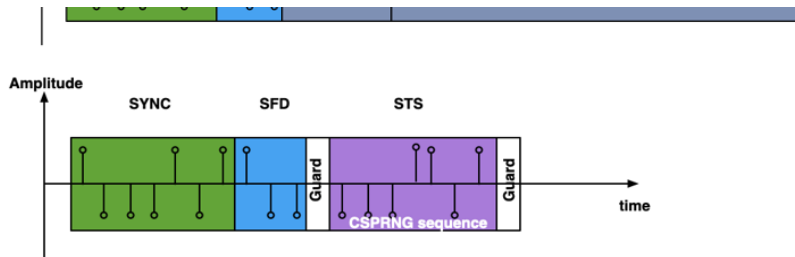


Figure 21-2: SP3
