## 1. The Outline of FOB-4FA2U44

- This unit is a Transmitter.
- FOB-4FA2U44 is a part of Remote Keyless System.
- This unit controls door lock/door unlock/trunk open/panic/remote start-stop/forward/backward/frunk
- This unit also uses UWB signals to enhance security of vehicle, which automatically communicates with the ibu regardless of button

- This unit uses a battery(CR2450)
