3. TEST METHODOLOGY

Both conducted and radiated testing were performed according to the procedures document on chapter 13 of ANSI C63.4 and FCC CFR 47, 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055 and 2.1057.

EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

DESCRIPTION OF TEST MODES

The EUT had been tested under operating condition.

EUT staying in continuous transmitting mode was programmed. Channel Low, Mid and High were chosen for full testing.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz, which worst case was in normal link mode only.

The field strength of spurious emission was measured as EUT stand-up position (H mode) and lie-down position (E1, E2 mode) for both GSM with all power adaptors. The worst emission was found in stand-up position (H mode) and the worst case was recorded.



4. INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipment, which is traceable to recognized national standards.



5. FACILITIES AND ACCREDITATIONS

FACILITIES

All measurement facilities used to collect the measurement data are located at CCS China Kunshan Lab at 10#, Weiye Rd, Innovation Park Eco. & Tec. Development Zone Kunshan city JiangSu, (215300)CHINA.

The sites are constructed in conformance with the requirements of ANSI C63.7, ANSI C63.4 and CISPR Publication 22.

EQUIPMENT




Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

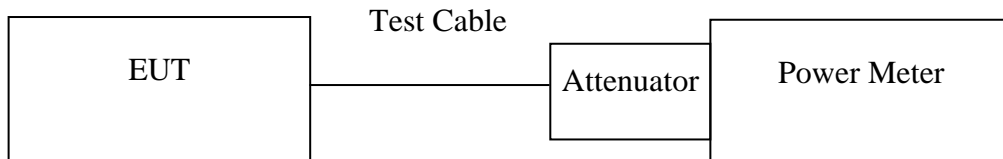

TEST PROCEDURE

The transmitter output was connected to a calibrated attenuator, the other end of which was connected to a power meter. Transmitter output was read off the power meter in dBm. The power output at the transmitter antenna port was determined by adding the value of the attenuator to the power meter reading.

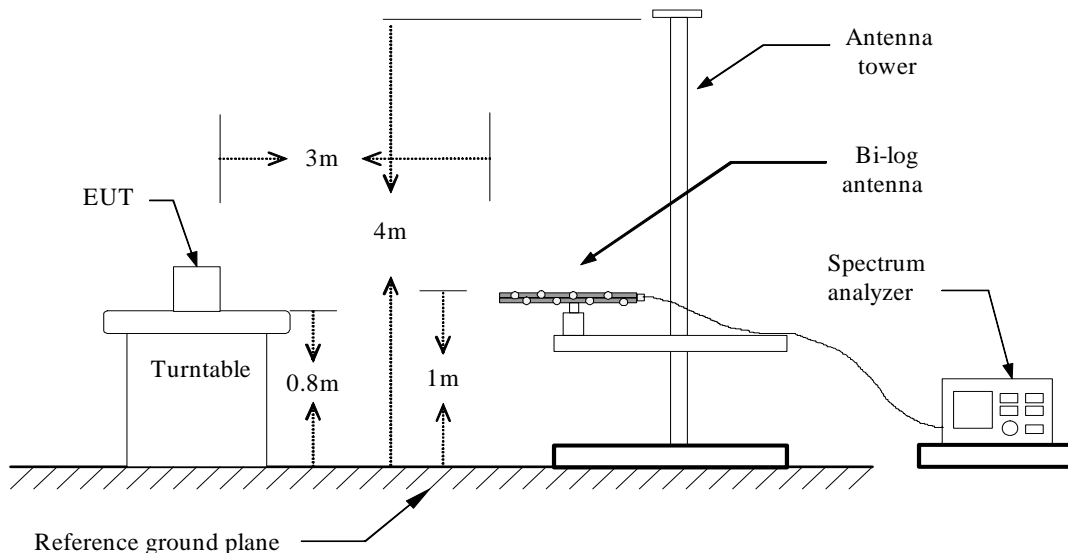

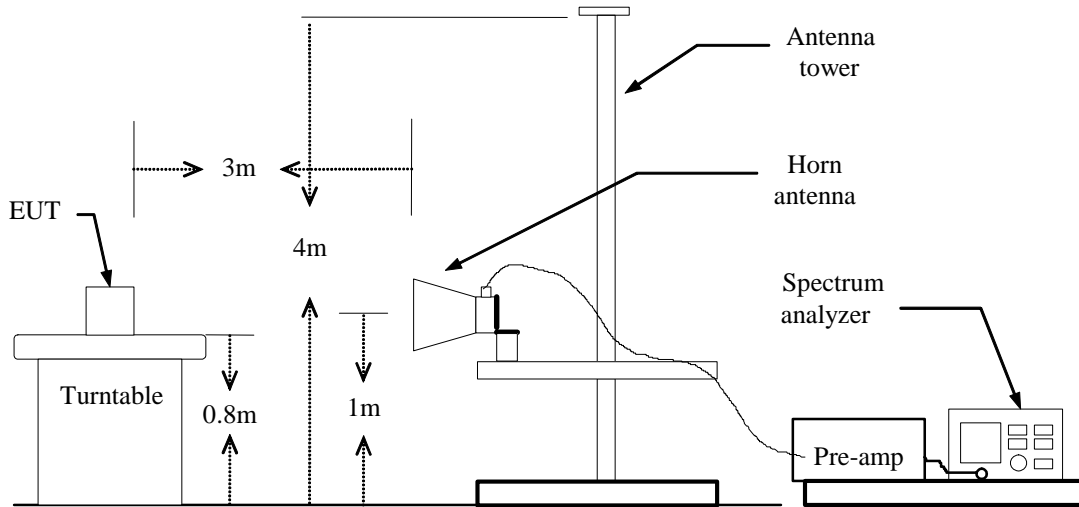

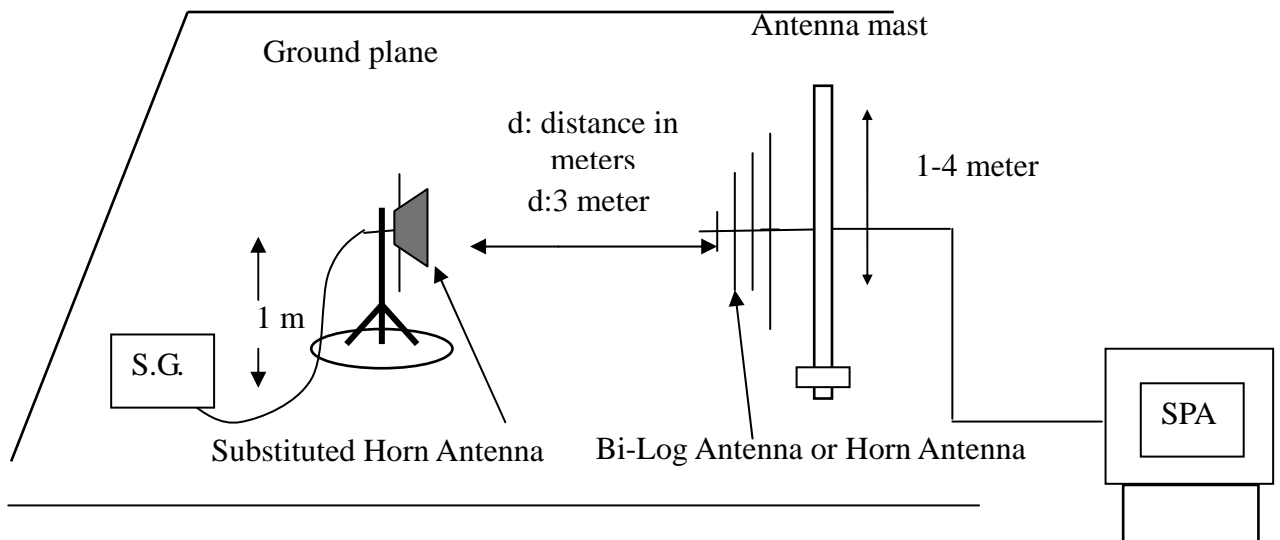
Below 1 GHz

TEST PROCEDURE

The EUT was placed on an non-conductive turntable using a non-conductive support. The radiated emission at the fundamental frequency was measured at 3 m with a test antenna and EMI spectrum analyzer.

During the measurement of the EUT, the resolution bandwidth was set to 3MHz and the average bandwidth was set to 3MHz. The highest emission was recorded with the rotation of the turntable and the lowering of the test antenna. The reading was recorded and the field strength (E in dBuV/m) was calculated.

ERP in frequency band 824-849MHz, and EIRP in frequency band 1851.25 –1910MHz were measured using a substitution method. The EUT was replaced by Bi-log antenna (824-849MHz) or horn antenna (1851.25-1910MHz) connected to a signal generator. The spectrum analyzer reading was recorded and ERP/EIRP was calculated as follows:

$$ERP = \text{S.G. output (dBm)} + \text{Antenna Gain (dBd)} - \text{Cable (dB)}$$

$$EIRP = \text{S.G. output (dBm)} + \text{Antenna Gain (dBi)} - \text{Cable (dB)}$$

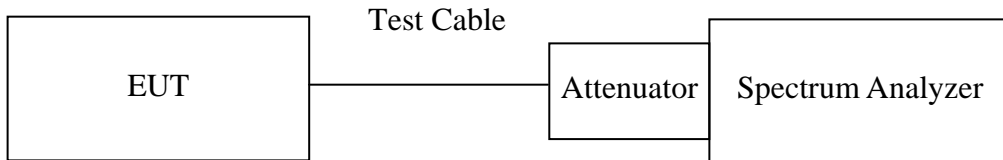

TEST PROCEDURE

The EUT's output RF connector was connected with a short cable to the spectrum analyzer, RBW was set to about 1% of emission BW, VBW is set to 3 times the RBW, -26dBc display line was placed on the screen (or 99% bandwidth), the occupied bandwidth is the delta frequency between the two points where the display line intersects the signal trace.

The spectrum analyzer is set to: RBW = 3 kHz, VBW = 10 kHz, Span = 1 MHz, Sweep = auto

OUT OF BAND EMISSION AT ANTENNA TERMINALS

LIMIT

According to FCC §2.1051, FCC §2.2917(f), FCC §22.917(f), FCC §24.238(a).

Out of Band Emissions: The mean power of emission must be attenuated below the mean power of the non-modulated carrier (P) on any frequency twice or more than twice the fundamental frequency by at least $43 + 10 \log P$ dB.

Mobile Emissions in Base Frequency Range: The mean power of any emissions appearing in the base station frequency range from cellular mobile transmitters operated must be attenuated to a level not exceed -80 dBm at the transmit antenna connector.

Band Edge Requirements: In the 1MHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 1% of the emission bandwidth of the fundamental emission of the transmitter may be employed to measure the Out of band Emission

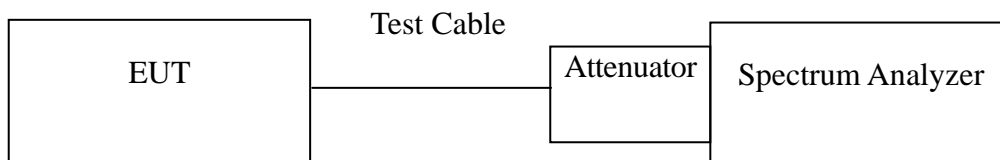

TEST PROCEDURE

The RF output of the transceiver was connected to a spectrum analyzer through appropriate attenuation. The resolution bandwidth of the spectrum analyzer was set at 1MHz, sufficient scans were taken to show the out of band Emissions if any up to 10th harmonic.

For the out of band: Set the RBW, VBW = 1MHz, Start=30MHz, Stop= 10 th harmonic. Limit = -13dBm

Band Edge Requirements (824 MHz and 849 MHz /1850MHz and 1910MHz): In the 1 MHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 1 percent of the emission bandwidth of the fundamental emission of the transmitter may be employed to measure the out of band Emissions. Limit, -13dBm.

For the Band Edge: The spectrum analyzer is set to: RBW = 3 kHz, VBW = 10 kHz, Span = 1 MHz, Sweep = auto

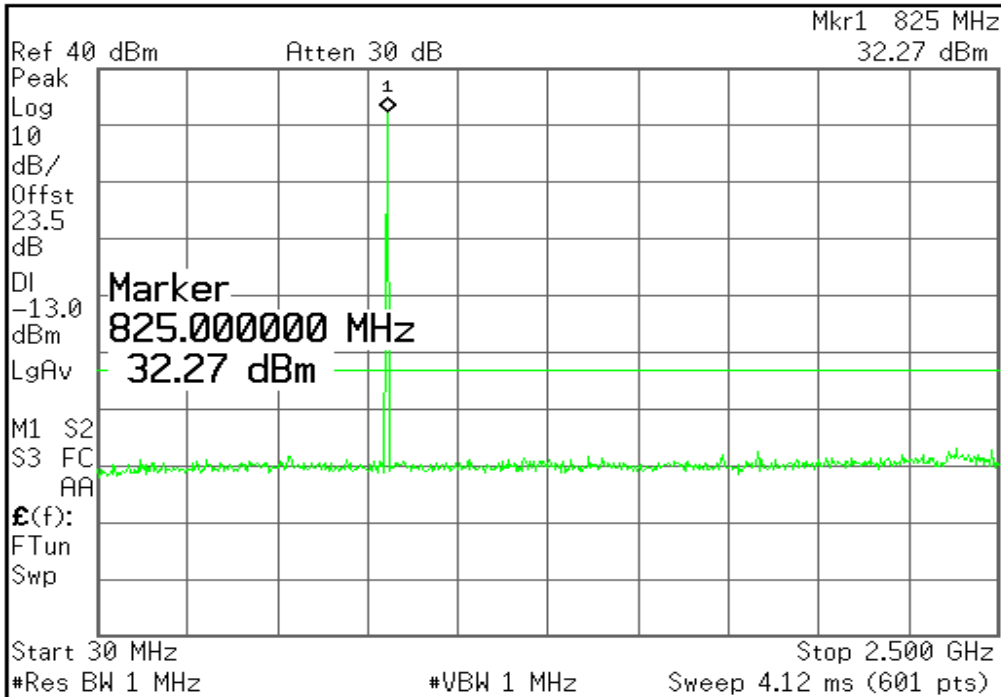

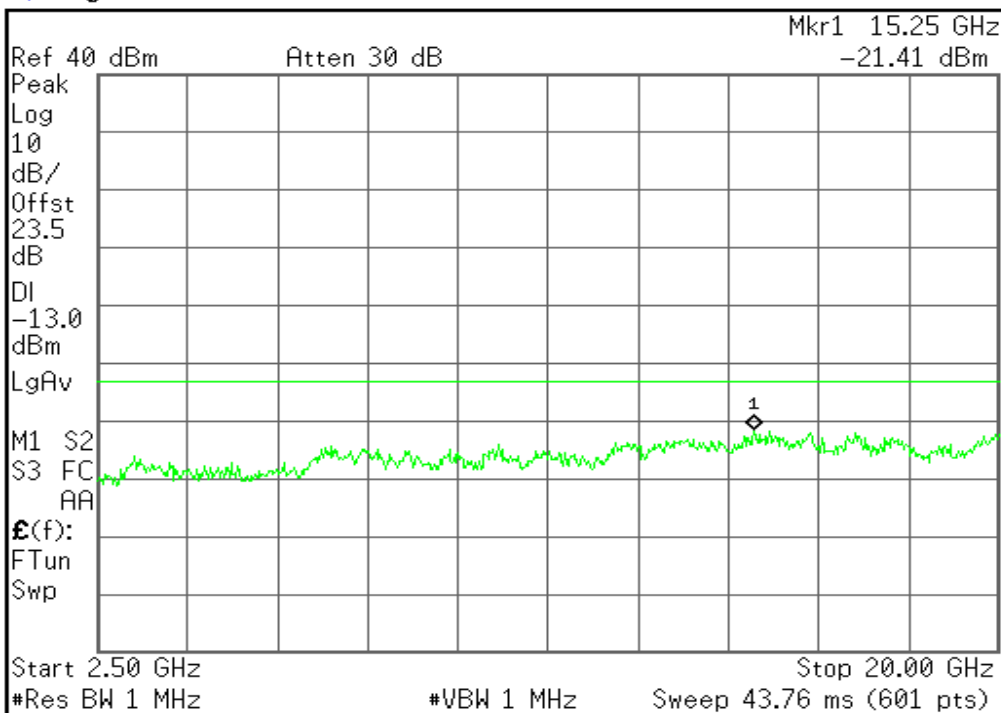

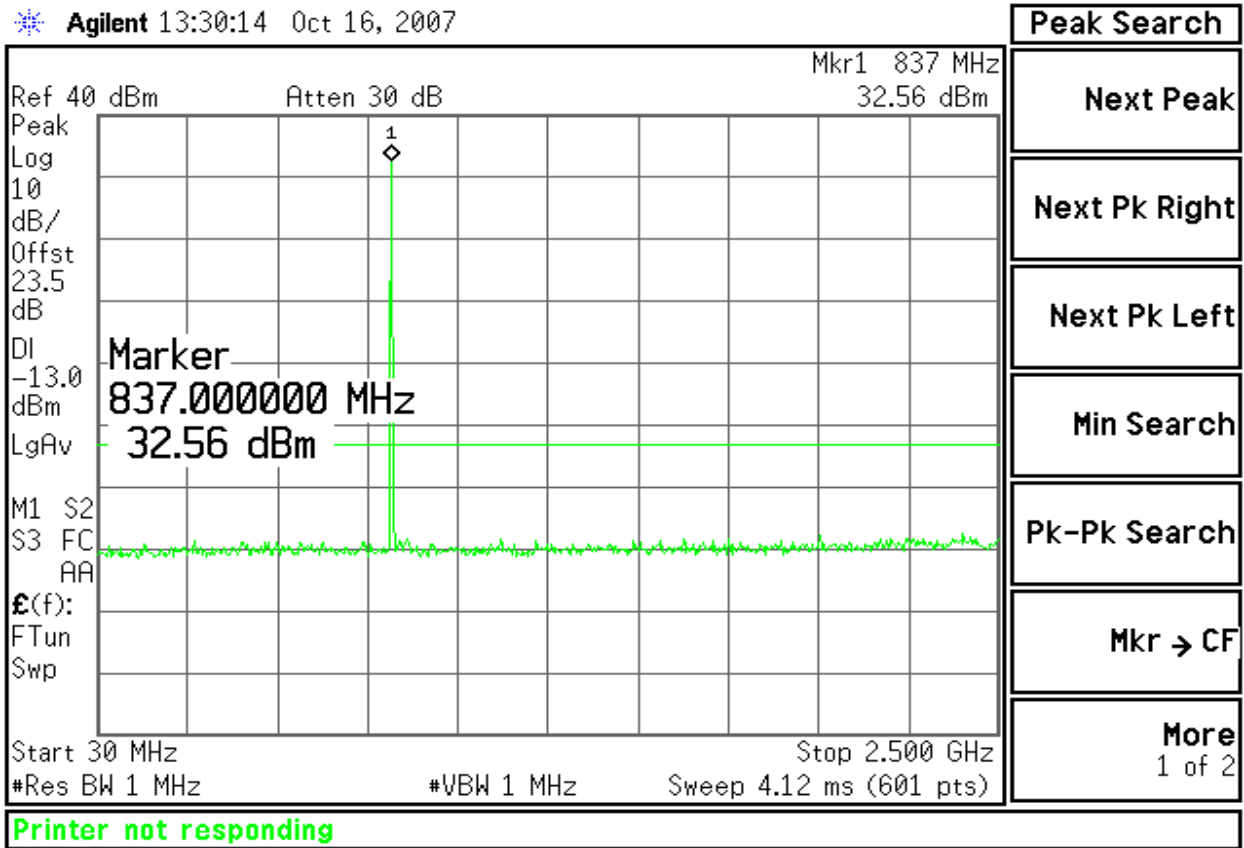


Figure 7-4: Out of Band emission at antenna terminals – GSM CH Mid

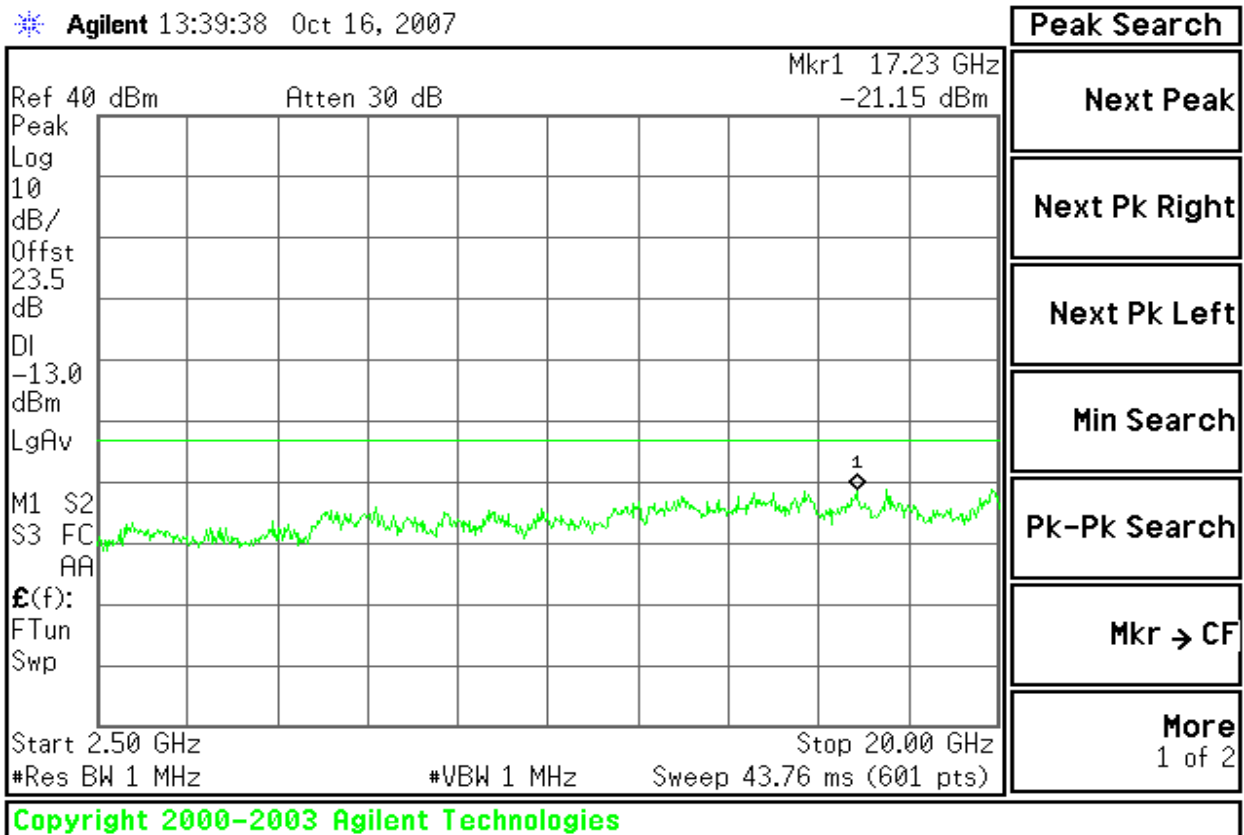




Figure 7-5: Out of Band emission at antenna terminals – GSM CH High

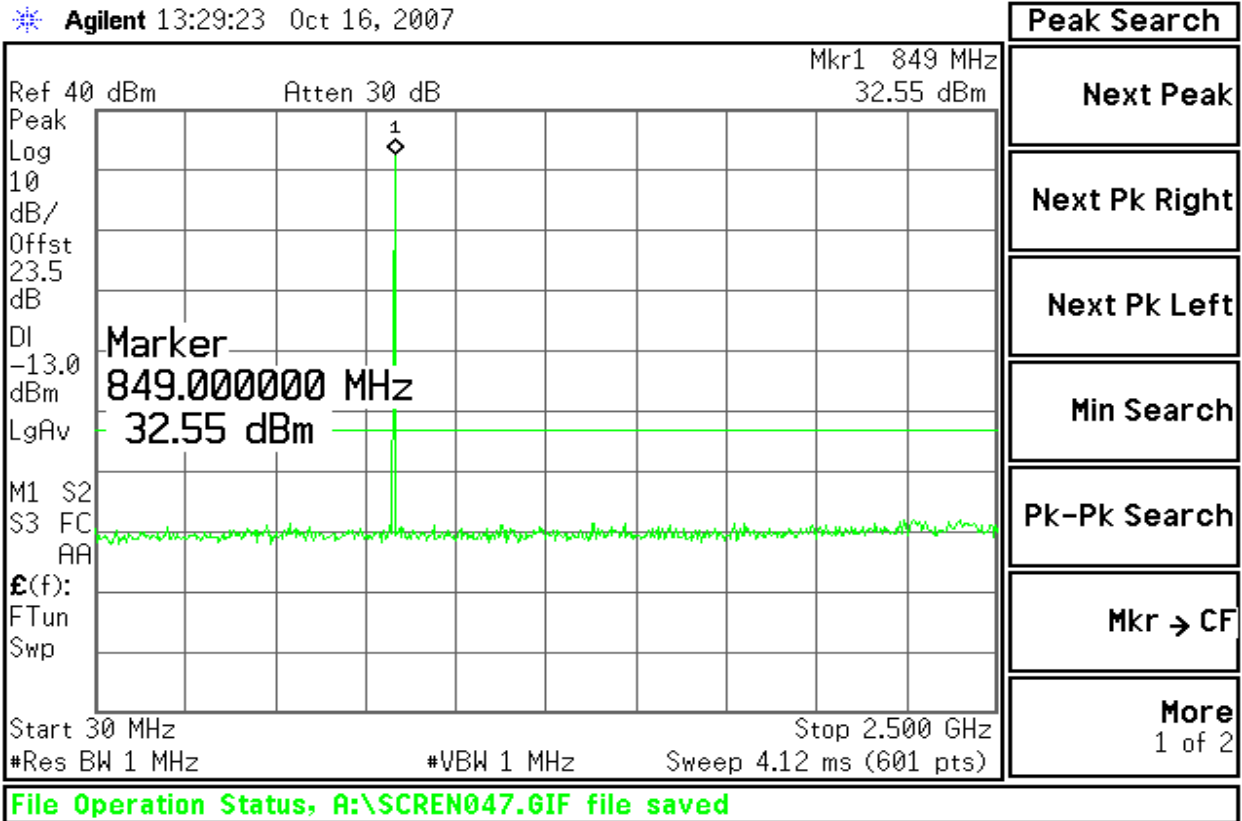
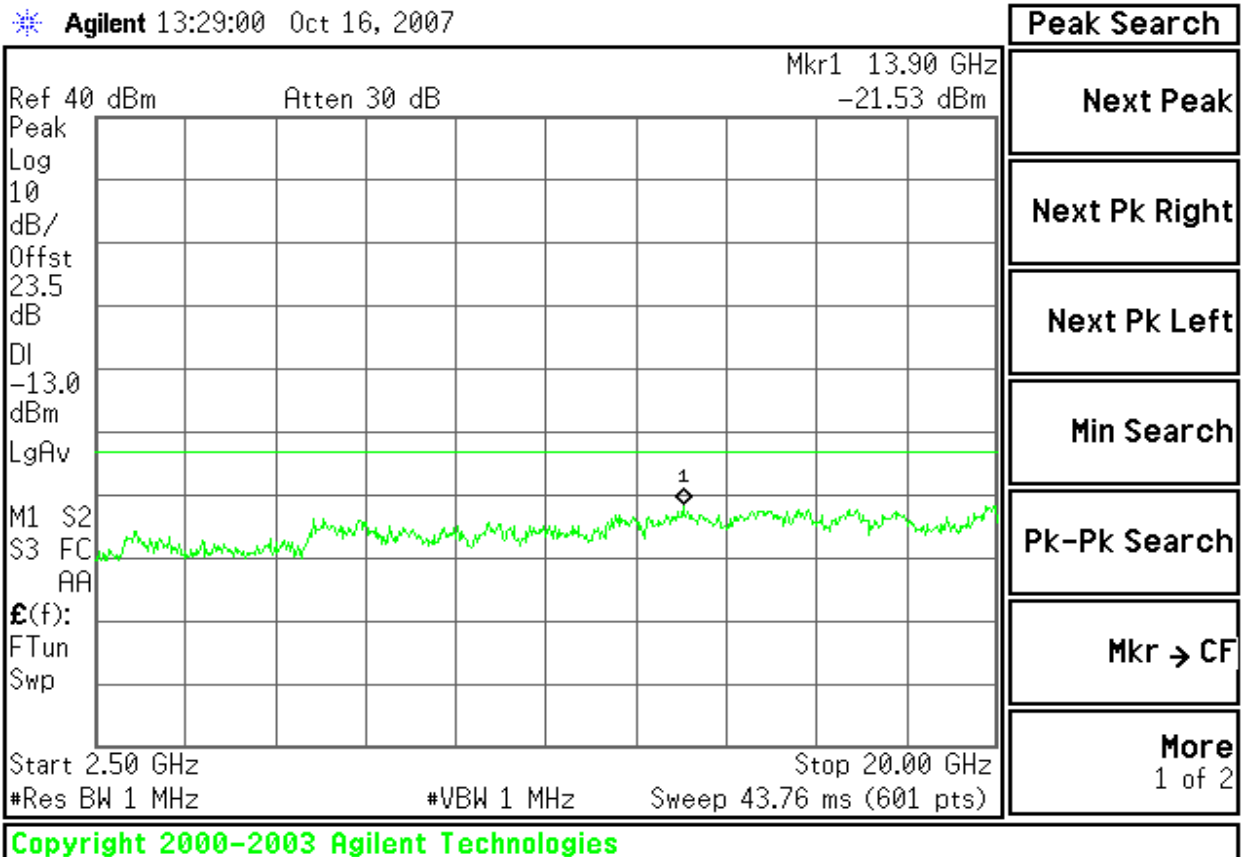


Figure 7-6: Out of Band emission at antenna terminals – GSM CH High

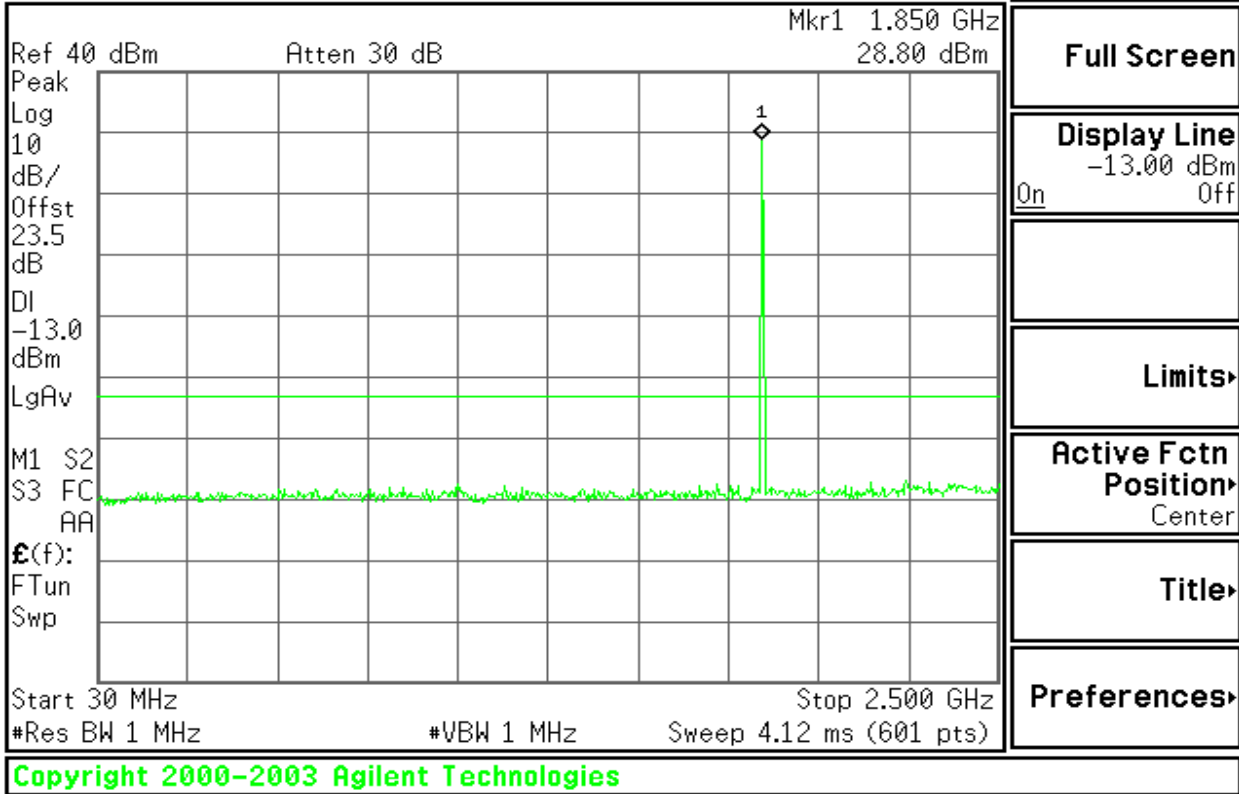


Figure 8-2: Out of Band emission at antenna terminals – GSM CH Low

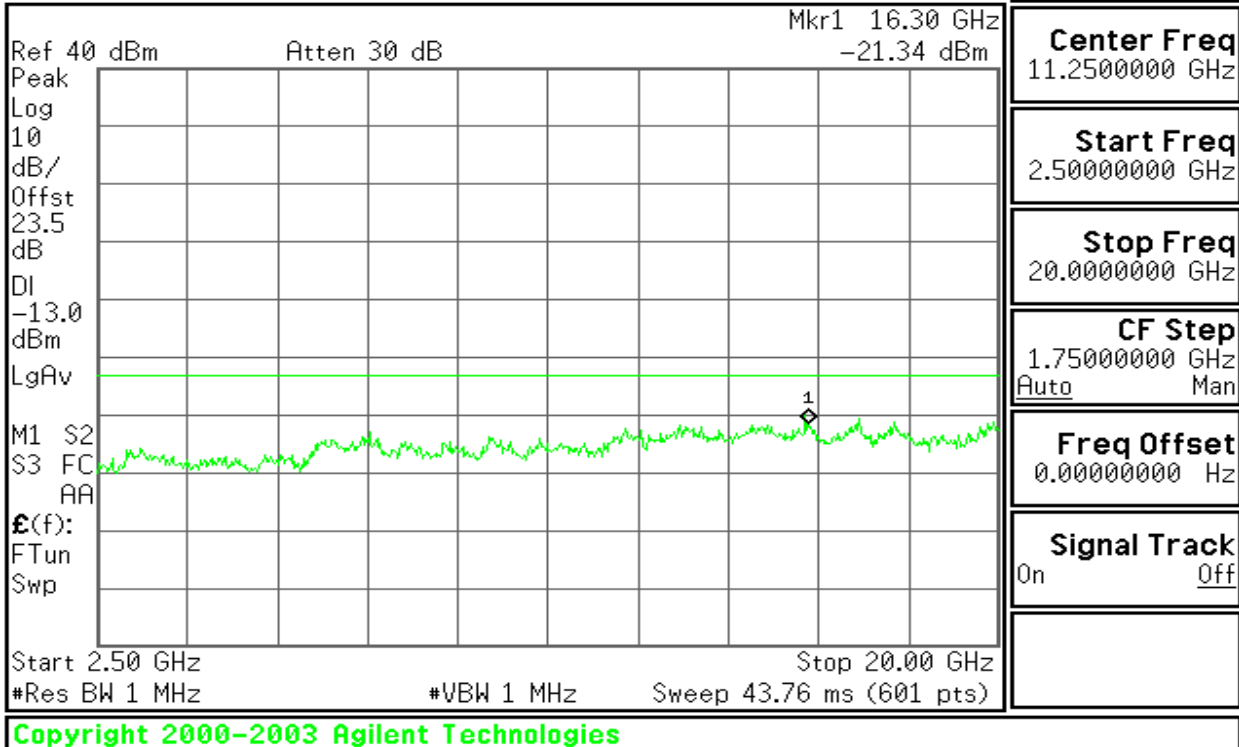


Figure 8-3: Out of Band emission at antenna terminals – GSM CH Mid

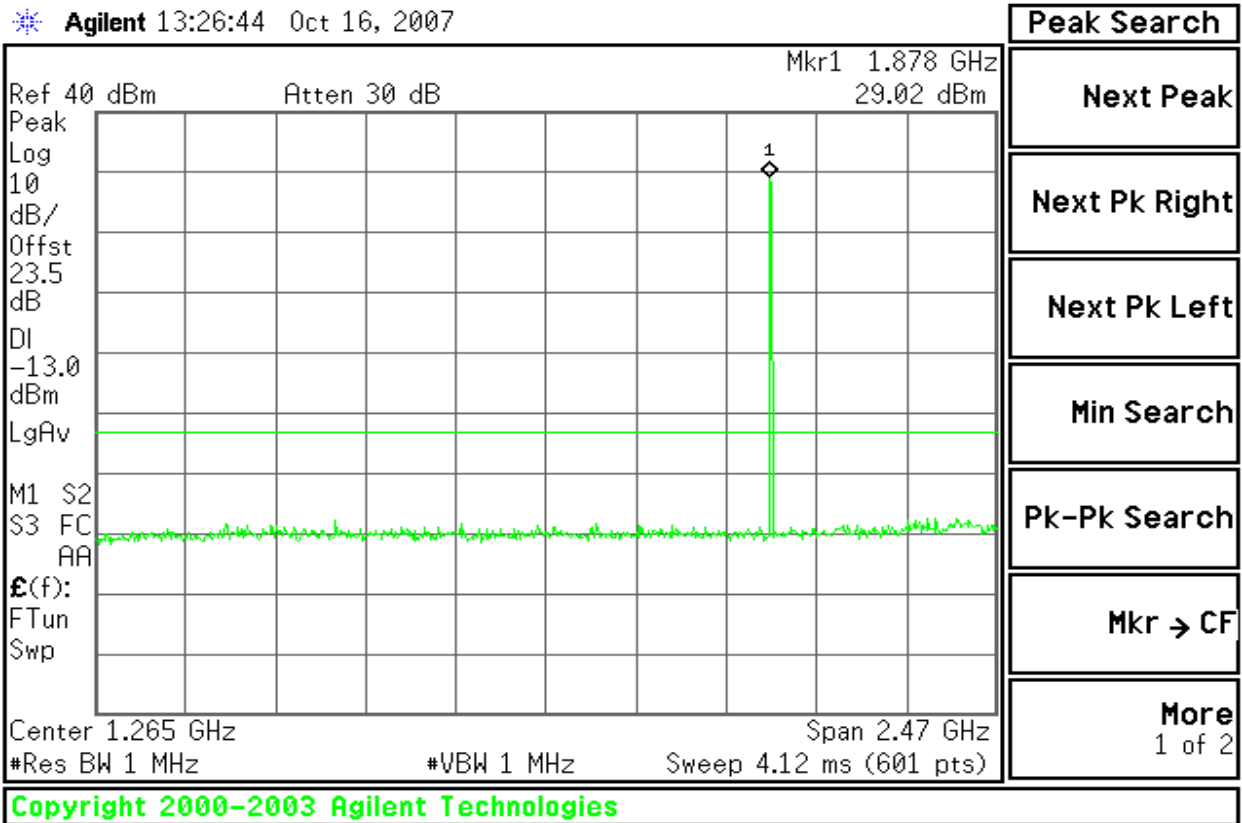


Figure 8-4: Out of Band emission at antenna terminals – GSM CH Mid

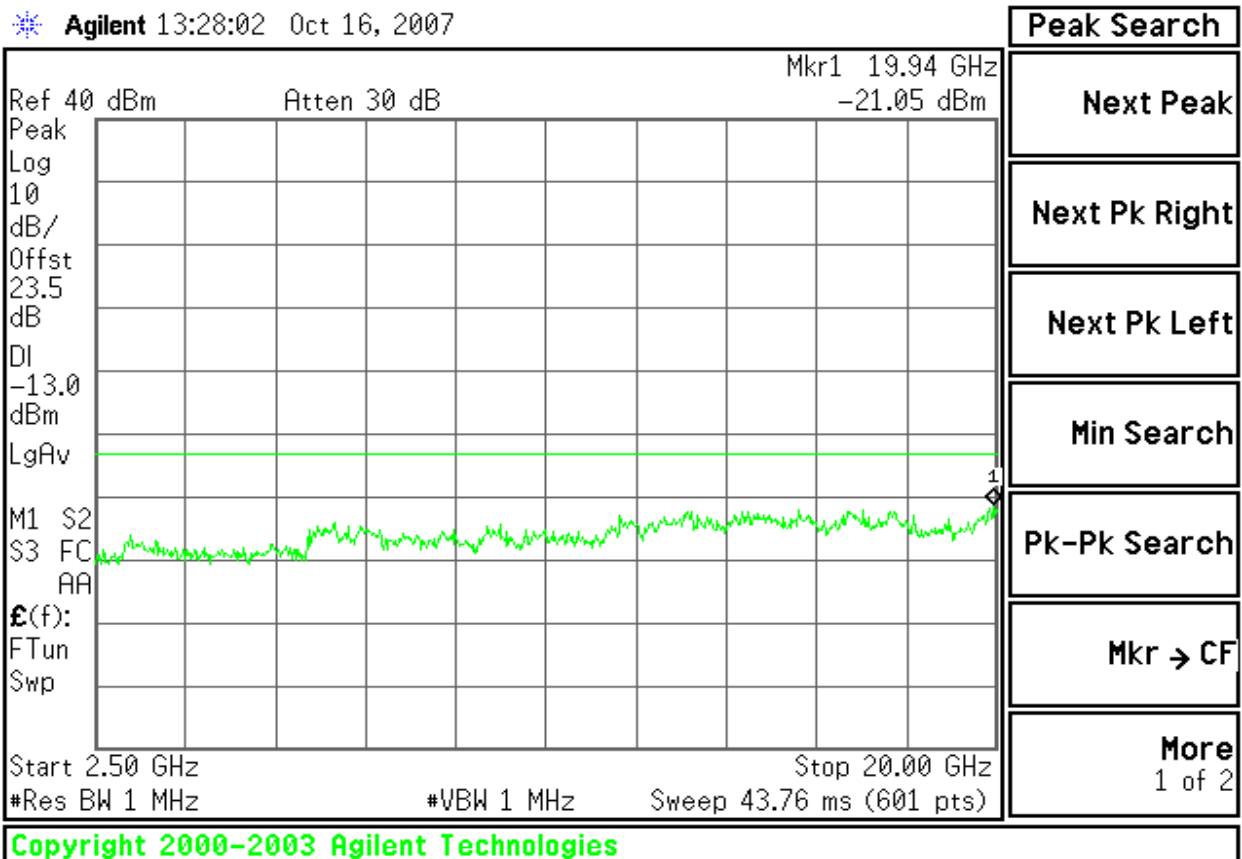


Figure 8-5: Out of Band emission at antenna terminals – GSM CH High

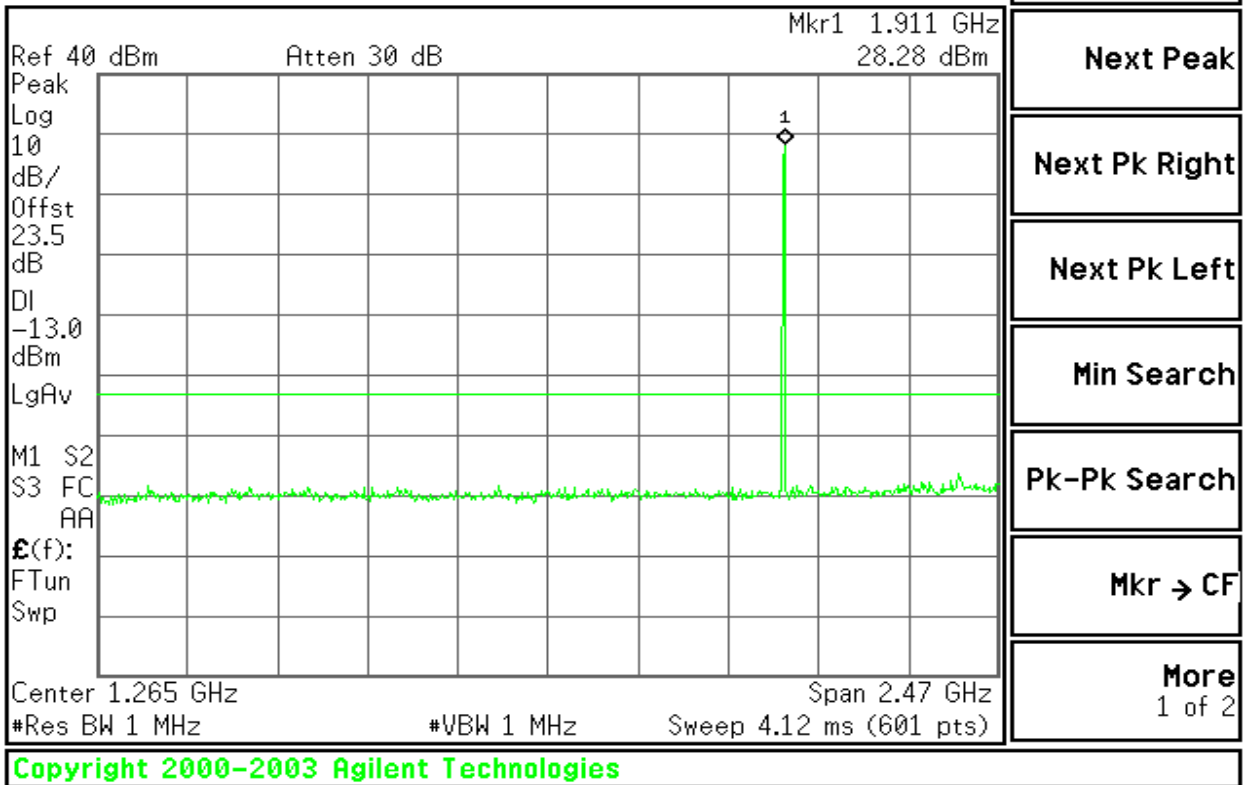
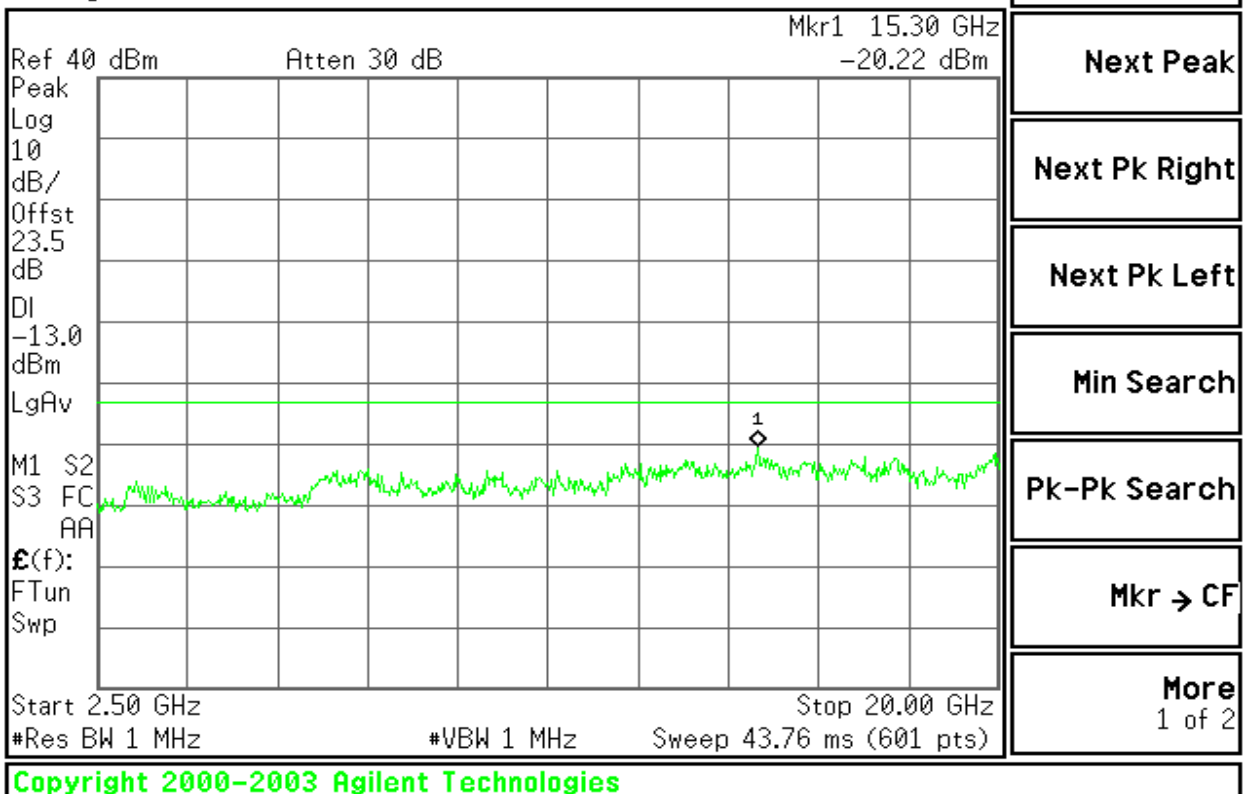


Figure 8-6: Out of Band emission at antenna terminals – GSM CH High

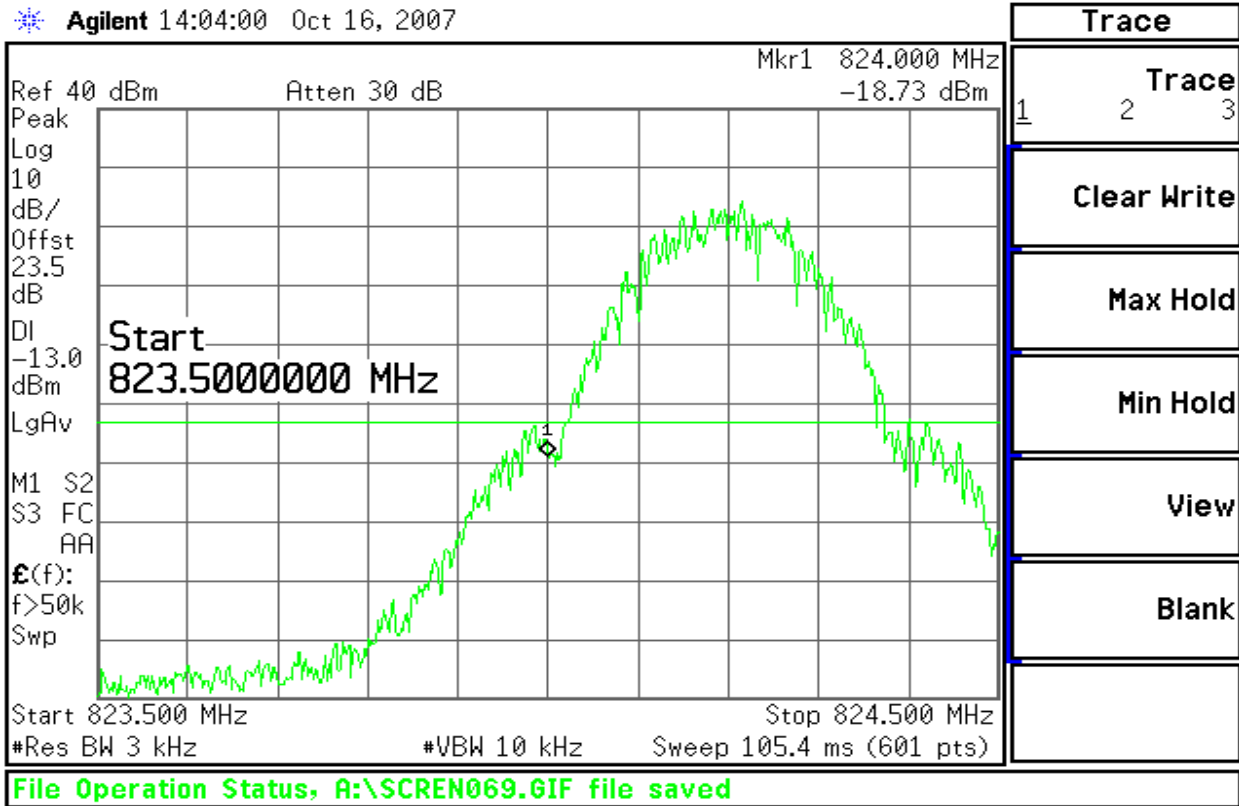
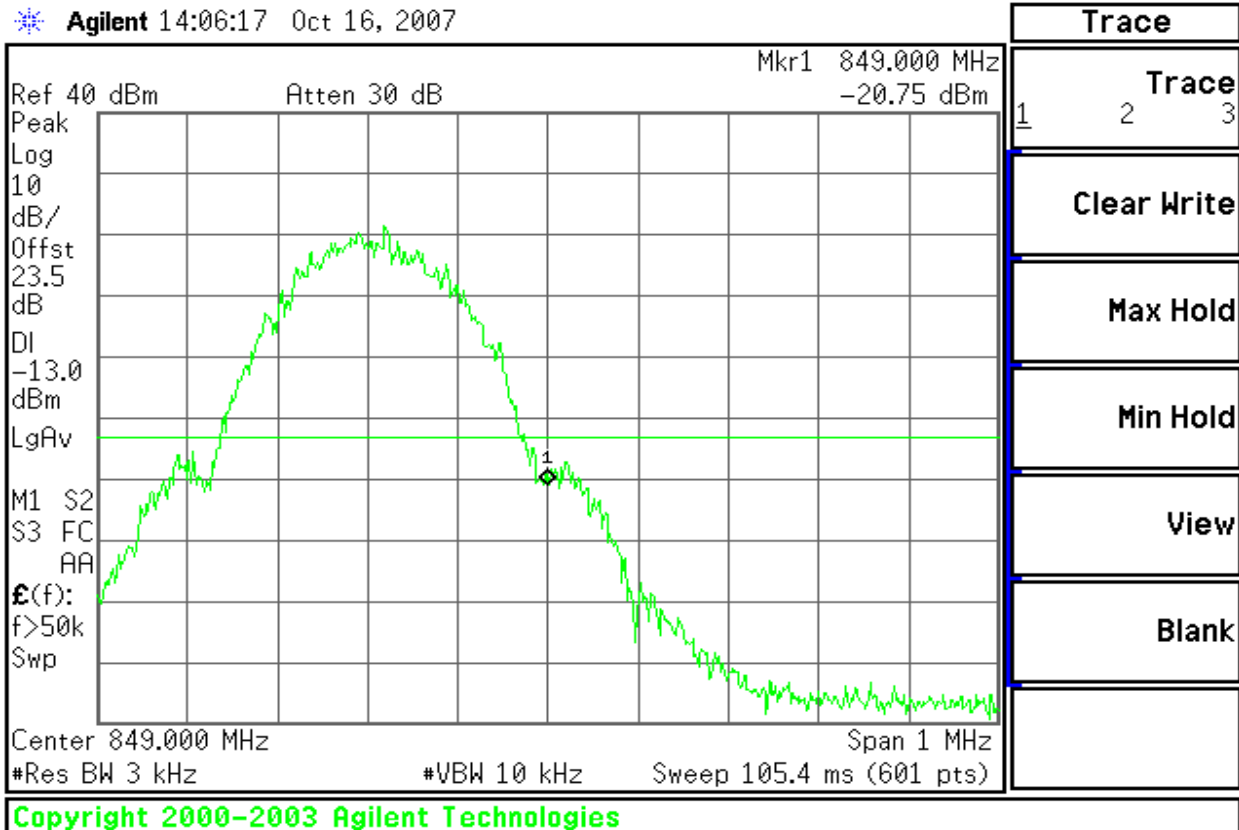


Figure 9-2: Band Edge emissions – GSM CH High

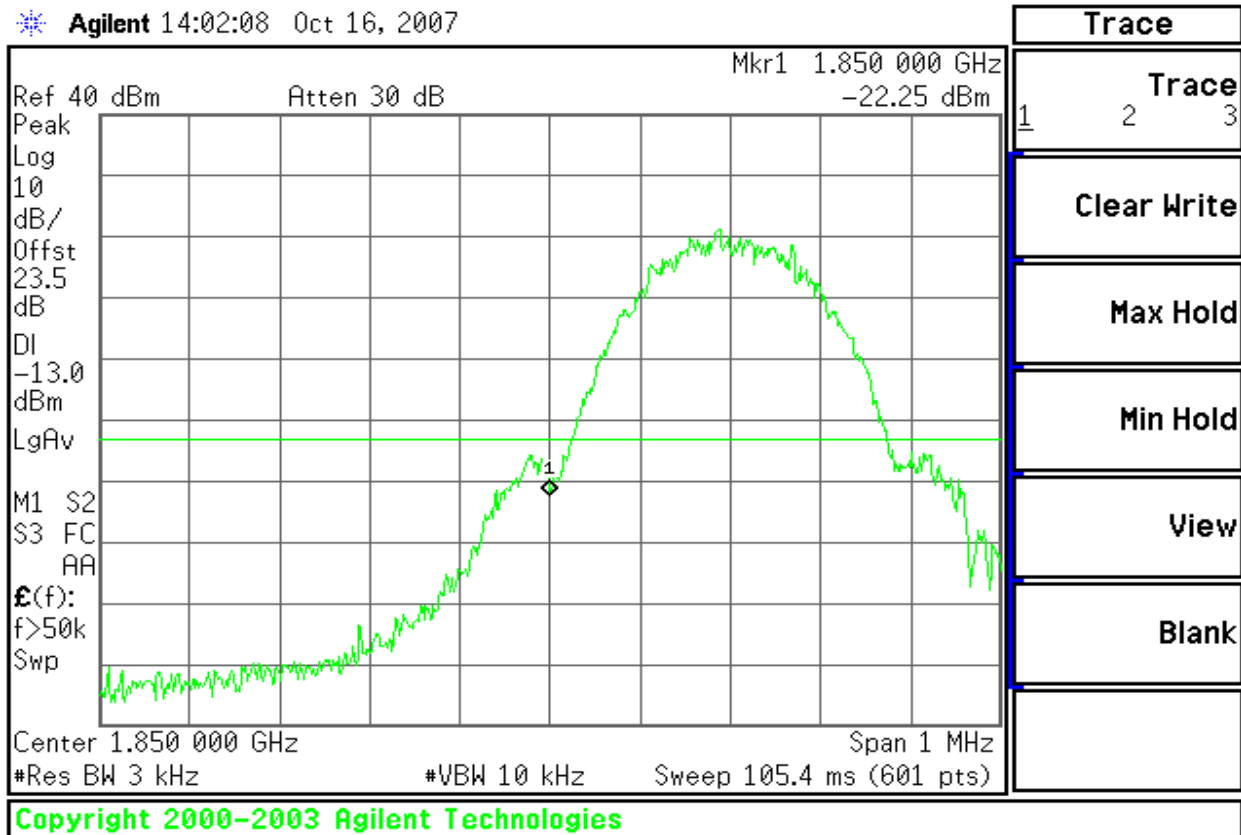
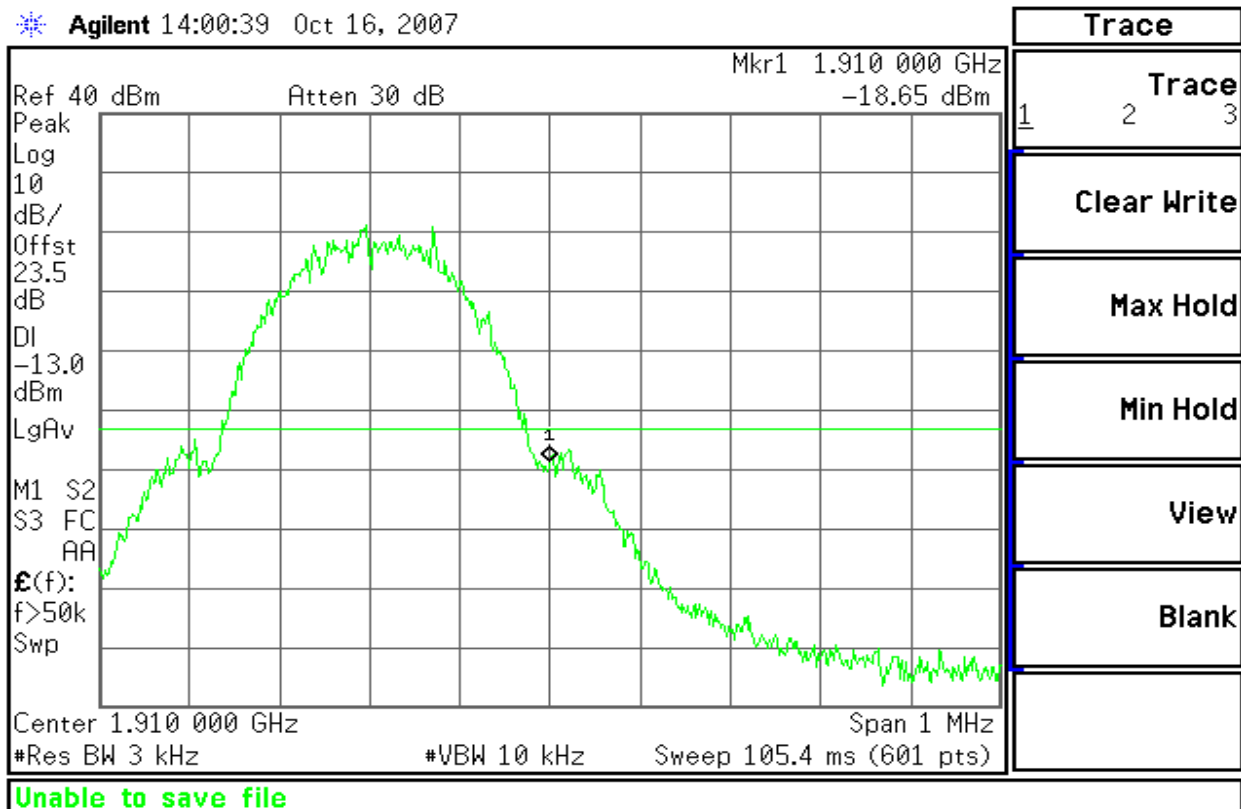


Figure 10-2: Band Edge emissions – GSM CH High

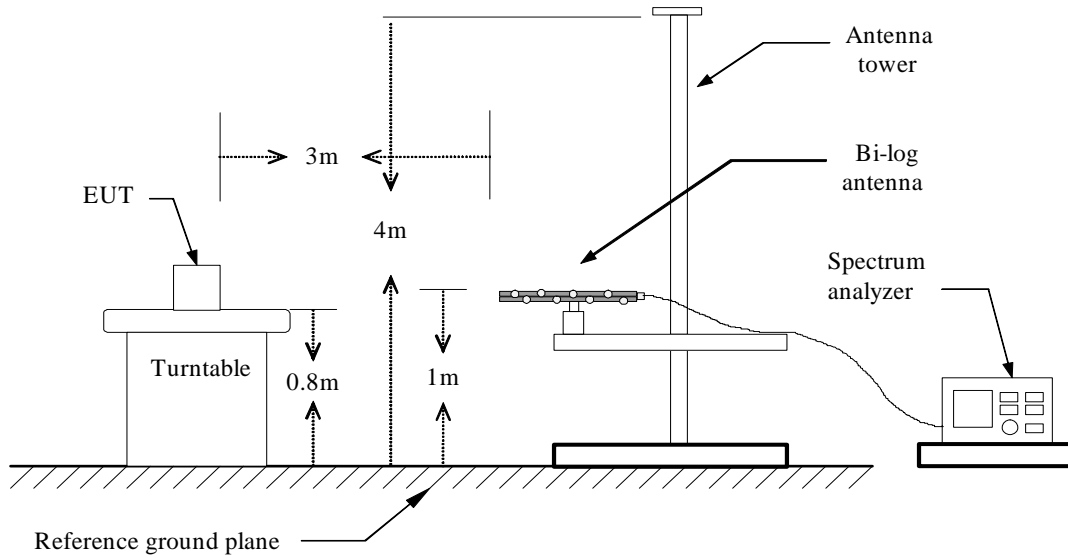

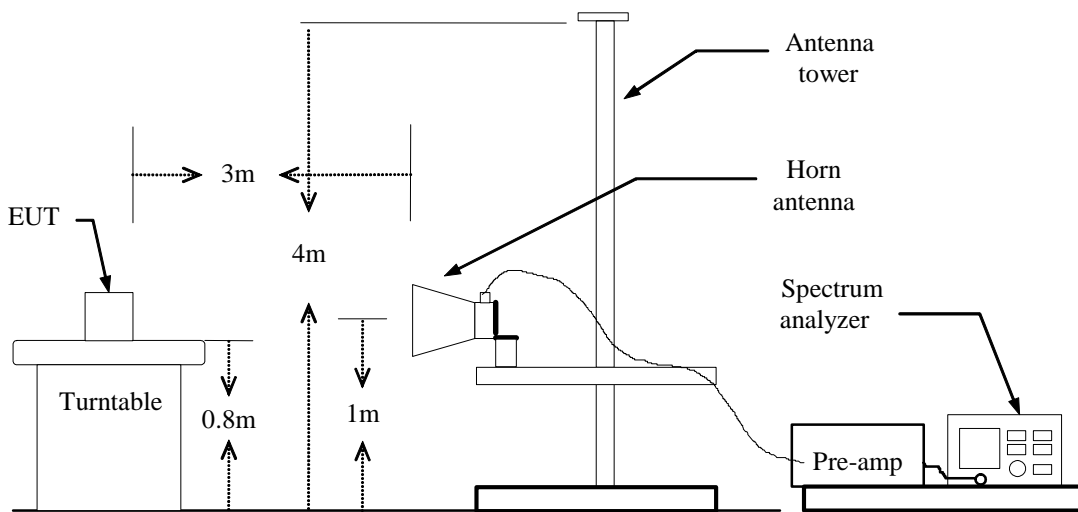

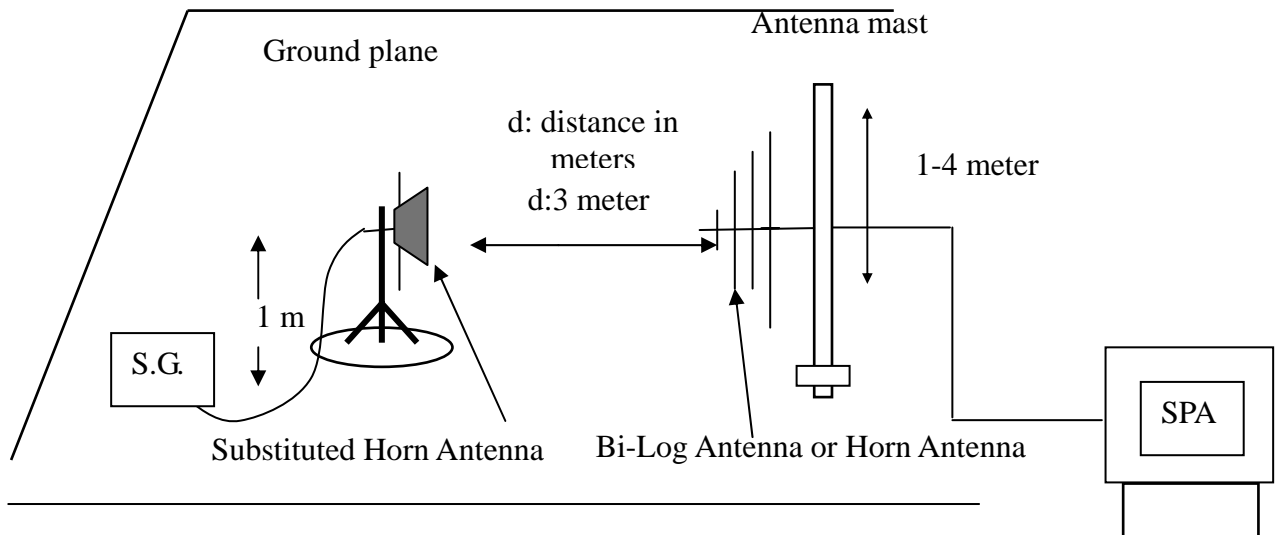

TEST PROCEDURE

The EUT was placed on a non-conductive, the measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.

The frequency range up to tenth harmonic was investigated for each of three fundamental frequency (low, middle and high channels). Once spurious emission were identified, the power of the emission was determined using the substitution method.

The spurious emissions attenuation was calculated as the difference between radiated power at the fundamental frequency and the spurious emissions frequency.

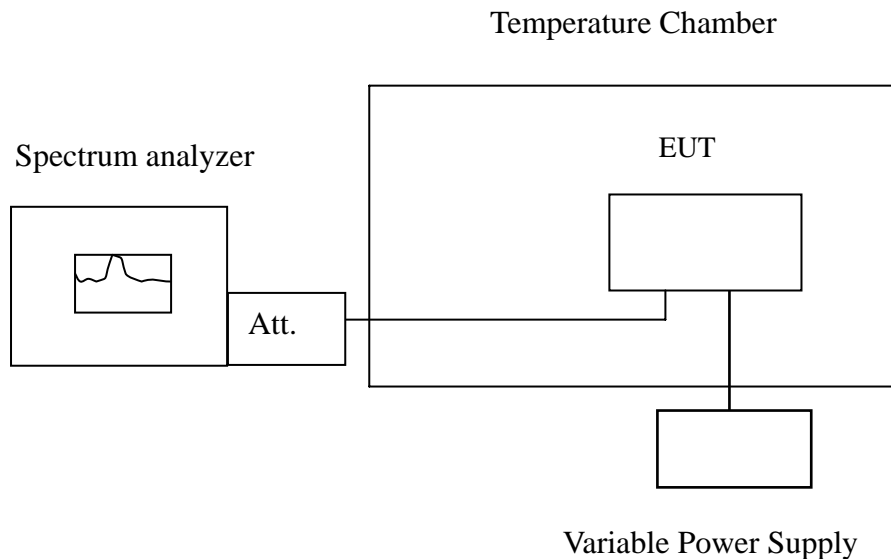

TEST PROCEDURE

The equipment under test was connected to an external AC or DC power supply and input rated voltage. RF output was connected to a frequency counter or spectrum analyzer via feed through attenuators. 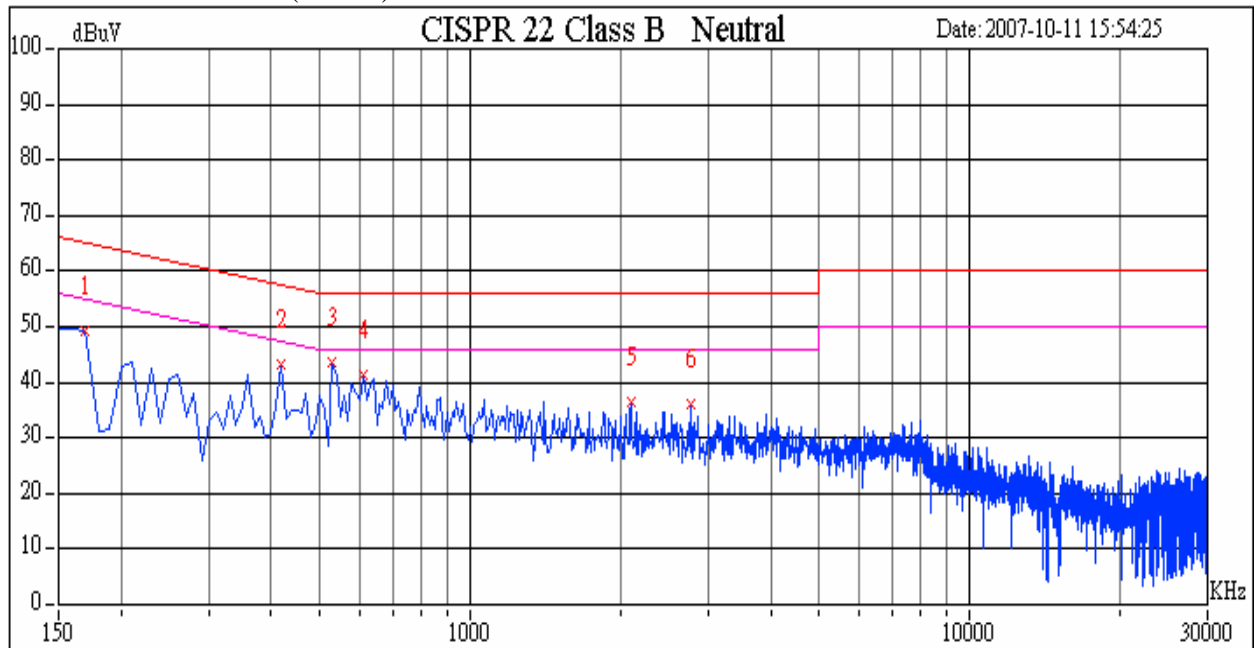

Conducted emissions (Line 1)



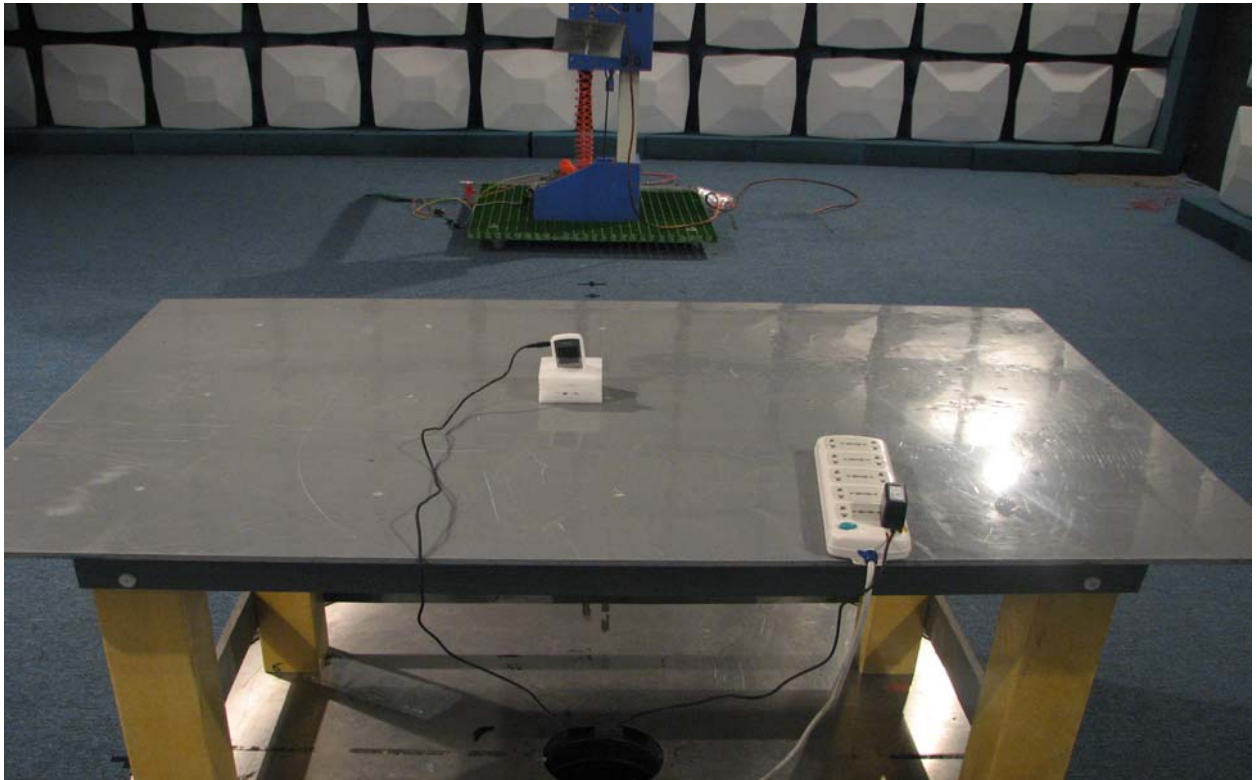

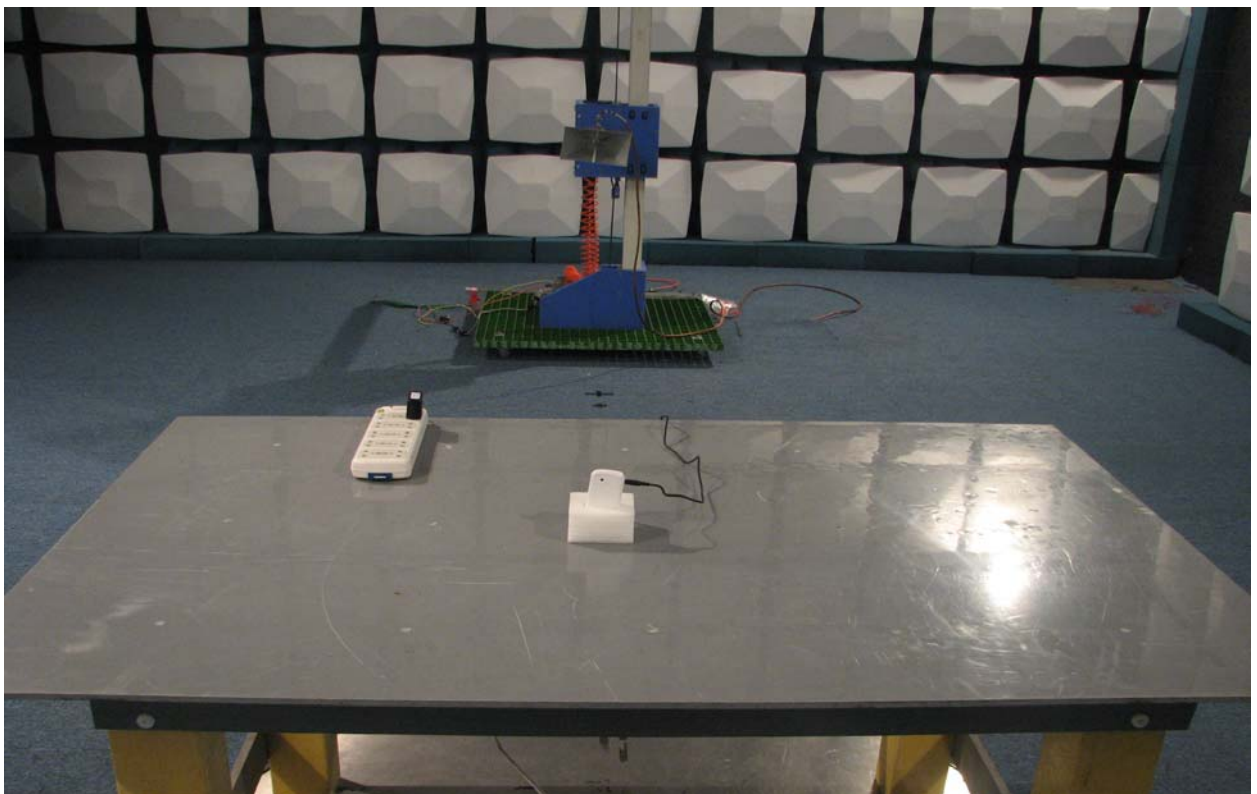
