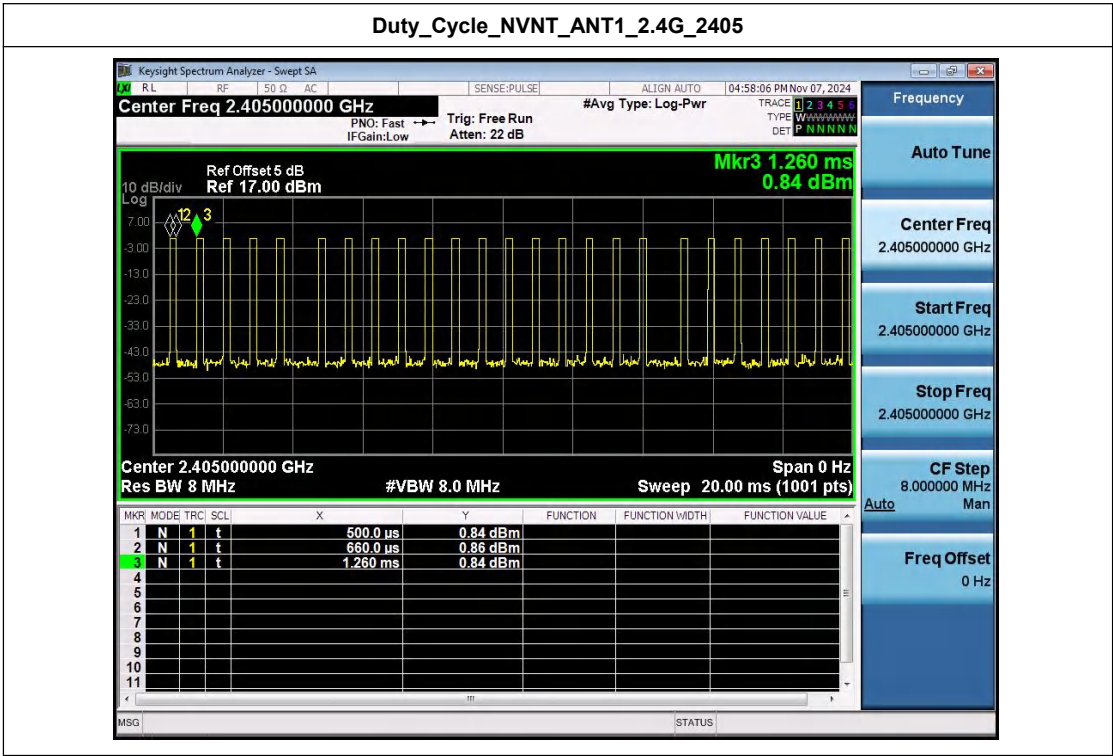

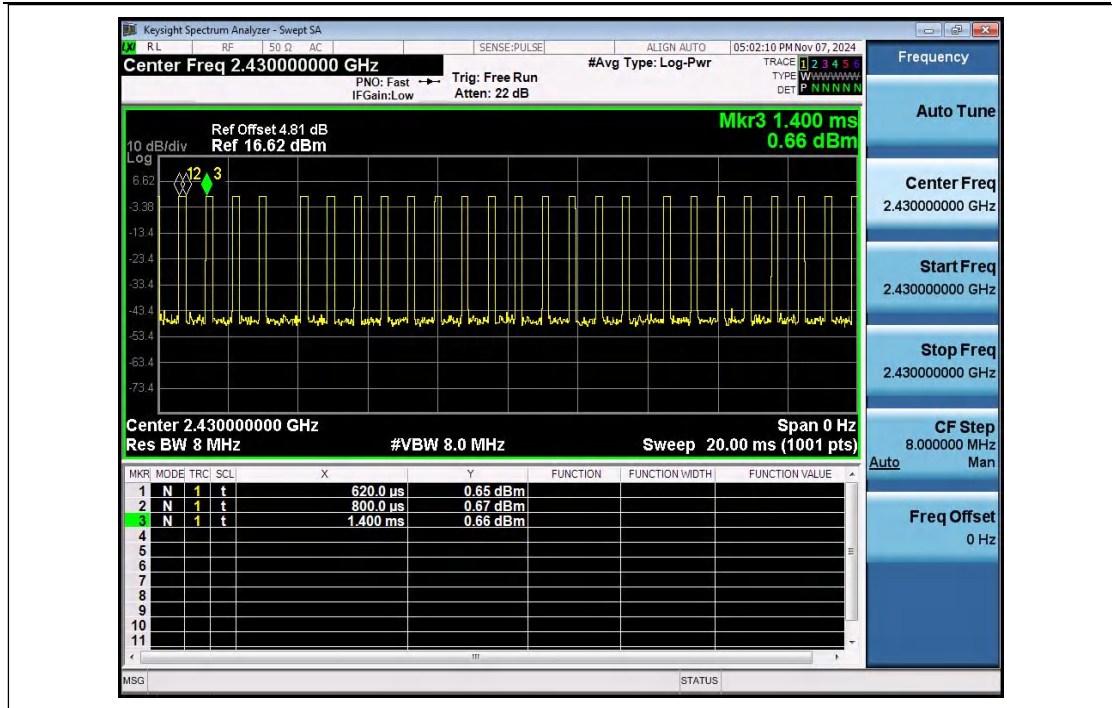

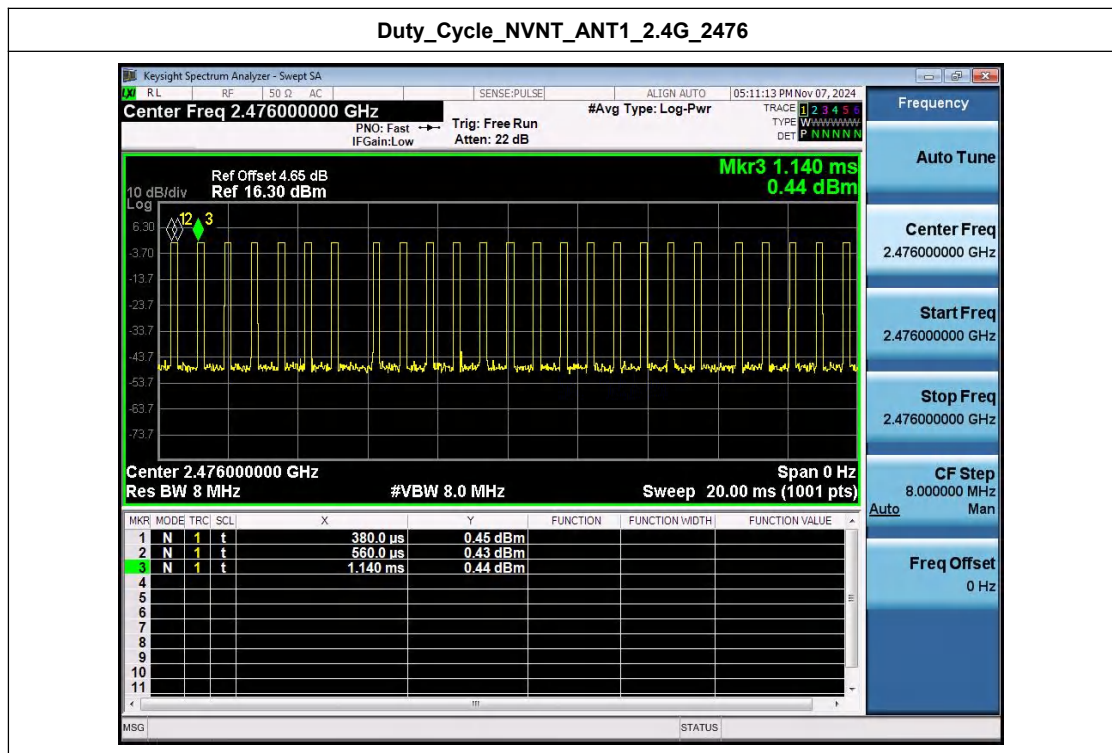


Duty_Cycle_NVNT_ANT1_2.4G_2430



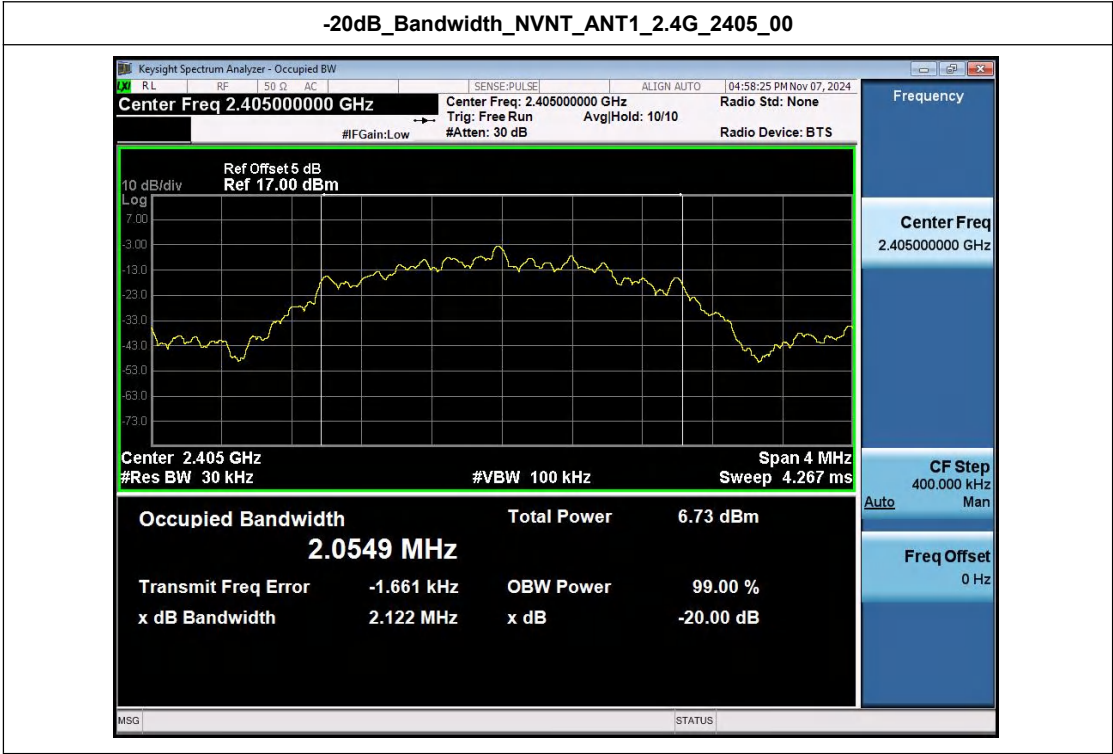

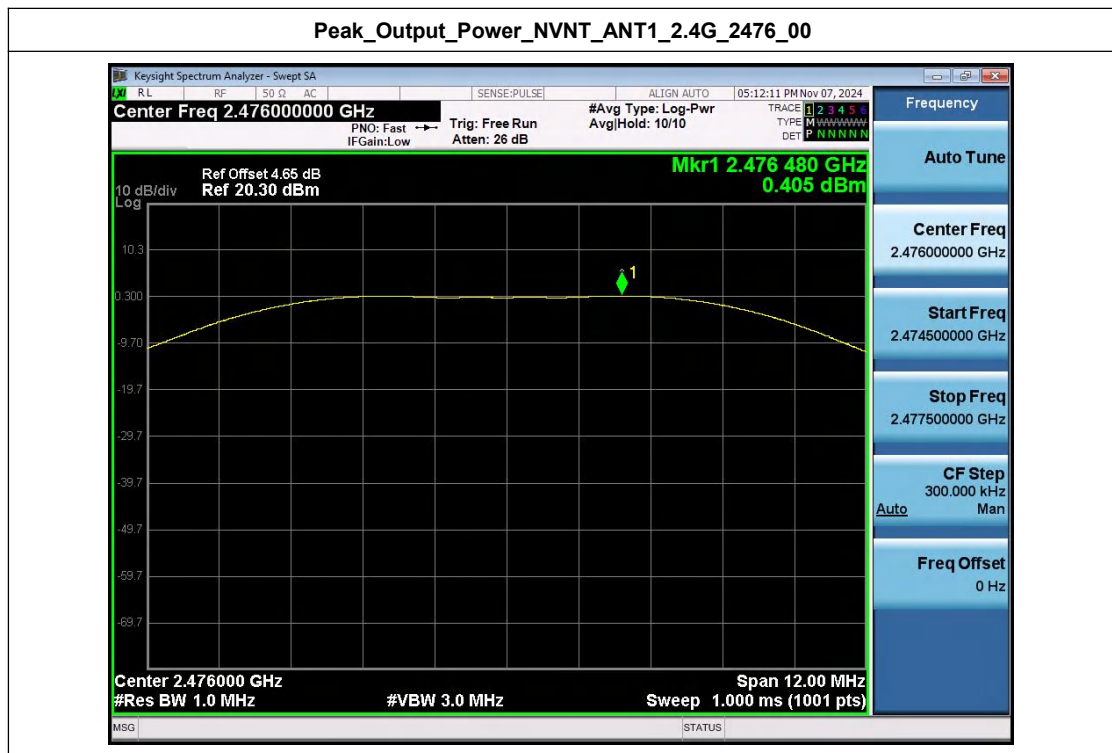
