**Band12-1.4MHz-QPSK-23173-1RB#0**

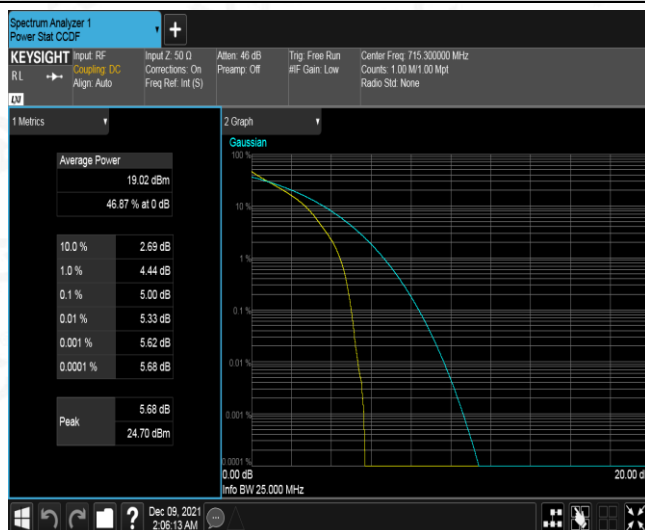
