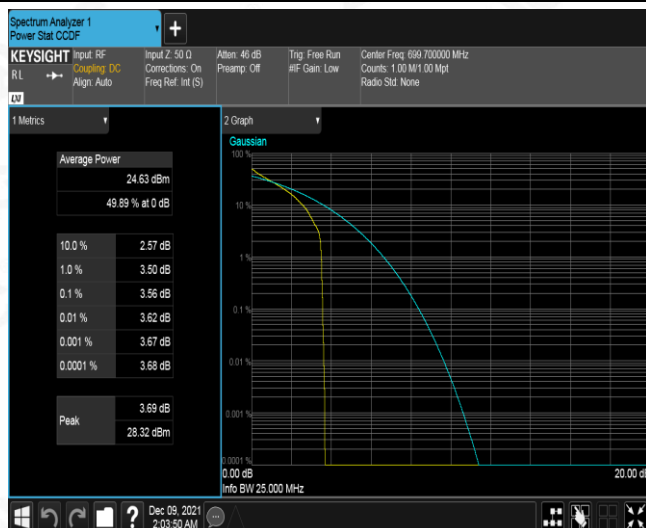

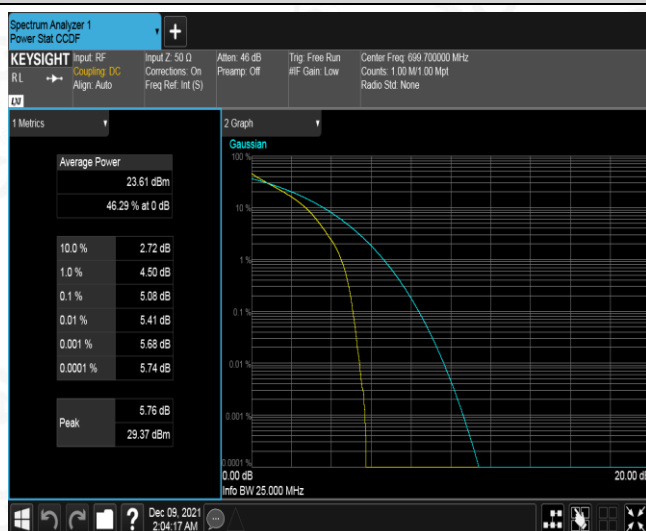

Band12-1.4MHz-QPSK-23017-6RB#0

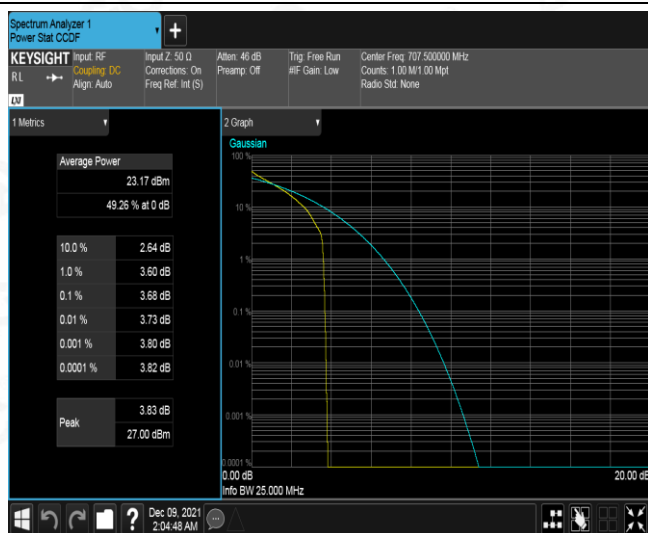


Band12-1.4MHz-QPSK-23095-1RB#0

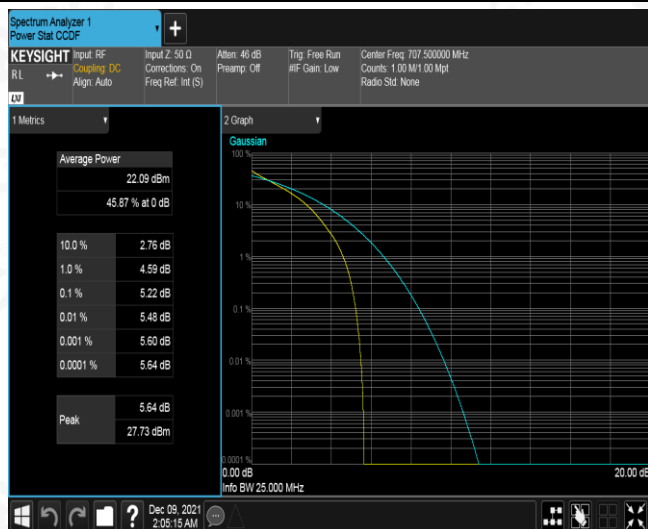

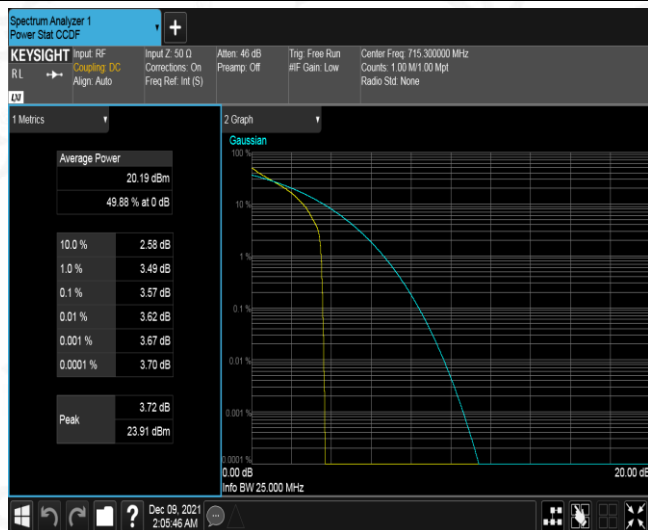




Band12-1.4MHz-QPSK-23095-6RB#0

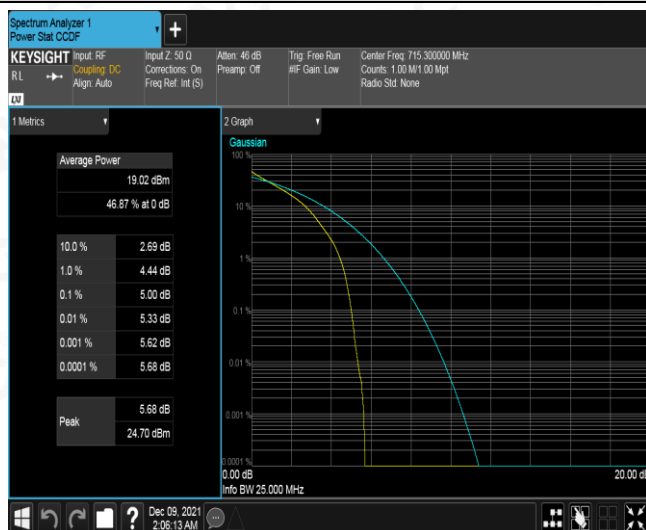

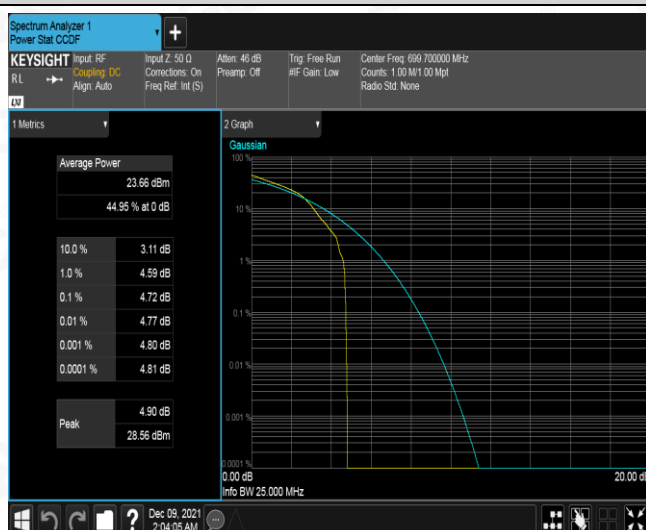

Band12-1.4MHz-16QAM-23017-1RB#0

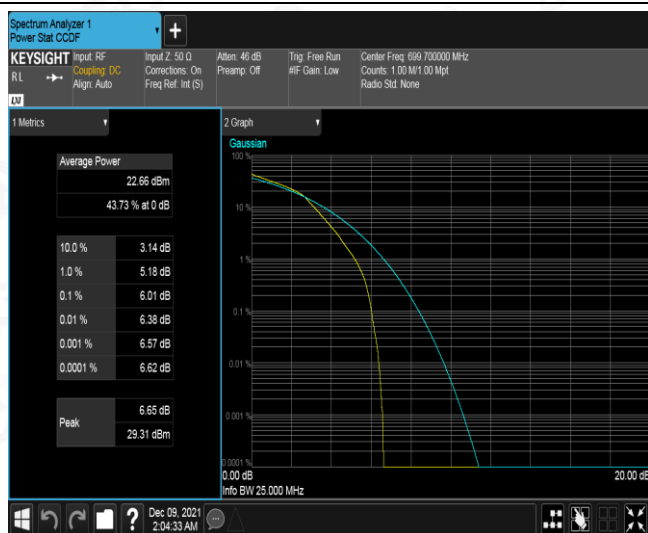
