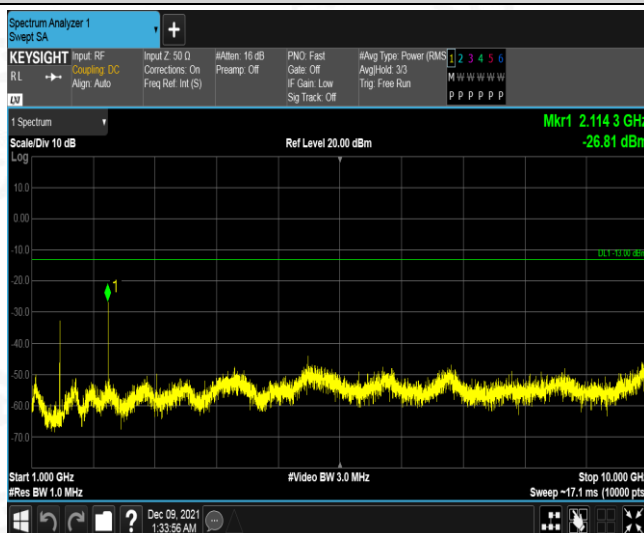

Band17-5MHz-16QAM-23825-1RB#0-Range2:1000~10000MHz

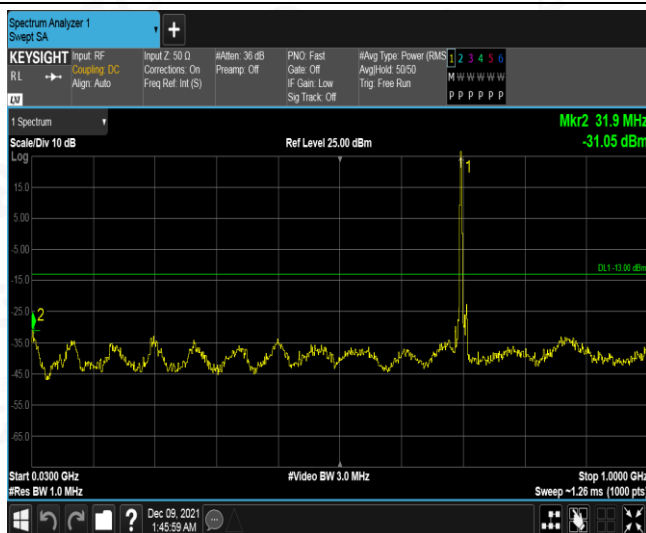

Band17-10MHz-16QAM-23790-1RB#0-Range2:1000~10000MHz

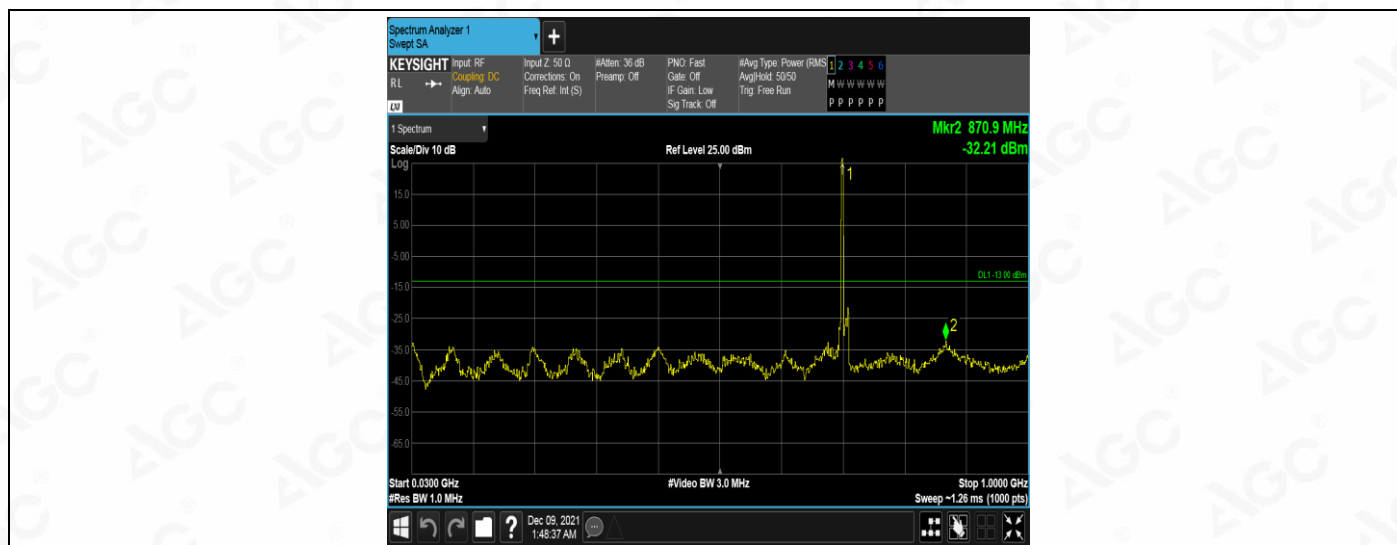

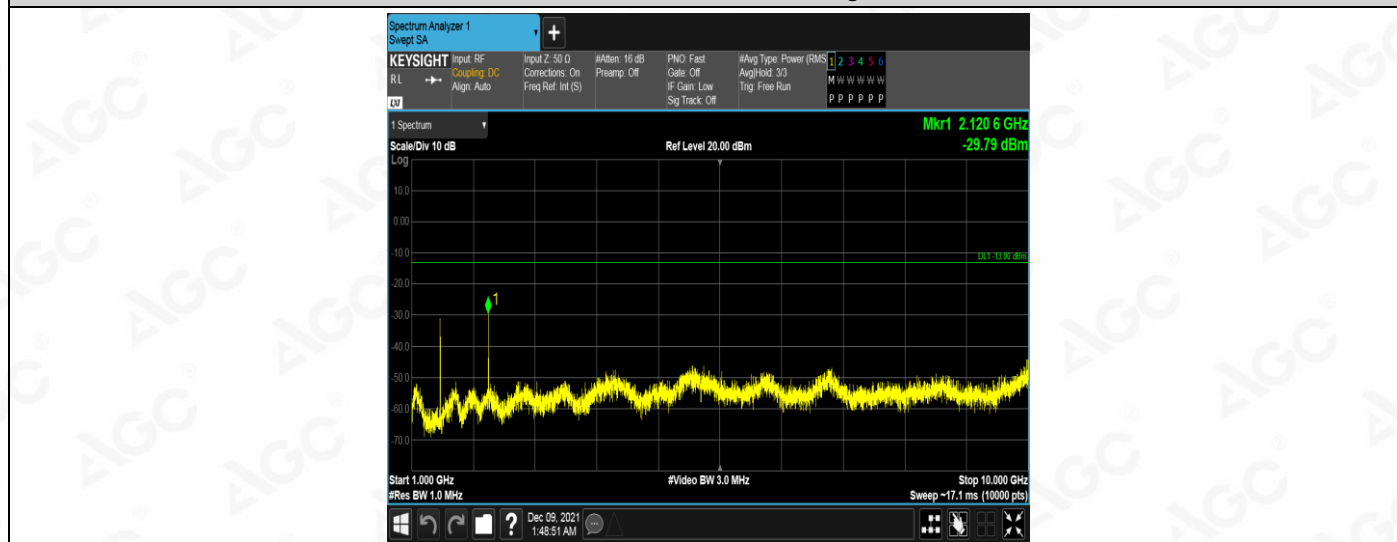
