

Photograph of the tissue simulant fluid liquid depth (Body)






Fig.2.1 Fig.2.2






Fig.3 EUT Back side_Main to flat phantom






Fig.5 EUT Top side to flat phantom



Body - distance between flat phantom and EUT is 0 mm






Fig.6 EUT Bottom side to flat phantom






Fig.7 EUT Right side to flat phantom






Fig.8 EUT Left side to flat phantom




Fig.11 Antenna location
