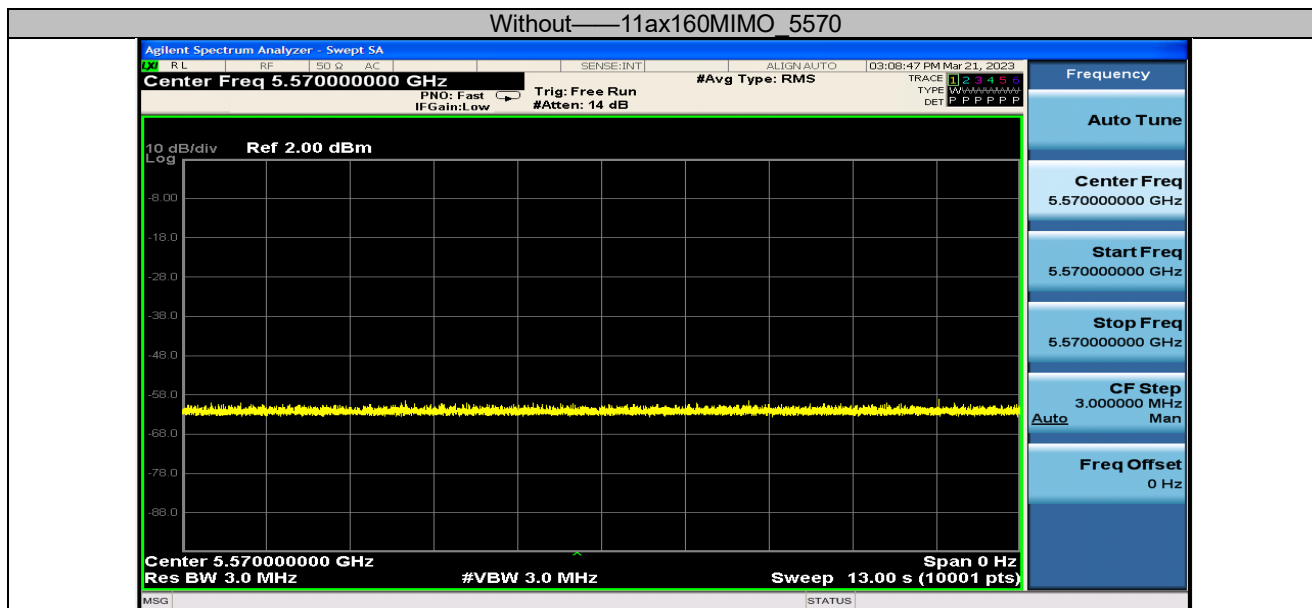
Data Traffic Plot Test Graphs
