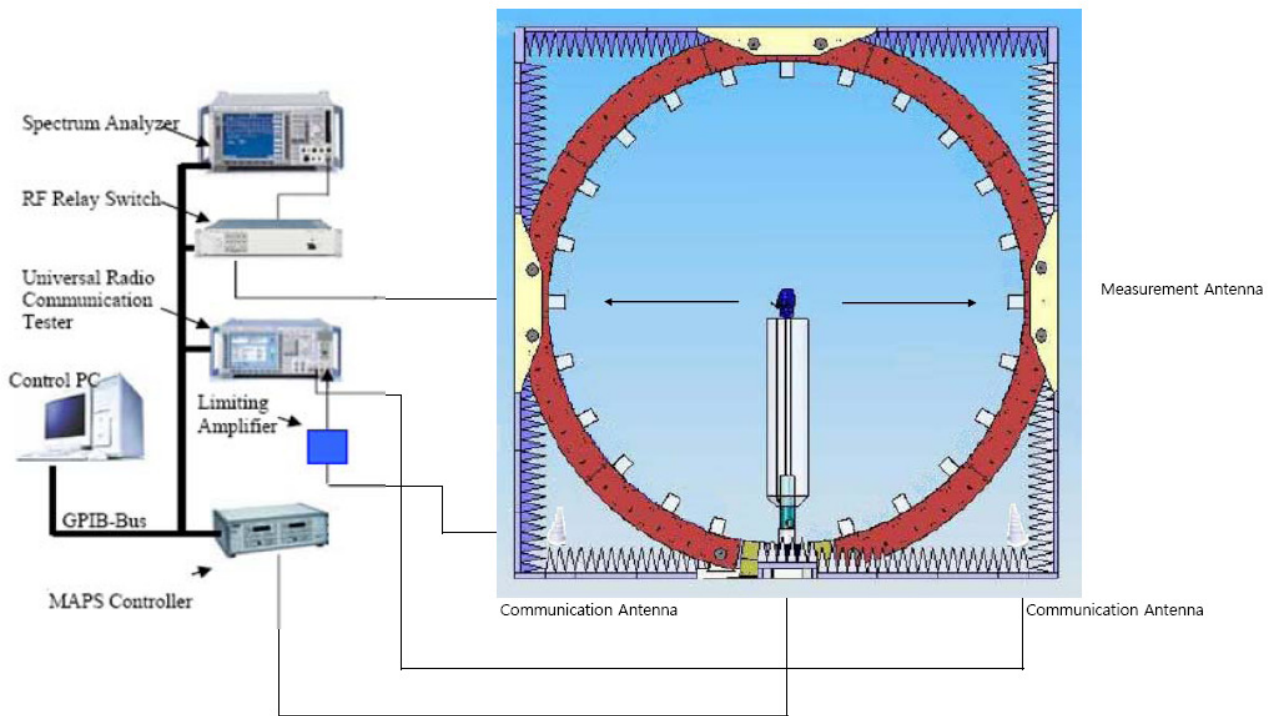

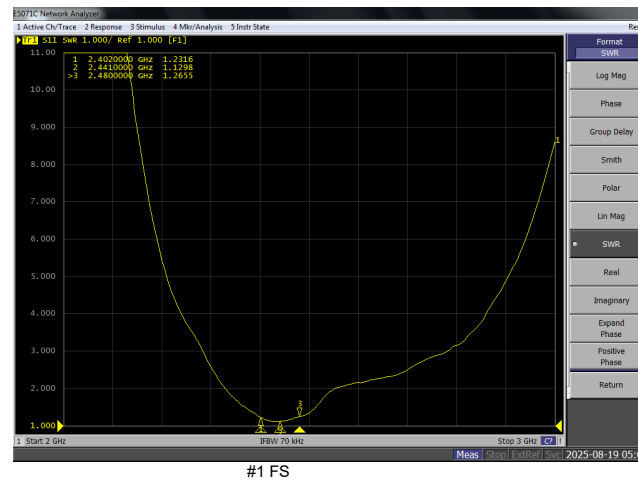

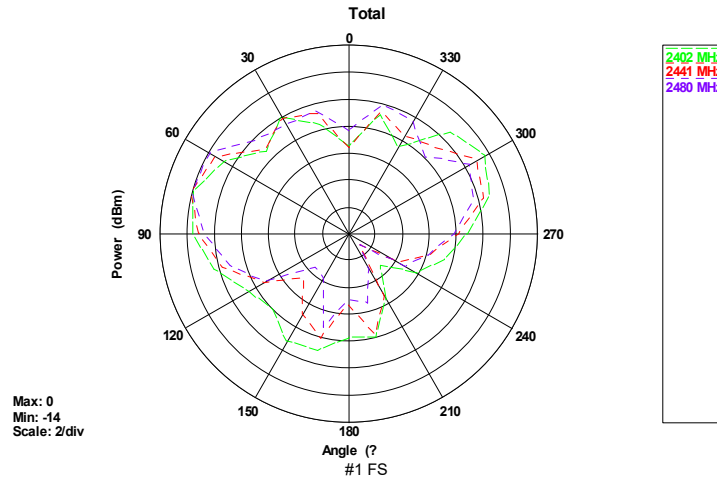

7 2-D Antenna Pattern

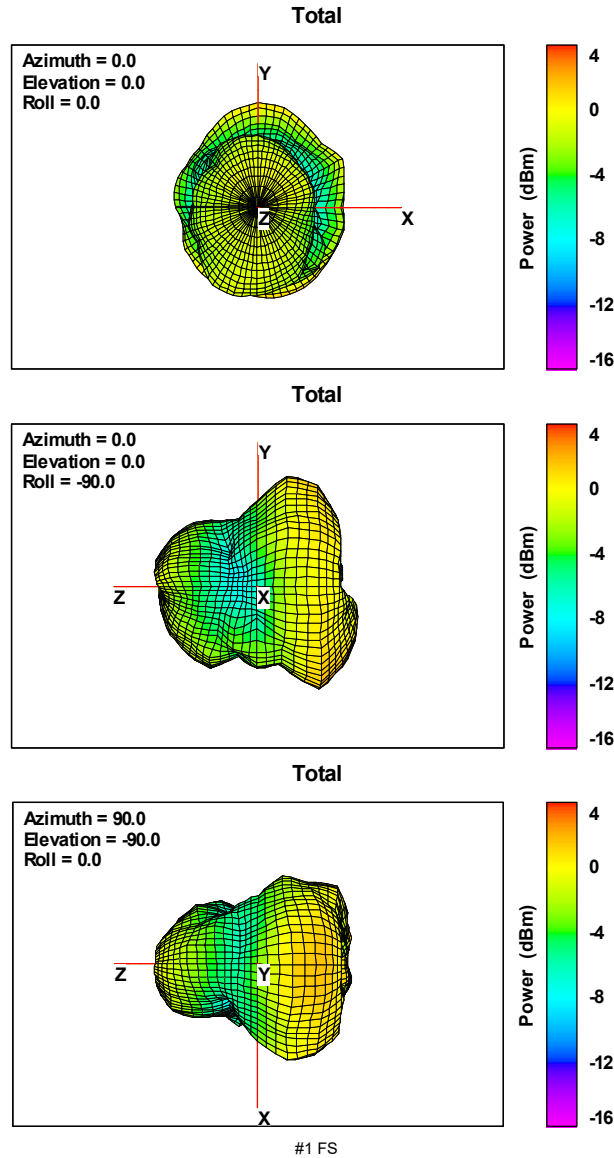

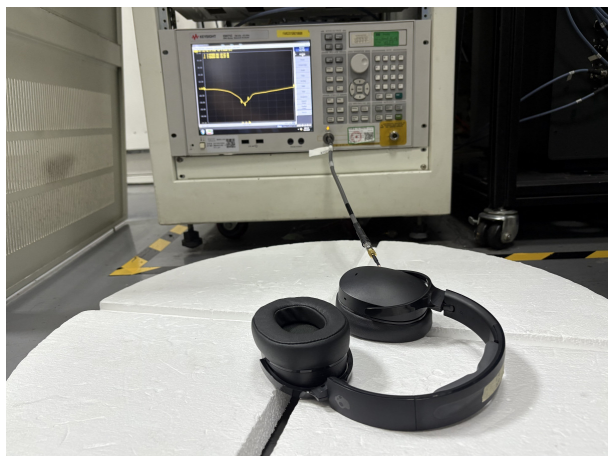
