Description of EUT Operation:

The Equipment Under Test (EUT) is a MAC DUE INTERNATIONAL LTD. of Radio Control toy. It is 2 buttons, 1 switch and 1 marble transmitter and operating at 27.145MHz. The EUT continues to transmit while buttons are being pressed, Modulation by IC, and type is pulse modulation.

The transmitter has different control:

1. Left button – Forward control
2. Right button – Backward control
3. ON/OFF switch – ON/OFF control
4. Marble – Left or Right control

Antenna Requirement (Section 15.203)

The EUT is use of a permanently antenna. The antenna consists of 19cm long metal spring covered with rubber. The antenna is not replaceable or user serviceable. The requirements of S15.203 are met. Test Procedure:


Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 – 2003.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, For battery operated equipment, the equipment tests shall be perform using new battery. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

For below 30MHz, a loop antenna with its vertical plane is place 3m from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. And the centre of the loop shall be 1m above the ground.



Duty Cycle Correction During 100msec:

Each function key sends a different series of characters, but each packet period (18.7 msec) never exceeds a series of 4 long (1.6msec) and 10 short (0.5msec) pulses. Assuming any combination of short and long pulses maybe obtained due to encoding the worst case transmit duty cycle would be considered (4x1.6msec)+(10x0.5msec) per 18.7msec = 61.0% duty cycle. Figure A through C shows the characteristics of the pulse train for one of these functions.


Duty Cycle Correction = $20\log(0.61) = -4.3\text{dB}$






Front View of the product




Rear View of the product


