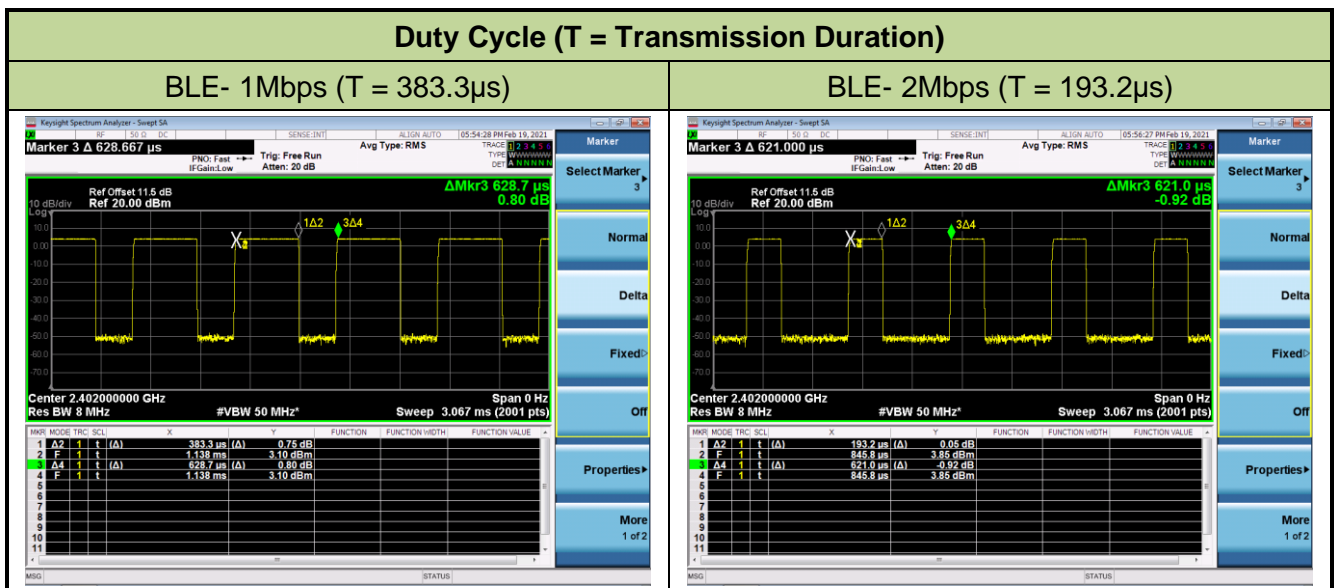

## 2.5. Duty Cycle

The maximum achievable duty cycles was determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz. The RBW and VBW were both greater than 50/T, where T is the minimum transmission duration, and the number of sweep points across T was greater than 100. The duty cycles are as follows:

Test Mode	Duty Cycle
BLE- 1Mbps	60.97%
BLE- 2Mbps	31.11%



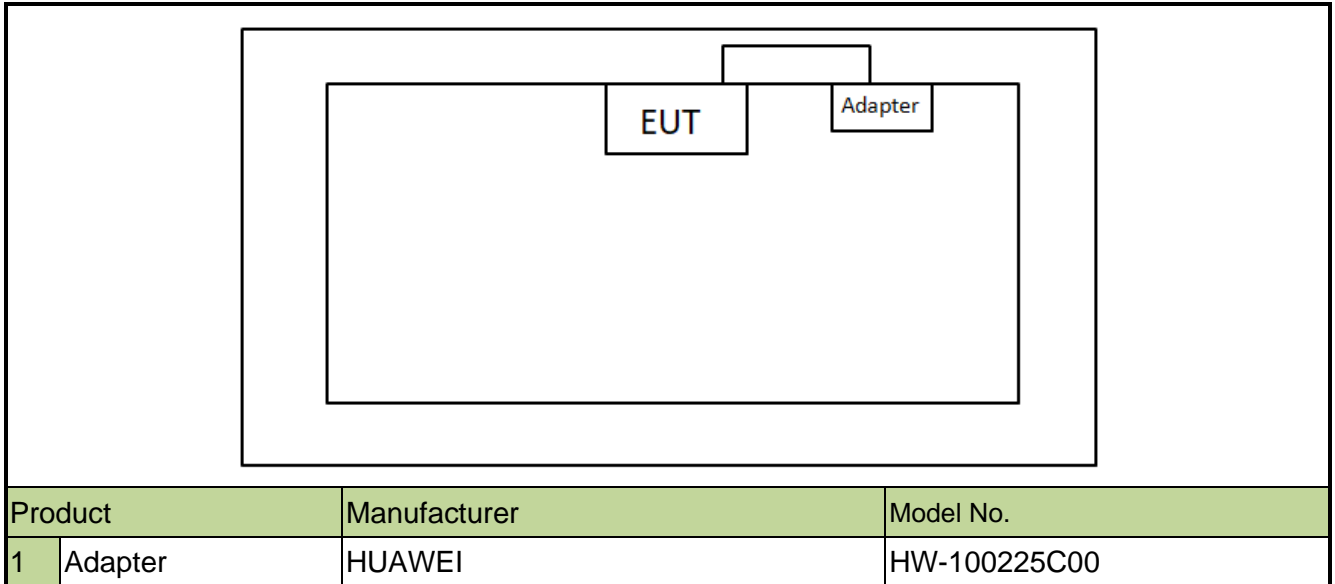
## 2.6. EMI Suppression Device(s)/Modifications

- 1) All modes of operation and data rates were investigated. For radiated emission test, every axis (X, Y, Z) was also verified. The test results shown in the following sections represent the worst-case emissions.
- 2) The analyzer plots shown in this section were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables and attenuators used as part of the system to connect the EUT to the analyzer at all frequencies of interest.

## 6.2. Occupied Bandwidth Measurement

### 6.2.1. Test Limit

The minimum 6dB bandwidth shall be at least 500 kHz.

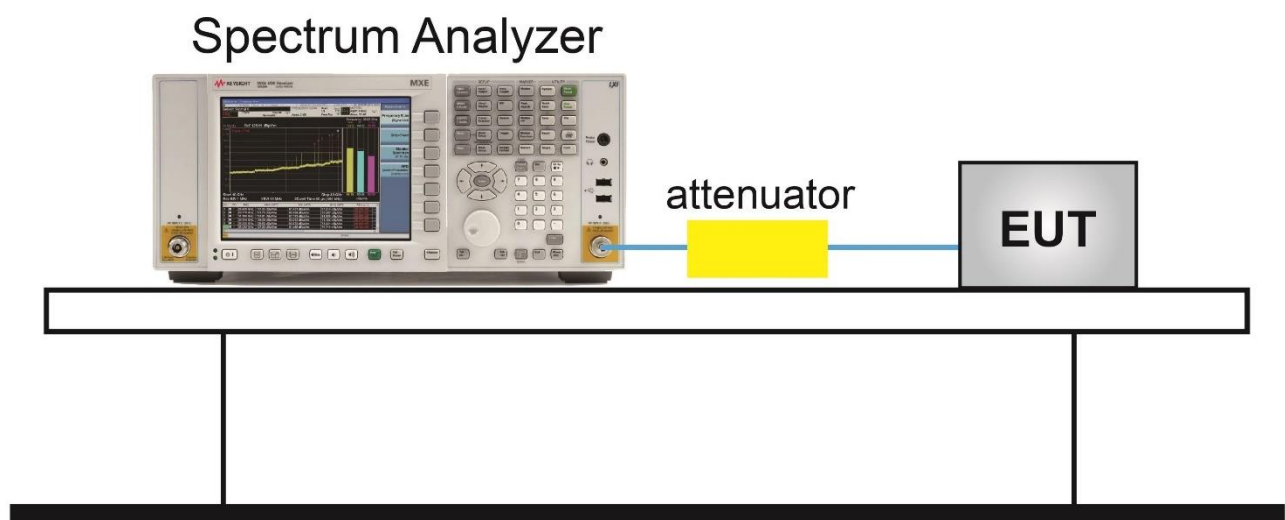
### 6.2.2. Test Procedure used

ANSI C63.10-2013 - Section 11.8

### 6.2.3. Test Setting

1. The Spectrum's automatic bandwidth measurement capability was used to perform the 6dB bandwidth measurement. The "X" dB bandwidth parameter was set to  $X = 6$ . The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
2. Set RBW = 100 kHz
3. VBW  $\geq 3 \times$  RBW
4. Detector = Peak
5. Trace mode = Max hold
6. Sweep = Auto couple
7. Allow the trace was allowed to stabilize

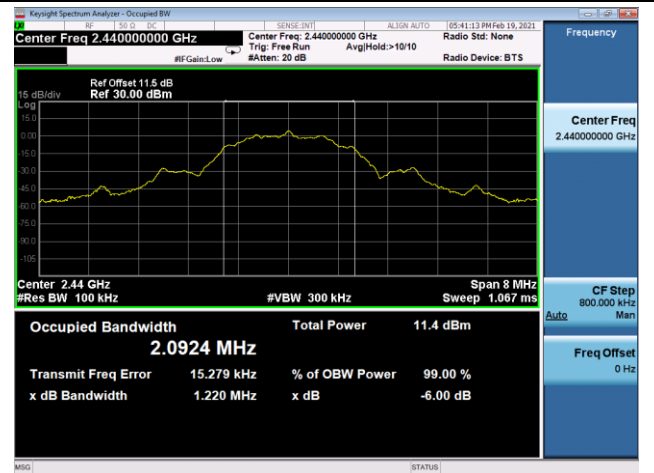


## BLE - 2Mbps

### **6.3. Output Power Measurement**

#### **6.3.1. Test Limit**

The conducted output power limit specified in paragraph FCC Part 15.247(b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs FCC Part 15.247(b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

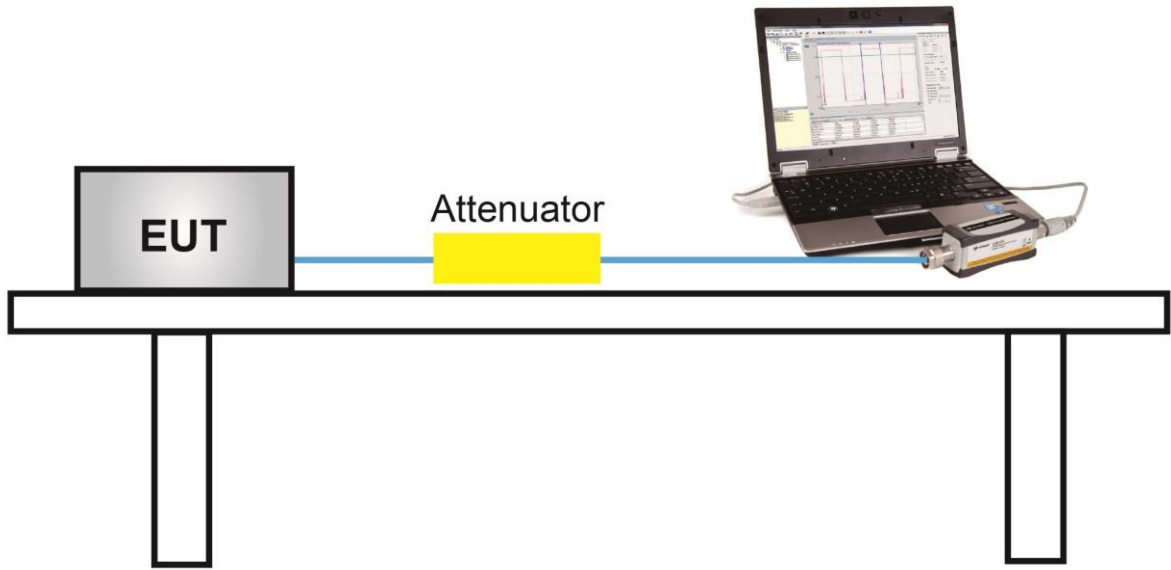
##### **Method PKPM1 (Peak Power Measurement)**

Peak power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The pulse sensor employs a VBW = 50MHz so this method was only used for signals whose DTS bandwidth was less than or equal to 50MHz.

##### **Method AVGPM-G (Measurement using a gated RF average-reading power meter)**

Measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Since this measurement is made only during the ON time of the transmitter, no duty cycle correction is required.

## 6.4. Power Spectral Density Measurement

### 6.4.1. Test Limit

The maximum permissible power spectral density is 8dBm in any 3 kHz band.

The same method of determining the conducted output power shall be used to determine the power spectral density.

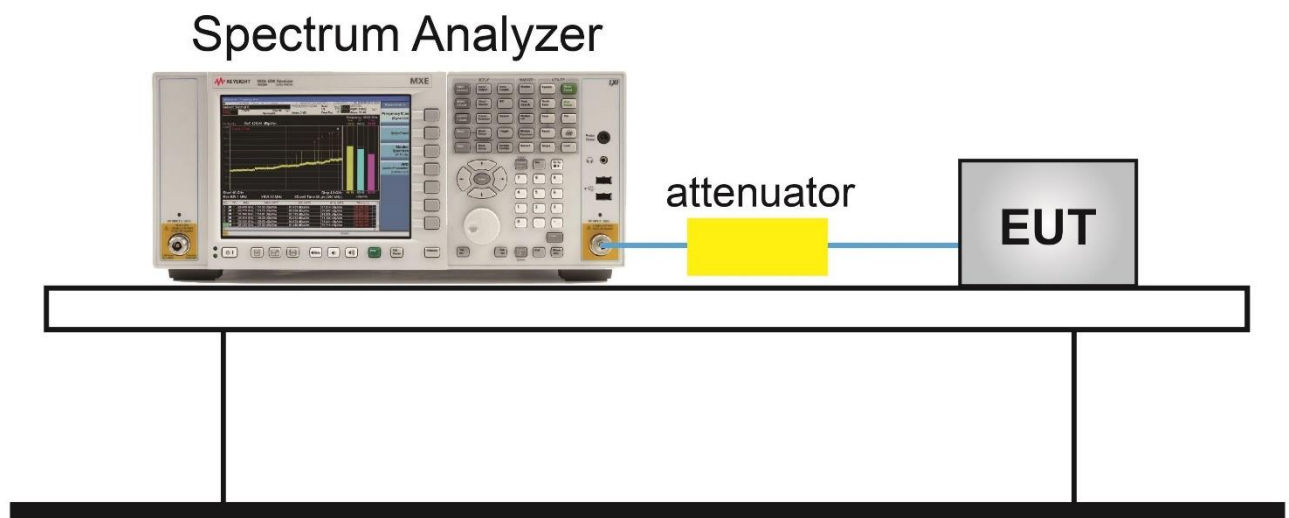

1. Analyzer was set to the center frequency of the DTS channel under investigation
2. Span = 1.5 times the DTS channel bandwidth
3. RBW = 3kHz
4. VBW = 10kHz
5. Detector = peak
6. Sweep time = auto couple
7. Trace mode = max hold
8. Trace was allowed to stabilize

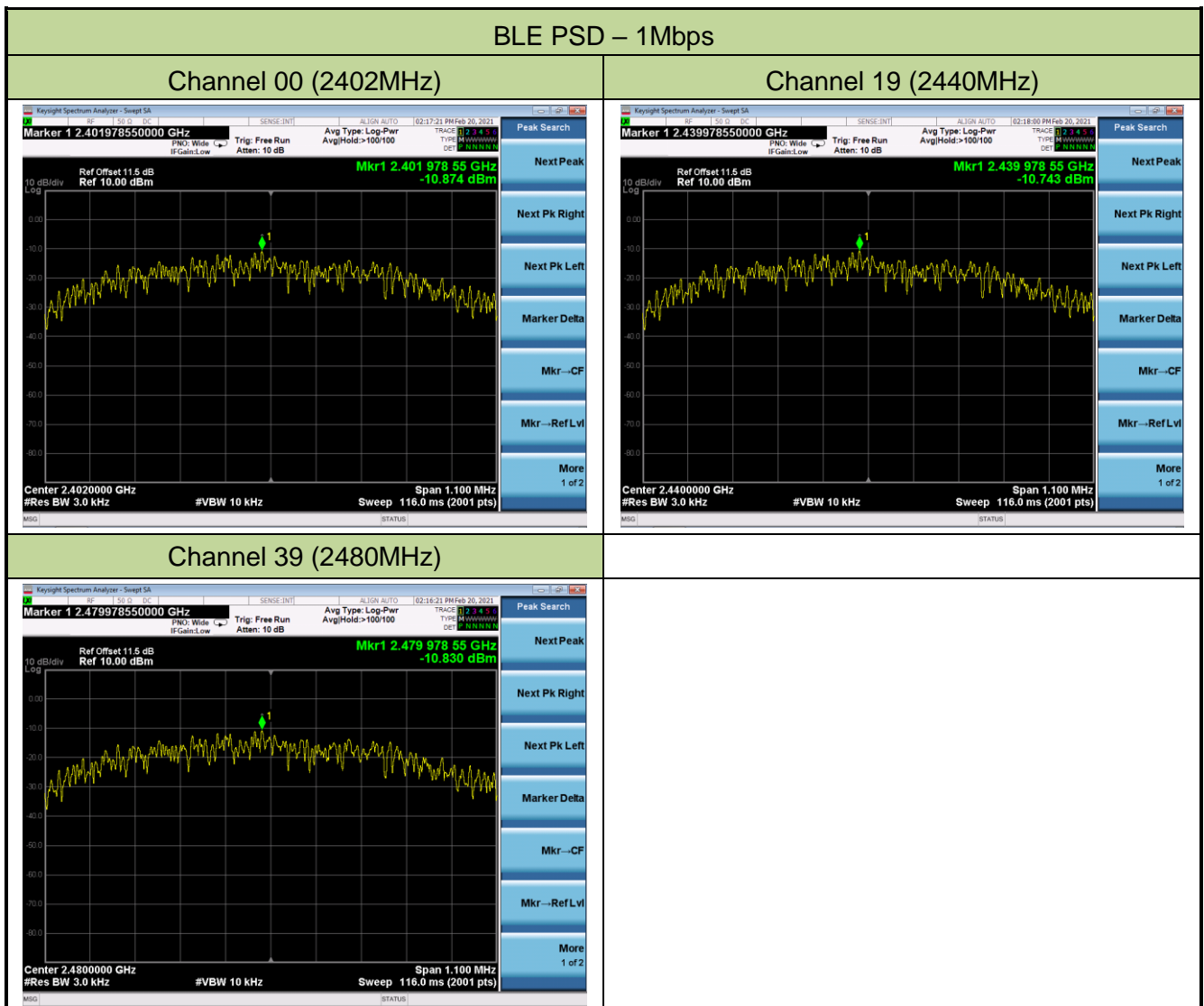

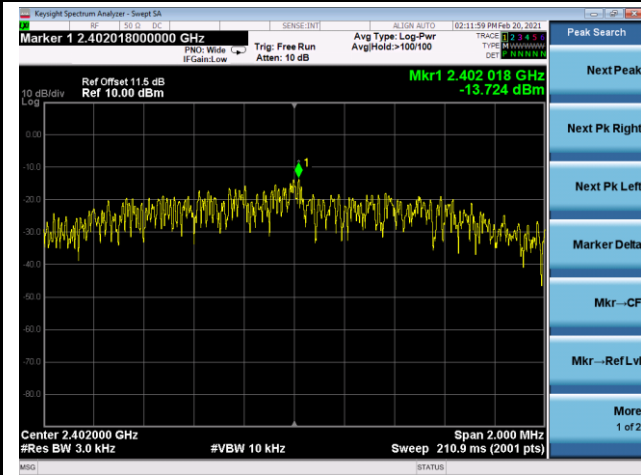

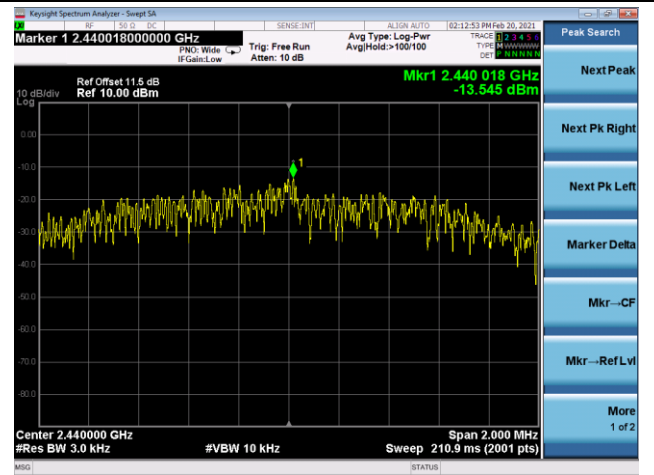


## BLE PSD – 2Mbps

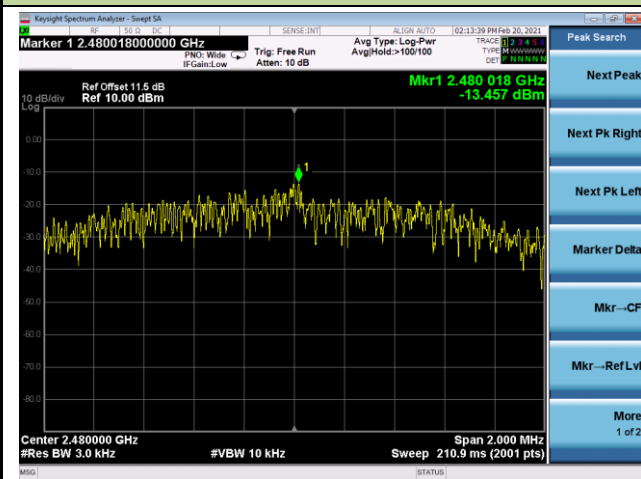
Channel 00 (2402MHz)

## **6.5. Conducted Band Edge and Out-of-Band Emissions**

### **6.5.1. Test Limit**

The limit for out-of-band spurious emissions at the band edge is 20dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100kHz bandwidth per the PSD procedure.

### **6.5.2. Test Procedure Used**

ANSI C63.10 Section 11.11

### **6.5.3. Test Setting**

#### **Reference level measurement**

1. Set instrument center frequency to DTS channel center frequency
2. Set the span to  $\geq 1.5$  times the DTS bandwidth
3. Set the RBW = 100 kHz
4. Set the VBW  $\geq 3 \times$  RBW
5. Detector = peak
6. Sweep time = auto couple
7. Trace mode = max hold
8. Allow trace to fully stabilize

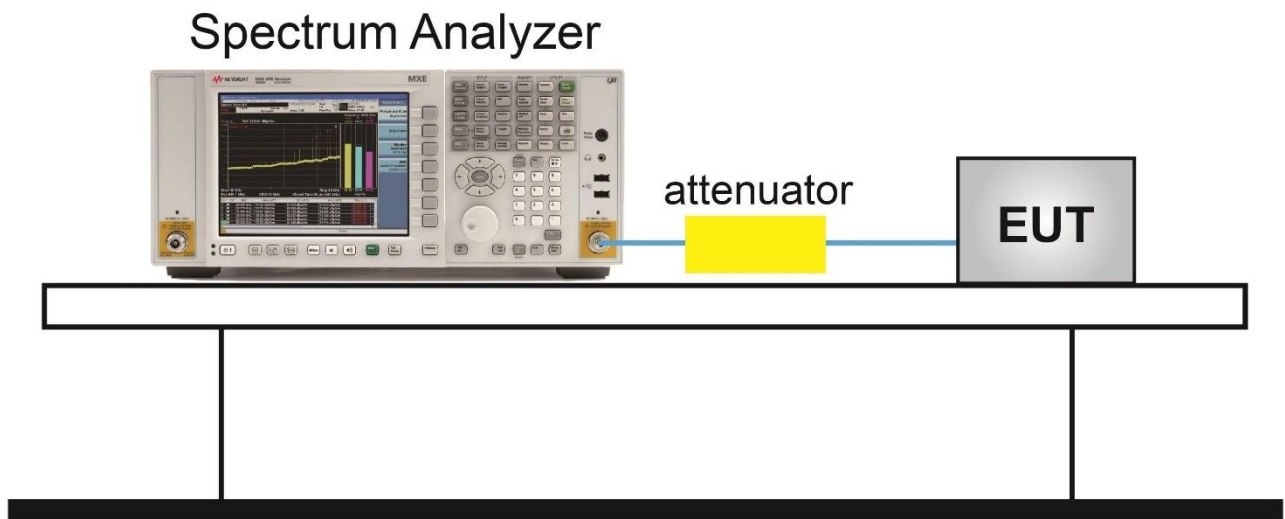
#### **Emission level measurement**

1. Set the center frequency and span to encompass frequency range to be measured
2. RBW = 100kHz
3. VBW = 300kHz
4. Detector = Peak
5. Trace mode = max hold
6. Sweep time = auto couple
7. The trace was allowed to stabilize

### Test Notes

1. RBW was set to 1.3MHz rather than 100kHz in order to increase the measurement speed.
2. The display line shown in the following plots denotes the limit at 20dB below the fundamental emission level measured in a 100kHz bandwidth. However, since the traces in the following plots are measured with a 1.3MHz RBW, the display line may not necessarily appear to be 20dB below the level of the fundamental in a 1.3MHz bandwidth.
3. For plots showing conducted spurious emissions near the limit, the frequencies were investigated with a reduced RBW to ensure that no emissions were present.

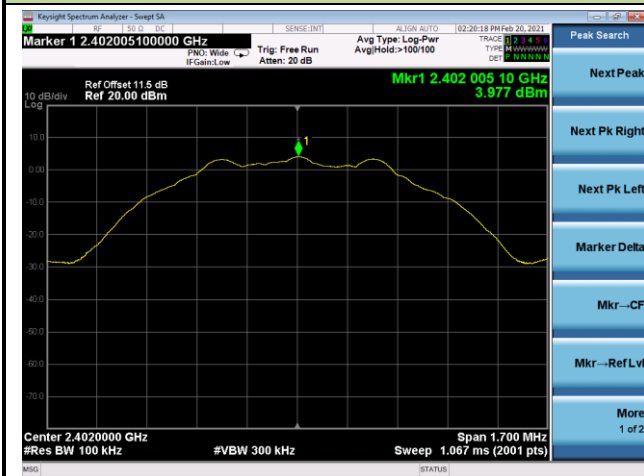

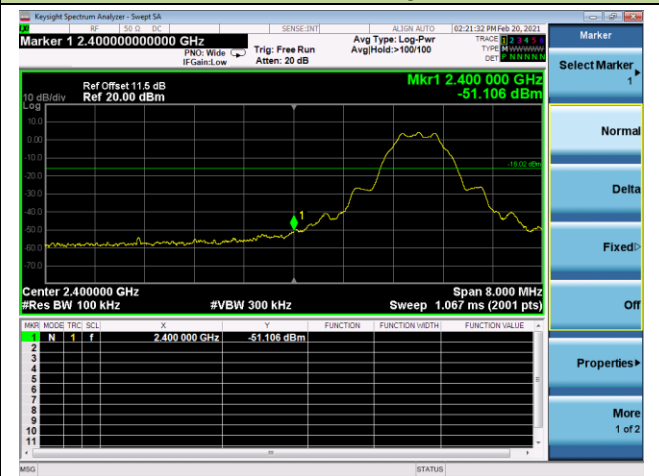

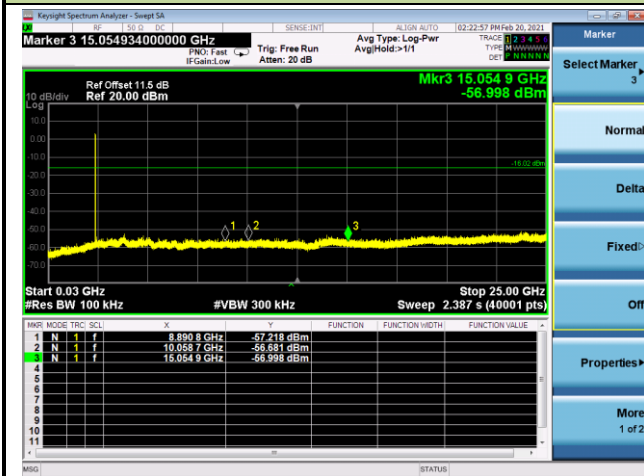
#### 100kHz PSD reference Level

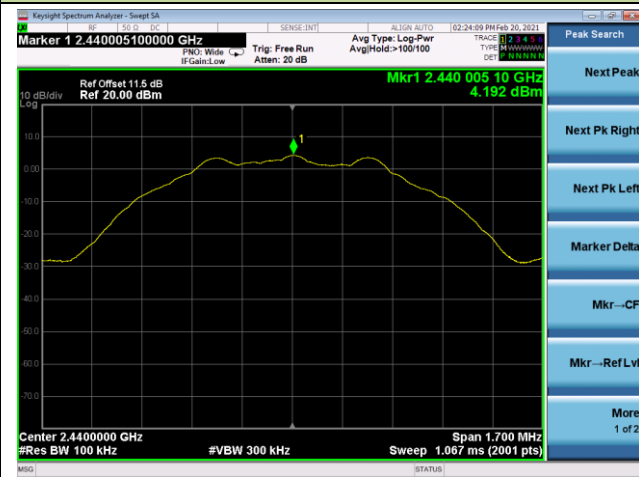

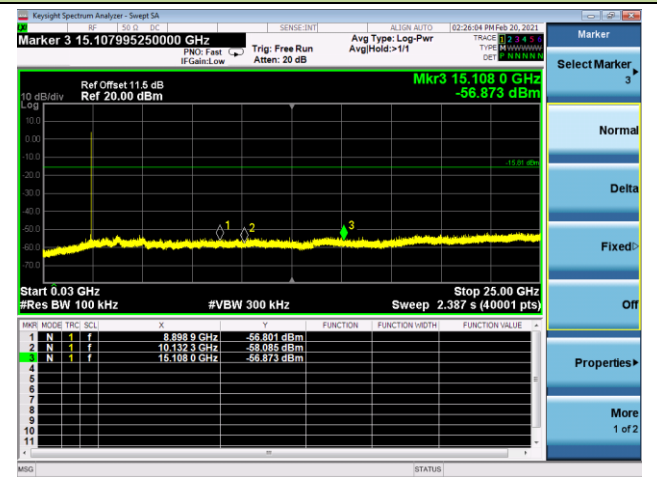

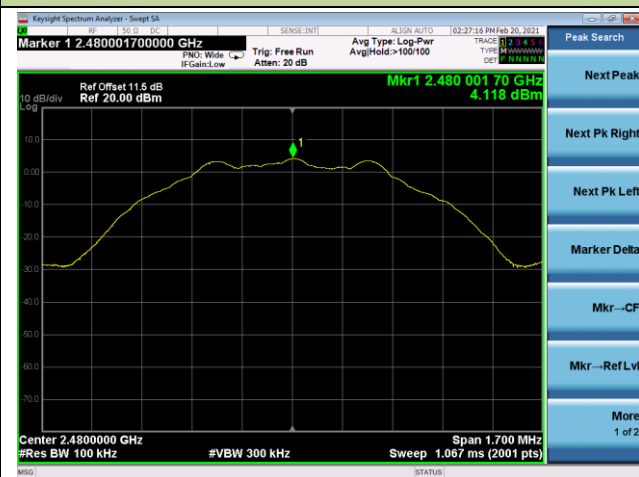

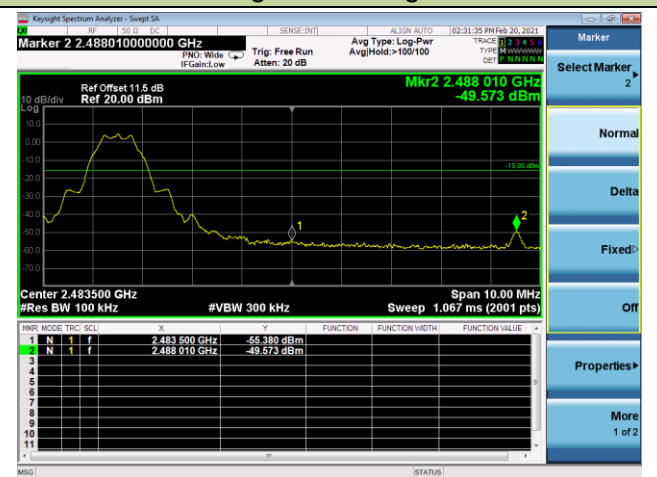

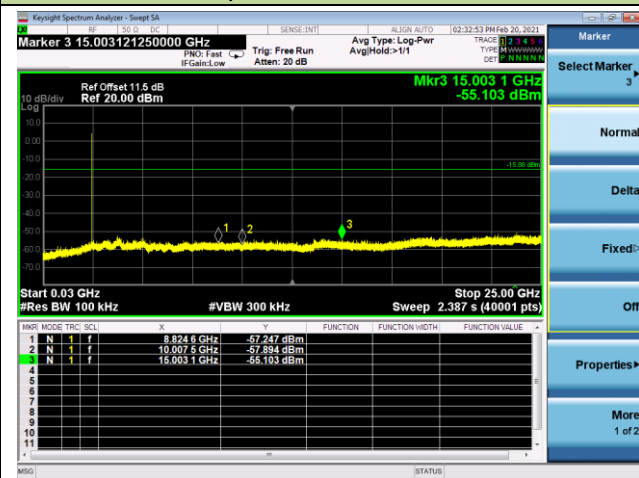

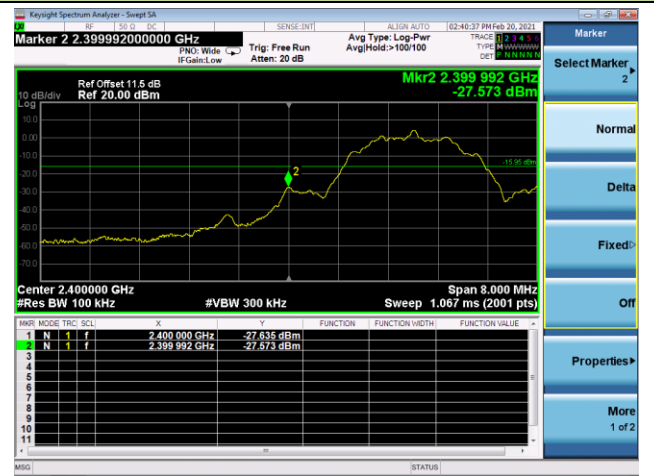
