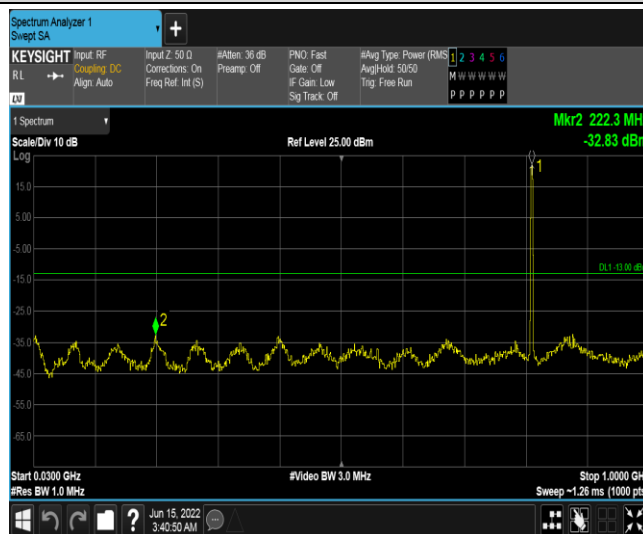

Band26-1.4MHz-QPSK-26697-1RB#0-Range1:30~1000MHz



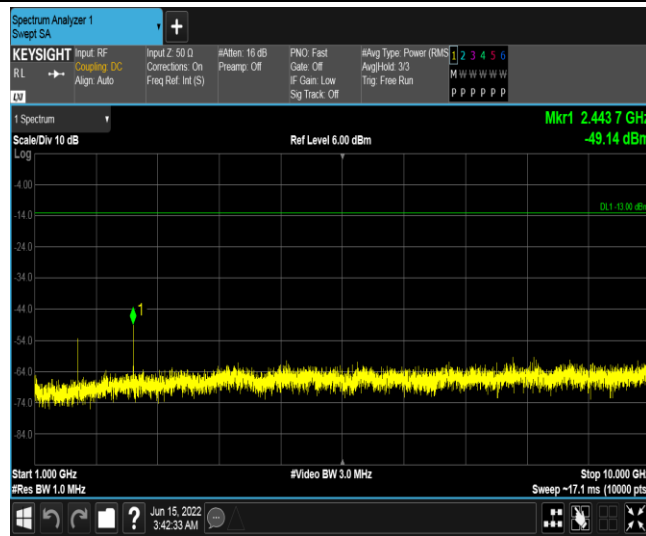
