





1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EME) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Industry Canada Certification and Engineering Bureau.

1.2 Testing Facility




Figure 1-1. Map of the Greater Baltimore and Metropolitan Washington, D.C. area

The map below shows the location of the PCTEST LABORATORY, its proximity to the FCC Laboratory, the Columbia vicinity, the Baltimore-Washington Internt'l (BWI) airport, the city of Baltimore and the Washington, DC area. (See Figure 1-1).

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The site coordinates are 39° 10'23" N latitude and 76° 49'50" W longitude. The facility is 0.4 miles North of the FCC laboratory, and the ambient signal and ambient signal strength are approximately equal to those of the FCC laboratory. The detailed description of the measurement facility was found to be in compliance with the requirements of § 2.948 according to ANSI C63.4-2003 on February 15, 2012.

3.0 DESCRIPTION OF TESTS

3.1 Measurement Procedure

The measurement procedures described in the document titled "Land Mobile FM or PM – Communications Equipment – Measurements and Performance Standards" (ANSI/TIA-603-C-2004) and "Procedures for Compliance Measurement of the Fundamental Emission Power of Licensed Wideband (> 1 MHz) Digital Transmission Systems" (KDB 971168) were used in the measurement of the **LG Portable Handset FCC ID: ZNFD950.**









3.9 Occupied Bandwidth §2.1049 RSS-Gen(4.6.1) RSS-133(2.3) RSS-139(2.3)

The implementation of this test is performed by the spectrum analyzer's occupied bandwidth function. The occupied bandwidth, that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured.

3.10 Spurious and Harmonic Emissions at Antenna Terminal §2.1051 §22.917(a)(b) §24.238(a)(b) §27.53(g) §27.53(h) §27.53(m) RSS-132(4.5.1) RSS-133(6.5.1) RSS-139(6.5.1)

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. The spectrum is scanned from the lowest frequency generated in the equipment up to a frequency including its 10th harmonic. On any frequency outside a licensee's frequency block, the power of any emission shall be attenuated below the transmitter power (P) by at least 43 + 10 log(P) dB. Compliance with these provisions is based on the use of measurement instrumentation employing a resolution bandwidth of 100 kHz or greater for Cell band, 698–746 MHz band, or 1 MHz or greater for PCS band, AWS band, BRS and EBS stations. However, in the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed for PCS band, AWS band, BRS and EBS stations. The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emission are attenuated at least 26 dB below the transmitter power.

3.11 Peak-Average Ratio §24.232(d) §27.50(d.5) RSS-132(5.4) RSS-133(6.4) RSS-139(6.4)

A peak to average ratio measurement is performed at the conducted port of the EUT. For LTE signals, the spectrum analyzers Complementary Cumulative Distribution Function (CCDF) measurement profile is used to determine the largest deviation between the average and the peak power of the EUT in a given bandwidth. The CCDF curve shows how much time the peak waveform spends at or above a given average power level. The percent of time the signal spends at or above the level defines the probability for that particular power level.

3.12 Radiated Power and Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. For measurements above 1GHz absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections. For measurements below 1GHz, the absorbers are removed. An ETS Lindgren Model 2188 raised turntable is used for radiated measurement. It is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. A 78cm high PVC support structure is placed on top of the turntable. A 3/4" (~1.9cm) sheet of high density polyethylene is used as the table top and is placed on top of the PVC supports to bring the total height of the table to 80cm.

The equipment under test was transmitting while connected to its integral antenna and is placed on a wooden turntable 80cm above the ground plane and 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer. Radiated power levels are also investigated with the receive antenna horizontally and vertically polarized. The maximized power level is recorded using the spectrum analyzer "Channel Power" function with the integration band set to the emissions' occupied bandwidth, a RMS detector, RBW = 100kHz, VBW = 300kHz, and a 1 second sweep time over a minimum of 10 sweeps, per the guidelines of KDB 971168.

Per the guidance of ANSI/TIA-603-C-2004, a half-wave dipole is then substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator with the level of the signal generator being adjusted to obtain the same receive spectrum analyzer level previously recorded from the spurious emission from the EUT. The power of the emission is calculated using the following formula:

$$P_{d [dBm]} = P_{g [dBm]} - cable loss_{[dB]} + antenna gain_{[dBd/dBi]}$$

Where, P_d is the dipole equivalent power, P_g is the generator output into the substitution antenna, and the antenna gain is the gain of the substitute antenna used relative to either a half-wave dipole (dBd) or an isotropic source (dBi). The substitute level is equal to $P_{g \, [dBm]}$ – cable loss $_{[dB]}$.

The calculated P_d levels are then compared to the absolute spurious emission limit of -13dBm which is equivalent to the required minimum attenuation of 43 + $10log_{10}$ (Power [Watts]) specified in 22.917(a) and 24.238(a).

The frequency stability of the transmitter is measured by:

- a.) **Temperature:** The temperature is varied from -30°C to +50°C in 10°C increments using an environmental chamber.
- b.) **Primary Supply Voltage:** The primary supply voltage is varied from 85% to 115% of the nominal value for non hand-carried battery and AC powered equipment. For hand-carried, battery-powered equipment, primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacturer.

Specification – The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block for Part 24 and 27. The frequency stability of the transmitter shall be maintained within $\pm 0.00025\%$ (± 2.5 ppm) of the center frequency for Part 22.

Time Period and Procedure:

- 1. The carrier frequency of the transmitter is measured at room temperature (20°C to provide a reference).
- 2. The equipment is turned on in a "standby" condition for one minute before applying power to the transmitter. Measurement of the carrier frequency of the transmitter is made within one minute after applying power to the transmitter.
- 3. Frequency measurements are made at 10°C intervals ranging from -30°C to +50°C. A sufficient stabilization period at each temperature shall be used prior to each frequency requirement.




Figure 6-1. Frequency Stability Graph (Band 17)




Figure 6-2. Frequency Stability Graph (Band 5)




Figure 6-3. Frequency Stability Graph (Band 4)




Figure 6-4. Frequency Stability Graph (Band 2)




Figure 6-5. Frequency Stability Graph (Band 7)




Plot 7-1. Lower Band Edge Plot (5.0MHz QPSK - RB Size 25)


Plot 7-4. Upper Band Edge Plot (5.0MHz QPSK - RB Size 25)




Plot 7-5. Lower Band Edge Plot (10.0MHz QPSK – RB Size 50)


Plot 7-6. Occupied Bandwidth Plot (10.0MHz QPSK - RB Size 50)




Plot 7-7. Occupied Bandwidth Plot (10.0MHz 16-QAM - RB Size 50)


Plot 7-8. Conducted Spurious Plot (10.0MHz QPSK - RB Size 1, RB Offset 0- Low Channel)




Plot 7-9. Conducted Spurious Plot (10.0MHz QPSK – RB Size 1, RB Offset 0 – Low Channel)


Plot 7-10. Conducted Spurious Plot (10.0MHz QPSK - RB Size 1, RB Offset 0 - Mid Channel)




Plot 7-11. Conducted Spurious Plot (10.0MHz QPSK - RB Size 1, RB Offset 0 - Mid Channel)


Plot 8-1. Lower Band Edge Plot (5.0MHz QPSK - RB Size 25)


Plot 8-2. Lower Extended Band Edge Plot (5.0MHz QPSK - RB Size 25)




Plot 8-3. Occupied Bandwidth Plot (5.0MHz QPSK - RB Size 25)


Plot 8-4. Occupied Bandwidth Plot (5.0MHz 16-QAM - RB Size 25)




Plot 8-5. Conducted Spurious Plot (5.0MHz QPSK – RB Size 1, RB Offset 0 – Low Channel)


Plot 8-6. Conducted Spurious Plot (5.0MHz QPSK - RB Size 1, RB Offset 0 - Low Channel)




Plot 8-7. Conducted Spurious Plot (5.0MHz QPSK - RB Size 1, RB Offset 0 - Mid Channel)


Plot 8-8. Conducted Spurious Plot (5.0MHz QPSK - RB Size 1, RB Offset 0 - Mid Channel)


Plot 8-10. Conducted Spurious Plot (5.0MHz QPSK - RB Size 1, RB Offset 0 - High Channel)




Plot 8-11. Upper Band Edge Plot (5.0MHz QPSK - RB Size 25)


Plot 8-12. Upper Extended Band Edge Plot (5.0MHz QPSK - RB Size 25)




Plot 8-13. Lower Band Edge Plot (10.0MHz QPSK - RB Size 50)


Plot 8-14. Lower Extended Band Edge Plot (10.0MHz QPSK - RB Size 50)






Plot 9-2. Lower Extended Band Edge Plot (5.0MHz QPSK - RB Size 25)





Plot 9-4. Occupied Bandwidth Plot (5.0MHz 16-QAM - RB Size 25)






Plot 9-6. Conducted Spurious Plot (5.0MHz QPSK - RB Size 1, RB Offset 0 - Low Channel)






Plot 9-8. Conducted Spurious Plot (5.0MHz QPSK - RB Size 1, RB Offset 0 - Mid Channel)

Plot 9-10. Conducted Spurious Plot (5.0MHz QPSK - RB Size 1, RB Offset 0 - High Channel)






Plot 9-12. Upper Extended Band Edge Plot (5.0MHz QPSK - RB Size 25)





Plot 9-14. PAR Plot (5.0MHz 16-QAM - RB Size 25)






Plot 9-16. Lower Extended Band Edge Plot (10.0MHz QPSK – RB Size 50)


Plot 9-20. Upper Extended Band Edge Plot (10.0MHz QPSK - RB Size 50)






Plot 10-2. Lower Extended Band Edge Plot (5.0MHz QPSK - RB Size 25)






Plot 10-4. Occupied Bandwidth Plot (5.0MHz 16-QAM - RB Size 25)






Plot 10-6. Conducted Spurious Plot (5.0MHz QPSK – RB Size 1, RB Offset 0 – Low Channel)


Plot 10-8. Conducted Spurious Plot (5.0MHz QPSK – RB Size 1, RB Offset 0 – Mid Channel)


Plot 10-12. Upper Extended Band Edge Plot (5.0MHz QPSK - RB Size 25)




Plot 10-16. Lower Extended Band Edge Plot (10.0MHz QPSK - RB Size 50)


Plot 10-18. Occupied Bandwidth Plot (10.0MHz 16-QAM - RB Size 50)






Plot 10-20. Upper Extended Band Edge Plot (10.0MHz QPSK - RB Size 50)


Plot 11-2. Lower Extended Band Edge Plot (5.0MHz QPSK - RB Size 25)






Plot 11-4. Occupied Bandwidth Plot (5.0MHz 16-QAM - RB Size 25)






Plot 11-6. Conducted Spurious Plot (5.0MHz QPSK – RB Size 1, RB Offset 0 – Low Channel)






Plot 11-8. Conducted Spurious Plot (5.0MHz QPSK – RB Size 1, RB Offset 0 – Mid Channel)




Plot 11-12. Upper Extended Band Edge Plot (5.0MHz QPSK - RB Size 25)








Plot 11-18. Lower Band Edge Plot (10.0MHz QPSK - RB Size 50)


Plot 11-22. Upper Band Edge Plot (10.0MHz QPSK - RB Size 50)






Plot 11-24. PAR Plot (10.0MHz QPSK - RB Size 50)


Plot 11-28. ACP Plot (10.0MHz QPSK - RB Size 50) - High Channel




Plot 11-29. Lower Band Edge Plot (15.0MHz QPSK - RB Size 75)


Plot 11-30. Lower Extended Band Edge Plot (15.0MHz QPSK - RB Size 75)


Plot 11-32. Occupied Bandwidth Plot (15.0MHz 16-QAM - RB Size 75)




Plot 11-33. Upper Band Edge Plot (15.0MHz QPSK – RB Size 75)


Plot 11-34. Upper Extended Band Edge Plot (15.0MHz QPSK – RB Size 75)




Plot 11-35. PAR Plot (15.0MHz QPSK - RB Size 75)

Plot 11-40. Lower Band Edge Plot (20.0MHz QPSK - RB Size 100)




Plot 11-41. Lower Extended Band Edge Plot (20.0MHz QPSK - RB Size 100)


Plot 11-44. Upper Band Edge Plot (20.0MHz QPSK - RB Size 100)




Plot 11-45. Upper Extended Band Edge Plot (20.0MHz QPSK - RB Size 100)


Plot 11-46. PAR Plot (20.0MHz QPSK - RB Size 100)




Plot 11-47. PAR Plot (20.0MHz 16-QAM - RB Size 100)


Plot 11-48. ACP Plot (20.0MHz QPSK - RB Size 100) - Low Channel
